 - Each county has a county committee for every party
 - Starting in Setpember 2020, we will have the Kings COunty Libertarians Party County Committee. All members must be enrolled libertarians. To be a member of the KCLCC. You must be elected to the committee. The registered LP voters are the people who can serve as officers and vote for officers. If elected to the LP county committee you can get the title "Honorable".
 - Also in September 2020, there will be an election for state committee.
 - Brooklyn will be entitled to several reps on the committee. Defined by the amount of enrolled LP members in Brooklyn. And how many votes gotten by Larry.
 - Must be enrolled LP to be an officer and to vote for officers at county and state.
 - You must submit you change of enrollment by September 2019 for it to be effective in September 2020. Wait until new voter registration forms are printed. When those are printed there will be an LP box.

- You will have to do a party petition to get on the primary ballot. Starts in June 2020. These districts are assembly districts.
- Important duties of the state committee such as picking the hotel at the LPN Convention. Lol.

Gary Popkin speaks on Getting Petition Signatures From Enrolled Libertarians

Enrolled Libertarians are few and far between. A petitioner has to go to the enrollee"s house to get a signature. You can get free enrollee data. The New York City Board of Elections publishes free online enrollment books with names, addresses, and apartments. The New York State Board of Elections provides a free disk with more data but still no telephone number or email address. For \$50 the city board provides a disk with more data including any telephone number and email address that the voter put on the voter-registration form.

Let's say you have the names and addresses of some enrolled Libertarians and you knock on the door of one. You say, "May I speak to Carlos de la Paz, please?" "Who wants to know?" Don't say you are from the Libertarian Party. Maybe Carlos doesn't want his family to know he is

a Libertarian. Say, "I'm collecting signatures to get some candidates on the ballot and I need Carlos' signature." "Can I sign?" "No. You are not on my list. Only Carlos is on my list." "Can I forge Carlos' signature?" "No. I have to see him sign." Do not commit election fraud. It might be a sting." Carlos is in the shower. Can I bring it to him to sign?" "No. I have to see him sign. I'll get into the shower with him so he can sign."

When you find a Libertarian, introduce yourself and say, "Will you sign to get some Libertarian candidates onto the ballot?"

A voter might say, "I'm not a Libertarian." How can that happen if the voter is on your list? Maybe the Board of Elections enrolled him wrong or he enrolled so long ago he forgot. Say, "Since none of this makes any difference to you, can you do me a favor and sign?"

How do you get from one Libertarian to the next? You can drive or have someone drive you. You can drive up into the voter's driveway and keep your eye on your car. You can park in the street blocking the driveway and keep your eye on your car.

The voter need only sign. You can fill in the date, the printed name, and the address because you know who the voter is.

If you telephone a voter and say that you want to come over for a signature, the voter will say, "Oh, no, I'm just going out." Rush right over and if it takes you 15 minutes the voter will still be there.

Maybe we can write to Libertarians telling them we will be collecting signatures and can they please call to make an appointment.

Your petition can be challenged only by an enrolled Libertarian eligible to vote in the contest of your petition. If you don't expect a challenge you don't have to be meticulous about your petition.

The petition period is always 38 days long--5 weeks plus 3 days. You might get one signature per hour. You cannot witness your own signature.
