Program Description

The Associate in Christian Law program with a Specialization in Faith-Based Christian Law and Ethics at HBI University provides students with a strong foundation in biblical justice, moral law, and legal principles relevant to church leadership and Christian communities. This program blends scriptural insights with essential legal knowledge to prepare students for advocacy, governance, and ethical leadership in faith-based settings.

Students will examine church governance, Christian ethics, biblical law, and social justice frameworks from a Kingdom perspective. Emphasis is placed on servant leadership, moral reasoning, and the integration of legal and theological understanding in ministry practice.

Graduates will be equipped to advise Christian ministries on ethical and legal matters, develop faith-informed policy, and support compliance efforts with both spiritual integrity and practical legal tools.
