## **Distance Counseling for Juniors**

Hello juniors. During the spring juniors typically focus on their classes so they have the strongest grades possible when applying to colleges, take the SAT and/or ACT, start meeting with their school counselor for college planning sessions, visit colleges, etc. The college planning process can be stressful in and of itself, but with the uncertainties brought by COVID your stress might be at an all-time high. Luckily, even though we're not in school the counselors can still provide support electronically!

Below are recommendations for things you can do over the next few weeks. It's not mandatory, but it's here if you want to take a look. The counselors will update this list, so check back periodically. If we're out of school for a longer period of time we'll add more recommendations to this list.

Today (3/16/20) ACT announced that they're cancelling the April ACT, and College Board announced that they're cancelling the May SAT. More changes will be coming...

Just remember- you will be ok. You will go to college. Things aren't going as planned, but try to stay level-headed and be flexible. Juniors across the country and around the world are also dealing with this. Colleges will need to make adjustments too. We've never been through something like this before, but we'll figure it out together. We'll make sure you get all of the information you need in regards to college planning. You can always email us with your questions and/or concerns too. We're here to support you academically and emotionally, so please reach out if you need us.

#### Masterman's College Planning Guide

#### Naviance

All juniors should have completed their Naviance lessons for the 2019-2020 school year. This was done in Junior Seminar. If you haven't completed the lessons, follow these directions:

- Go to philasd.org
- Login
- Go to the Naviance portal
- When you're on your Naviance homepage, click "My Planner" in the top right hand corner
- Then click "Tasks"
- Scroll down. Complete anything on the left side of the screen under the red "Overdue" heading that's from the 2019-2020 school year. Read the directions carefully.
- You'll know you completed a task when it moves to the right side of the screen under "Tasks you've completed"
- If you'd like to complete a task from a previous school year, you can do that too.

There's also plenty to explore in Naviance that isn't specifically assigned to you. Browse the site! For example, explore careers in Roadtrip Nation.

### **Summer Programs**

5/12/20- It looks like some programs are being moved online, and many are being cancelled. Remember that all juniors are in the same situation, and colleges understand that you won't be able to participate in most summer activities. We recommend that you use the summer to work on your Common App (the counselors are setting a date to have a Junior Seminar class on Google Meet to help you with this), revise your Common App essay, and explore things you're interested in but never had time to pursue. Read a book that's been sitting on your shelf.

Research a topic that's intrigued you but you haven't learned about it in school. Show genuine curiosity and interest in something!

#### **College Board SAT Updates**

The May and June SAT are cancelled.

Whether you plan to take the SAT in August or in the fall, you can do SAT practice over the next few weeks. You can practice through Khan Academy if you haven't already. If you login to your College Board account you can link it to Khan Academy and get free, personalized practice based on your PSAT score. We highly recommend it! Official SAT® Practice

4/23/20- College Board has added a new SAT administration for Saturday, September 26, 2020. This date will be for the SAT only, in the United States and internationally, with no SAT Subject Tests™ available. Sunday testing for religious reasons will be on September 27.

Registration for the 2020-21 SAT administrations will open the week of May 26. At that point, June registrants will be able to transfer their seat to a 2020-21 administration. All other students in the high school class of 2021 who don't have SAT scores will also have early access to register for the August, September, and October administrations. This includes students who had registered for March or May and had their registrations canceled and refunded. For each administration this year, we're also preparing to significantly expand our capacity. More info here.

## **Update on an At-Home SAT Option**

The College Board will pause on offering an at-home SAT this year because taking it would require three hours of uninterrupted, video-quality internet for each student, which can't be guaranteed for all. We'll continue to develop remote proctoring capabilities to make an at-home SAT possible in the future. We will also continue to deliver the SAT online in some schools but won't introduce the stress that could result from extended at-home testing in an already disrupted admissions season.

#### 4/3/20 - SAT Subject Tests

The counselors are starting to receive emails from multiple colleges stating that they **WILL NOT** be requiring or recommending SAT Subject tests for current juniors who will be applying to college this fall. Don't stress about subject tests if you haven't taken them yet, or if you wanted to retake them to improve your score. Check the websites of the specific colleges you're interested in to see any changes to requirements.

Harvard- "Students will not be disadvantaged in any way if they do not submit subject tests. Similarly, students will not be disadvantaged if they are unable to submit AP results."

Penn- "For the 2020-21 admissions cycle, SAT Subject Tests will be *optional* (i.e., neither required nor recommended) for applicants. We will continue to require students submit SAT or ACT scores."

Yale- "Yale requires all applicants for first-year and transfer admission to report results from the ACT or SAT. At this time, we expect there will be sufficient opportunities for all applicants to

complete the ACT or SAT before the next admissions deadlines. If Yale's policies change, we will provide a public notice as soon as possible.

All other standardized tests (i.e. SAT subject tests, AP exams, IB exams, A-Level exams) are optional. We do not expect students currently enrolled in academic-year courses associated with any of these tests to complete these exams in spring or summer 2020. Students may choose to complete these exams this year if circumstances allow, or not."

MIT- "MIT has made the decision to no longer consider the SAT Subject Tests as part of the admissions process starting with the 2020–21 admissions cycle. This decision was made after considerable study and we believe this decision will improve access for students applying to MIT."

3/18/20- Case Western just announced that they're going test optional for students entering college in fall 2021 (current juniors). Get details <u>here</u>:

3/24/20- "Tufts University is introducing a test-optional admissions policy for all undergraduate applicants for a 3-year period, beginning with applicants who apply for the Fall 2021 semester.

Starting with our next admissions cycle, first-year and transfer applicants have a choice about whether or not to submit SAT or ACT scores to be considered for undergraduate admission to Tufts."

**Tufts Introduces SAT & ACT Test-Optional Admissions Policy** 

4/22/20- "The SARS-COV-2 pandemic emergency has led to many SAT and ACT administration cancellations. Due to this extraordinary circumstance, students seeking to enroll at Cornell University beginning in August 2021 can submit their applications without including the results from ACT or SAT exams. This will be true for both the Early Decision and Regular Decision rounds of review." Info here.

4/23/20- "Barnard recognizes the challenges that students are facing due to the COVID-19 pandemic and, in response, Barnard will adopt a one-year SAT and ACT test-optional admission policy for students applying for Fall 2021 first-year admission."

4/23/20- "Given the fact that many high school students were, or will be, unable to sit for standardized tests this spring and summer, Wellesley has temporarily suspended its requirement that first-year applicants submit SAT or ACT scores. This means testing will be optional for first-year applicants applying to the College for entry in the fall of 2021. If an applicant wishes to have their standardized test scores considered as one component of their application, we will consider those scores in a nuanced and contextual way alongside all other application credentials. If students choose not to submit standardized test scores, we will evaluate their application in a nuanced and contextual way without test scores. Our holistic, committee-based application review process gives us the flexibility to evaluate each applicant's academic and extracurricular accomplishments within individual context."

5/29/20- "I am pleased to announce that Drexel University has adopted a Test-Optional policy for students applying as first-year or transfer students during the 2020–2021 admissions cycle. At the end of the 2020–2021 admissions cycle, we will decide whether to reinstate a standardized testing requirement for undergraduate applicants or extend the Test-Optional policy."

6/4/20- "Due to ongoing standardized testing disruptions associated with the COVID-19 pandemic, Columbia is adopting a one year test-optional policy for first-year applicants to Columbia College or Columbia Engineering for the fall of 2021.

Testing is no longer a required component for this year's first-year application cycle. Students who are unable or choose not to submit test scores will not be disadvantaged in any way. If students have completed testing and would like to submit their results, we welcome those scores and will review them, as with all optional or required information, within the holistic and

contextual review process that considers individual circumstances shaping each applicant's journey."

## **Emails From Colleges to Students**

3/19/20- Below is an email that UChicago sent to students. We're sharing it because it probably addresses some of your worries about the college process. Remember that juniors across the country are in the same situation as you, and that colleges are understanding and will be flexible in regards to admissions for next year. You'll be ok and all of this will be worked out.

Dear Student,

I hope you are all weathering the current storm and staying healthy and safe!

The COVID-19 pandemic is impacting so many aspects of life and forcing changes, cancellations, and new policies at all levels of education. Many students and families have written to me and expressed their worries and frustrations, especially those just beginning the college search process. As Dean of Admissions, I want to assure all students and their families that we (and most of my peers at other highly selective institutions) will be understanding and accommodating of these changes. The current crisis will NOT negatively impact how we review your application, and there will still be time once this crisis is over for you to find your future college home. At UChicago, our goal is to assist students with as much flexibility as possible. Given the changing landscape in the admissions area, I hope this additional information about the admissions process will help ease some worry during this difficult time:

- We recognize that school transcripts will look different for many students this year, and we will work with that! Academic progress as usual is currently being disrupted for students across the globe. We encourage students to continue to engage with whatever method of learning your school is able to offer, and to do so to the best of your ability. If your school moves to an alternative grading system or method of credit notation (pass/fail, credit/no credit, etc.), we will fully understand why the change has been made and it will not, in any way, be an issue for an admissions office. If a high school closes and does not provide any online or structured replacement educational opportunities, rest assured that we will understand that as well (this is a good opportunity to read something new that piques your interest!).
- You do not need to visit campus to be admitted to a selective school. UChicago does
  not consider demonstrated interest as part of our admissions process. While
  universities are currently restricted in our ability to offer information sessions on

- campus or in local communities, many universities will offer virtual information sessions. UChicago will be posting many new online opportunities in the weeks ahead. The goal for our online programming (and any sessions we offer on or off campus in the future) is simply to help students learn more about the highly selective admissions process, the financial aid process at most schools, and the impactful nature of a UChicago education. Visiting or attending an online session is NOT a requirement of admission to UChicago.
- Many final national exams or international certificate programs (such as Advanced Placement tests, the International Baccalaureate program, Cambridge Programme/A-Levels, etc.) have been (or will be) moved online, postponed, or cancelled. Most highly selective admissions offices do not require AP scores and are aware of the changes (and will also understand that students will have few opportunities to take any required tests more than once which is a good thing!). At UChicago, we do not require any students to complete exams in these or other national programs as a condition of enrollment. UChicago does not require AP or SAT Subject Test results for any applicant. We understand that many students' preparation for or ability to take these exams will be impacted by current events. Supplemental testing is not required in our admission process, even for test-optional candidates, and it will not impact a student's application if they are unable to share these test results with us next year.
- Many schools are closed temporarily or indefinitely, and some students may worry
  how they can showcase their accomplishments for the spring. Do not worry. This will
  be the case for most students, and an application is always read in context.
- Your school counselors will give you excellent and well-informed advice! Universities communicate updates and changes in the admissions process with your school counselors (and school counselors call us when they have questions or need clarifications). If you do not have a school counselor, UChicago provides information that will help you with this process at most universities, not just ours. We will be sharing more general college admissions resources and other information with students who may need extra assistance or resources in the weeks ahead. Continue to check our website, collegeadmissions.uchicago.edu, for more details in the coming weeks.

We hope that this information was helpful to you and alleviates some of your college admissions stress (the current crisis creates more than enough stress – you do not need more).
