Privacy Policy

1. Introduction

Welcome to our application. This Privacy Policy explains how we collect, use, disclose, and protect your personal information when you use our AI doll-generation app ("App"). By uploading your photo and customizing accessories, you agree to the terms described in this policy.

We value your privacy and are committed to ensuring that your data is handled responsibly and transparently. This policy applies to all users of the App and covers the data collected through our services, including images, customization inputs, and device-related information.

Please read this Privacy Policy carefully. If you do not agree with the practices described here, we recommend not using the App.

2. Information We Collect

When you use our App, we may collect the following types of information:

2.1. Personal Data You Provide

- **Photos**: When you upload your photo to generate an AI doll, we temporarily process your image to create results.
- Accessory Selections & Customization Inputs: We collect the choices you make regarding doll customization (e.g., hairstyle, clothing, accessories) to generate personalized content.

2.2. Automatically Collected Data

- **Device Information**: We may collect data about your device, such as device model, operating system version, language settings, and mobile device identifiers.
- **Usage Data**: We collect information on how you interact with the App, including session duration, features used, and crash reports.

2.3. Analytics Data

We may use third-party analytics tools to collect anonymized data for performance monitoring and to improve our services. This includes aggregated data such as feature popularity and user engagement trends. We do not collect or store biometric data or facial recognition patterns. Uploaded images are used solely for generating your AI doll and are not stored longer than necessary for processing, unless explicitly stated otherwise.

3. How We Use Your Information

We use the information we collect for the following purposes:

3.1. To Provide Core Functionality

- To generate personalized AI dolls based on your uploaded photo and selected accessories.
- To deliver a smooth and engaging user experience by storing temporary data necessary for processing.

3.2. To Improve and Optimize the App

- To analyze how users interact with the App in order to improve functionality, performance, and design.
- To fix bugs, monitor system performance, and enhance usability.

3.3. To Communicate With You

 To send important updates, service-related notifications, or respond to your inquiries, if applicable.

3.4. For Legal Compliance and Protection

- To comply with applicable laws, regulations, or legal obligations.
- To protect the rights, safety, and property of the App, its users, and others.

We do **not** use your photos or customization inputs for advertising purposes, nor do we sell your personal data to third parties.

4. Data Storage and Retention

4.1. Photo and Input Data

Uploaded photos and customization choices are temporarily stored on secure servers solely for the purpose of generating your AI doll. These files are automatically deleted after processing is complete, unless the user explicitly consents to saving them (e.g., for gallery or history features).

4.2. Usage and Technical Data

Non-personal data (such as usage statistics and device information) may be stored for a longer period to help us improve the App and monitor performance. This data is anonymized and does not identify individual users.

4.3. Data Retention Period

We retain personal data only for as long as necessary to fulfill the purposes outlined in this Privacy Policy, unless a longer retention period is required or permitted by law. Once data is no longer needed, it is securely deleted or anonymized.

4.4. Storage Location

All data is stored using reputable cloud service providers with industry-standard security protocols. Depending on your region, data may be stored in servers located in or outside your country of residence, in compliance with applicable laws.

5. Data Sharing and Disclosure

We take your privacy seriously and limit the sharing of your data to only what is necessary. We may share information in the following cases:

5.1. Service Providers

We may share data with trusted third-party vendors who help us operate the App and provide services such as cloud storage, image processing, analytics, and customer support. These providers are obligated to protect your data and are not allowed to use it for any other purpose.

5.2. Legal Requirements

We may disclose your information if required to do so by law or in response to valid legal processes, such as a court order, subpoena, or government request.
