## Leadership Report- Nikki Mitchell

- Tuition reimbursement process.
  - o 5K in budget for next year
  - o One teacher already planning to apply for tuition reimbursement for Montessori Training.
  - o Would love see this budget amount raised to 10-15K per year
- Enrollment
  - o Only a few spots available in 6th grade and 7 spots available for 7<sup>th</sup> grade
  - o Good for enrollment for next year
  - o Hiring- we only have one teaching position that is unfilled for this year. Hopeful to have all positions filled for next year.
  - o Assistant positions will be looked at in August.
- Parent Survey
  - o 42 responses so far
  - o Data will be used to inform school improvement
- State Testing
  - o Wrapping up with only 2 students left
  - o Looking forward to sharing with families and the board
  - o Individual student results will be sent home to families in the mail
- Aftercare
  - o Will be outsourced next year with a company called Champions
  - o Curriculum, staffing, materials, management-
  - o Big relief for admin
  - o Serving several other schools in the area, and they had great referrals
  - o They will be paying Ivy rent and there will be profit sharing

- Plant Sale- \$4500 (a little more than last year, but the weather was dismal or we might have done even better)
- PTA recruitmen t/ replacement for roles that are leaving next year.
- Making sure that everyone who starts those roles has adequate support.

## Old Business

- Board Recruiting
  - Cat Galimidi- is here today. Looking at board participation.
- Building to the North
  - Eric and Nikki in communication with building owners. Proposal to meet with building to the north about sponsorship. Meeting to be scheduled in June.
- Equity Plan
  - There are SMART goals in the plan
  - Equity audit will be coming back from Embracing Equity soon
  - board members have received a link to review and comment- comment via the document

## New Business

- Upcoming year's budget
  - State funding projecting 2.6% per student funding rate raise
    - Not projecting a major change in the state funding amount
  - Ivy projecting 289 students for next year, an increase of 18 students for next year
  - SIA funding amount 198K- 9% decrease (Students Invest Account)
  - Afterschool tuition at 0% because of outsourcing for next year
    - Increased revenue for our building through rental income from Champions
  - Childrens House tuition- budgeting for 9 tuition based students and we have put in 2 full scholarships.
  - Total fundraising goal 33K (1% of total budget)
  - Total revenue 3.3 million for the budget
    - Budget for next year is 1% lower than 23-24 (about 38K less than last year)
    - Pandemic funding went away so had to make adjustment
  - Total expense 23-24 \$3.3million (54K 2% lower than 23-24)
    - COLA to most of staff 3% this year
  - Some funds into building improvements, minimal.
- Budget Discussion
  - Student fees- why are we not collecting more than 62%.
    - A: Due to income limitations and scholarships. 62% is in the expected range for student fees.
  - Vacant part time kitchen assistant eliminating- due to budget.
    - If kitchen staff is sick, admin has to take up the slack
