



Payment Agreement

Tuition and Fees

I agree to pay DA for the class instruction of the student listed per the published tuition rates for the student(s) period of study. I understand that I can make payment by automatic draft, bill pay through my bank, check or cash. I understand that NO REFUNDS, prorated rates, or discounts will be given for classes missed because of illness, vacation, studio closings due to acts of nature such as inclement weather or government mandated shutdown. I understand that tuition fees are due on the first of each month; that a late fee of \$10 will be charged on the sixth of each month for tuition not paid and that this late fee is applicable for each month that the payment is late. If tuition is late three (3) times within one dance season, August through July, the student will be dismissed from the studio. In the event a student must be dismissed due to late tuition payments, said student will not be allowed to register for classes, privates, camps, or workshops for a full 12 months.

By submitting the registration form, I understand that tuition is not prorated due to missed classes. I also understand that in order to be dropped from a class, an email and/or letter by mail needs to be sent to danceascension.info@gmail.com at least 30 days prior to the desired date for drop or withdrawal from class. If contact from the office has not been made in order to confirm a student's withdrawal class, I understand that it is my responsibility to resend email/letter as well as contact the office.

You further agree and understand any and all fees for tuition, registration fees, camp/workshop fees, costumes fees, recital fees, etc are NON REFUNDABLE. No exceptions. Summer camps/workshops must be paid in full prior to the first day of the camp or the student will be dropped from the camp. If you decide to withdraw from a dance class (not a summer camp/workshop), please notify the office via email (lolelei.danceascension@gmail.com) 30 days in advance of the withdrawal date (see withdrawal form).

Company Auditions

By completing class registration and paying the registration fee at the time of application, I understand that all registration & audition fees are non-refundable. I understand that audition fees & registration fees are separate. Audition fees are



applicable to students auditioning for DAPT/DADC only. Acceptance into the classes/camps/workshops/company are not guaranteed until accepted and payment is made. Acceptance information will be sent out via email.

Make-up Classes

While we do not offer refunds for fees or tuition, we do offer make-up classes in the event classes are missed due to illnesses or to what we consider an excessive amount of classes missed due to inclement weather. A student may take any equivalent class as a make-up class. Please contact the office at the studio location your child(ren) attends to schedule a make-up class. Make-up classes must be scheduled and completed within 30 days of the date of the missed class(es). If you do not wish to make-up the missed class(es), you do not need to contact the studio office.

Policy Agreement
