TERRY PUNISHMENT #1

You, TERRY the terrorist, have been suspected and caught in the act of terrorism. The P-Ville Prosecution Office believes no one should be excommunicated, which means getting kicked out of P-Ville. This could be the punishment you will receive if you are found guilty in a court of law. Again, P-Ville is a privilege and what you have done is a reflection of what you think of P-Ville. You obviously hate the special privilege. While some may think or express disdain for P-ville and its citizens, you are the only one to actively intend to take unjust, unconstitutional and wrongful actions against P-ville and its citizens. The P-Ville Police Force has compiled and attained overwhelming evidence proving your guilt in this matter. If you publicly announce that you tried to start a terrorist group and that you tried to attack P4 DOD Shelby La Rue, P4 SCM Jordan Koshi and P3 Former DOD & Stock Broker Joseph Hettinger and apologize to them and P-Villians in general, your punishment will be more lenient and less severe than getting excommunicated.
