

# **Undocumented Student Rules in Utah Colleges & Universities**

### What is Utah House Bill 144 (HB 144)?

Utah's HB 144 is a state law that allows certain undocumented non-resident students to pay in-state tuition at Utah's public colleges and universities.

There are no federal laws prohibiting their admission, and many states offer tuition equity laws, allowing them to pay in-state tuition rates. While they are ineligible for federal financial aid, they can access state and private aid, attend a variety of public and private institutions, and find support through organizations like <a href="https://example.com/TheDream.US">TheDream.US</a> and <a href="https://example.com/Informed/Inmigrant">Informed/Inmigrant</a>.

### To qualify, students must:

- · Attend a Utah high school for 3 or more years
- · Graduate from a Utah high school or earn a GED in Utah
- File an affidavit with the college promising to apply for legal status when eligible
- Not have been enrolled in college before Fall 2002-03 term

This law does not provide federal financial aid, but it can save students thousands in tuition costs. More info: Utah Legislature: HB 144

# If You Have DACA: Scholarships & Financial Aid — Quick Guide

## What DACA Means for Money

- You are not eligible for federal aid (FAFSA grants/loans/work-study). Some colleges still ask you to file FAFSA or an alternative form to assess institutional aid.
- Utah: If you graduated from a Utah high school and meet HB144 requirements, you can usually qualify for in-state tuition (talk to your college).
- Many Utah state programs (e.g., Opportunity Scholarship) require citizenship or permanent residency DACA students typically aren't eligible. Always verify.
- Private scholarships (local, community, national) may be open to DACA/undocumented. Read eligibility carefully.

### **Smart Paying Strategy (Stack Your Options)**

- In-state tuition (if eligible via HB144) to lower the baseline cost.
- Institutional aid: ask each college about scholarships open to DACA/undocumented students.
- Private scholarships: focus on local awards (city, county, credit unions, foundations) and identity-based or interest-based awards.
- Work: campus jobs available at some schools (policies vary); off-campus options depend on your situation.

### **Action Steps**

- Tell your counselor/scholarship office your status (confidentially) so we can route you to the right resources.
- Ask each target college about Dreamer/DACA support and institutional scholarships.
- Search and apply weekly: build a shortlist and track deadlines.
- Gather docs early: transcripts, recommendation letters, short bio/activities, personal statement.
