Be it enacted by the Senate of the Student Government Association of The Johns Hopkins University assembled that:

SECTION 1. TITLE.

This Act may be referred to as the “SGA Spring 2023 Inauguration Bill”

SECTION 2. DEFINITIONS.

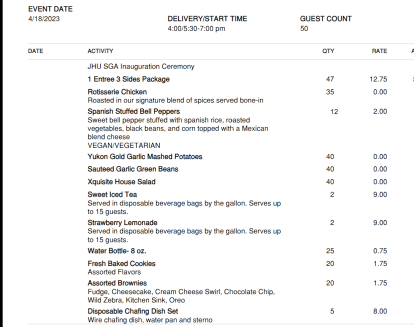
- (a) SGA — The term “SGA” shall refer to the Student Government Association of The Johns Hopkins University.
- (b) JHU, Hopkins - The terms “JHU” and “Hopkins” shall refer to the Johns Hopkins University.

SECTION 3. FINDINGS AND PURPOSES.

(a) FINDINGS & PURPOSES.

- An inauguration will be held to induct newly elected members into SGA and transition old members out.
- This is to increase SGA visibility and professionalism, promote openness and transparency of what SGA does, and provide outgoing members and seniors with memorable closure.
