## **Privacy Policy**

#### 1.Introduction

**Data Studio TM** ("us", "we", or "our") operates the website and the "Notes App" mobile application (hereinafter referred to as the "Service").

This page informs you of our policies regarding the collection, use and disclosure of personal data when you use our Service and the choices you have associated with that data.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy. Unless otherwise defined in this Privacy Policy, the terms used in this Privacy Policy have the same meanings as in our Terms and Conditions.

#### 2.Definition

**Service** Service means the mobile application "Notes App" operated by Data Studio TM

**Personal Data** Personal Data means data about a living individual who can be identified from that data (or from those and other information either in our possession or likely to come into our possession).

**Usage Data** Usage Data is data collected automatically either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

**Cookies** Cookies are small files stored on your device.

**Data Controller** Data Controller means the natural or legal person who (either alone or jointly or in common with other persons) determines the purposes for which and the manner in which any personal information are, or are to be, processed. For the purpose of this Privacy Policy, we are a Data Controller of your Personal Data.

**Data Processors (or Service Providers)** Data Processor (or Service Provider) means any natural or legal person who processes the data on behalf of the

Data Controller. We may use the services of various Service Providers in order to process your data more effectively.

**Data Subject (or User)** Data Subject is any living individual who is using our Service and is the subject of Personal Data.

#### 3.Information Collection and Use

We collect several different types of information for various purposes to provide and improve our Service to you.

#### **Types of Data Collected:**

3.1.Personal Data For a better experience, while using our Service, we may require you to provide us with certain personally identifiable information. The information that we request will be retained by us and used as described in this privacy policy.

Notes App collects Crash logs data to enable app functionality and to create analytics reports even when the app is closed or not in use and is also used to support advertising.

Notes App collects Advertising ID to enable app functionality and show related advertising even when the app is closed or not in use and is also used to support advertising.

Notes App collects Device or other IDs to enable app functionality and is used to identify users even when the app is closed or not in use and is also used to support advertising.

The app does use third party services that may collect information used to identify you.

#### 3.2.Usage Data

We may also collect information that your browser sends whenever you visit our Service or when you access the Service by or through a mobile device ("Usage Data").

This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

When you access the Service with a mobile device, this Usage Data may include information such as the type of mobile device you use, your mobile device unique ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browser you use, unique device identifiers and other diagnostic data.

#### 3.3. Tracking & Cookies Data

We use cookies and similar tracking technologies to track the activity on our Service and we hold certain information.

Cookies are files with a small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Other tracking technologies are also used such as beacons, tags and scripts to collect and track information and to improve and analyze our Service.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Service.

Examples of Cookies we use:

- Session Cookies. We use Session Cookies to operate our Service.
- Preference Cookies. We use Preference Cookies to remember your preferences and various settings.
- Security Cookies. We use Security Cookies for security purposes.

Data Studio TM uses the collected data for various purposes:

5.Legal Basis for Processing Personal Data under the General Data Protection Regulation (GDPR)

Data Studio TM may process your Personal Data because:

#### 6. Retention of Data

**Data Studio TM** will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of our Service, or we are legally obligated to retain this data for longer periods.

#### 7. Transfer of Data

Your information, including Personal Data, may be transferred to — and maintained on — computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ from those of your jurisdiction.

If you are located outside Pakistan and choose to provide information to us, please note that we transfer the data, including Personal Data, to Pakistan and process it there.

Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

**Data Studio TM** will take all the steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

### 8. Disclosure of Data

#### 8.1.Business Transaction

If **Data Studio TM** is involved in a merger, acquisition or asset sale, your Personal Data may be transferred. We will provide notice before your Personal Data is transferred and becomes subject to a different Privacy Policy.
