Golden Rule Mighty Networks Community Agreement and Liability Waiver

Golden Rule Community, connected to The Spiral Path

Effective Date and Acceptance

This Golden Rule Mighty Networks Community Agreement and Liability Waiver (Agreement) is effective when you click to join, subscribe, or otherwise access the Golden Rule Mighty Networks community (Community), or when you click “I agree” (or similar) to these terms within Mighty Networks.

By accepting, you confirm that you have read, understood, and voluntarily agree to be bound by this Agreement.

Parties

This Agreement is between you (Member) and The Spiral Path, including its management company, with Golden Rule included as a third party beneficiary (collectively, TSP Parties).

1. Acknowledgment of Religious Association and Doctrine

1. **Religious association.** You understand and agree that The Spiral Path is an unincorporated religious association.
2. **Golden Rule and The Spiral Path.** You understand and agree that participation in the Golden Rule Mighty Networks Community is participation in a Community connected to The Spiral Path, and your engagement is intended to be consistent with The Spiral Path spiritual doctrine and beliefs.
3. **[Doctrine reviewed](#).** You acknowledge that you have received access to The Spiral Path doctrine, and you have reviewed it, or you are choosing to participate while exploring whether this spiritual practice is right for you.
4. **Spiritual framing.** You understand that The Spiral Path regards its sacraments as sacred spiritual allies and divine teachers used within sincere religious practice.

2. Eligibility

You represent that you are at least twenty one years of age. If you do not meet this requirement, do not join or access the Community.

3. Community Purpose and Scope

The Community may include education, spiritual discussion, integration style reflection, community gatherings, and access to spiritual guidance, coaching, or harm reduction oriented support, as offered from time to time.

You understand that TSP Parties do not provide mental health treatment or medical treatment through the Community.

4. No Professional Advice

1. **No clinical relationship.** Nothing in the Community creates a therapist patient relationship, doctor patient relationship, or other clinical relationship.
2. **Personal responsibility.** You are responsible for your own choices, actions, and wellbeing.
3. **Independent guidance.** If you have health concerns, a diagnosis, are pregnant or nursing, are taking prescription substances, or have questions about contraindications, seek guidance from a qualified licensed professional before participating in any activity discussed in the Community. (Your existing waiver emphasizes independent advice before engaging in activities related to sacrament use.)

5. Assumption of Risk

You understand and acknowledge that participation in the Community, including any discussions about sacraments or spiritual practices, may involve risks, including physical, emotional, psychological, and legal risks. You voluntarily assume full responsibility for all such risks arising from or related to your participation.

6. Release of Liability, Covenant Not to Sue, Limitation of Liability

1. **Release.** To the maximum extent permitted by applicable law, you release the TSP Parties from any and all claims, demands, causes of action, damages, and liabilities of any nature arising out of or related to your participation in the Community or any activities you choose to engage in.
2. **Covenant not to sue.** You agree not to bring any lawsuit or other proceeding against the TSP Parties for any injury, loss, or damage arising from your participation, whether based in negligence or any other theory of liability, to the maximum extent permitted by law.
3. **Cap on liability.** If liability is found despite this Agreement, you agree that in no event will the TSP Parties' total liability exceed the amount you paid for Community access during the twelve month period immediately preceding the event giving rise to the claim (or if no amount was paid, one hundred dollars), to the maximum extent permitted by law. (Your current waiver caps liability based on amounts paid for services.)

7. Indemnity

You agree to indemnify and hold harmless the TSP Parties from and against claims, damages, losses, liabilities, and expenses (including reasonable attorneys' fees) arising out of or related to your actions, your breach of this Agreement, your misuse of the Community, or your violation of law. (Your current waiver includes release, indemnity, and hold harmless language.)

8. Confidentiality, Privacy, and Respectful Speech

1. **Confidential space.** You agree to keep Community discussions confidential, and you will not disclose the identity, stories, or personal information of other members outside the Community without their express permission.
2. **No recording.** You agree not to record, share, publish, or reproduce Community gatherings, sessions, teachings, posts, or comments without written consent from TSP Parties.
3. **Public posts and non disparagement.** You agree not to make public posts that are false, misleading, or disparaging regarding TSP Parties, their affiliates, or members, and you agree not to post about TSP in a way that violates these confidentiality expectations.

9. Community Conduct Standards

To protect the integrity of the Community, you agree to:

- Act with respect, integrity, and compassion toward other members (aligned with The Spiral Path core values).
- Refrain from harassment, hate speech, threats, doxxing, or coercion.
- Avoid encouraging unsafe behavior, including pressuring others into any practice or protocol.
- Follow all Mighty Networks rules, plus any additional Community guidelines posted by moderators.

TSP Parties may remove content, suspend, or terminate access at any time, with or without notice, to protect member safety, privacy, and Community integrity.

10. Intellectual Property

Community content provided by TSP Parties (including teachings, workshops, downloads, audio, and written materials) is owned by TSP Parties or their licensors and is for your personal use within the Community. You may not copy, distribute, or create derivative works without written permission.

11. Dispute Resolution, Mediation, and Arbitration

Before initiating any action, you agree to attempt to resolve disputes through good faith mediation. If not resolved, you agree that disputes will be determined exclusively by mandatory binding arbitration in Denver, Colorado, governed by the Colorado Uniform Arbitration Act, to the extent permitted by law.

12. Governing Law

This Agreement is governed by Colorado law, without regard to conflict of law principles, to the extent permitted by law.

13. Entire Agreement, Updates

This Agreement is the entire agreement regarding your Community participation. TSP Parties may update these terms from time to time by posting an updated version in the Community. Continued participation after posting means you accept the updated terms.

14. Acknowledgment

By joining or accessing the Community, you confirm:

- You are at least twenty one years old.
- You understand the Community is connected to The Spiral Path religious association and doctrine.
- You voluntarily assume the risks of participation and agree to the release and indemnity terms stated above.
