

S2E7: PROJECTION

Intro: Kalila Stormfire's Economical Magick services. The following entry is for initiated ears only. Case Twenty: Projection.

FADE IN: A knock at the door.

KALILA

Remember what we agreed, do not screw this up for me. We might be able to get something good out of this.

SHADOW

Oh, sure, like maybe getting them to stop smearing you on social media. I bet that's priority numero uno on their list of things to appeal to Kalila for. You should just let me drive, you are such a push over when it comes to authority.

KALILA

Shadow!

SHADOW

Fine. Don't say I didn't warn you, though.

Kalila coughs, sighs, and then walks to the door. The sound of chimes that indicates the arrival that a visitor that is angry.

KALILA

High Priestess. Welcome.

GABRIELLE

Hmm. Thank you for meeting me.

KALILA

Of course. Um, please take a seat.

GABRIELLE and KALILA move to the living room. GABRIELLE sits on the couch, KALILA remains standing.

Would you like some tea?

GABRIELLE

I'm fine. I'm hoping this won't take long.

KALILA

Oh. Okay. Well...(sits in a chair) What is it you needed to talk to me about?

GABRIELLE

I do hope I am talking to...you.

KALILA

I'm sorry?

GABRIELLE

You are Kalila, correct? Not the demon?

KALILA

(clears throat) Y-yes. I am Kalila.  
(laughs nervously)

GABRIELLE

Very well. If you have the thing under control, that will make it easier to convince the Elder Circle.

KALILA

About what?

GABRIELLE

I have a proposition for you. The Coven has been dealing with some very difficult situations lately, not the least of which your...situation. It isn't pleasant to have ex-initiates, but you understand we have to protect the integrity of the institution, don't you?

KALILA

What is this about, High Priestess?

GABRIELLE

We have felt that letting you go so abruptly might have led to your current...predicament. The Coven wishes to alleviate that. We know that Gloria has been working with you to deal with your Shadow, but we believe it is too dangerous to leave untreated for so long. You've been like this for over a year now, with little improvement from what I've been told.

KALILA

Wait...you've been keeping tabs on me?

GABRIELLE

We keep tabs on all initiates, excommunicated or not. It is a way to ensure the health of our community, you see. Oh, don't look at me like that. This was for your own good, Kalila. You have done something unprecedented. Dangerous. We wouldn't want other inexperienced witches try to do the same thing.

MUSIC FADE IN: COLD & HARD - BLUE DOT SESSIONS

KALILA

It's not like I'm out here advocating for everyone and their mother to split their soul.

GABRIELLE

We're getting off topic. The Coven would like to offer you a probationary period, a way for you to return to the Temple.

KALILA

What?

GABRIELLE

You will get additional assessment by our healers. You remember James Rainboon? He has been doing additional

research into your particular ailment. I think you'd appreciate some additional help. Also, we would be willing to hire you as a financial assistant. This comes with a healthy salary, of course. You won't have to survive off of selling tarot readings and spell bags. And you won't have to live in Southside anymore.

KALILA

I...this is...surprising. I thought excommunication was permanent?

GABRIELLE

You are a special case, Kalila. We'd be remiss if we didn't consider all the factors. So? When would you like to schedule some time with James?

KALILA

Oh...um. (gathers herself) This is a very generous offer, High Priestess. I think I will need some time to consider.

GABRIELLE

There's a lot the Coven is doing, Kalila. We won't wait around forever.

KALILA

I understand that. I just, this is a little sudden. I have clients I've already scheduled for. I can't exactly cancel on them just yet to immediately start a new job.

MUSIC FADES OUT.

GABRIELLE

Hmm. Very well. When you do make up your mind, send Gloria along with your decision. Sooner than later, I hope.

KALILA

Of course. I'll let you know.

GABRIELLE

I'll be on my way then. (stands up) I don't like to leave my car parked in this part of town for long.

SHADOW

We don't like you parked here either.

GABRIELLE

Excuse me?

KALILA

Are you sure you won't like some tea to go either?

GABRIELLE

(suspicious) No, thank you.

GABRIELLE walks to the door and opens it.

Goodbye, Kalila. I expect to hear from you soon.

KALILA

Drive safe, ma'am.

GABRIELLE leaves, and the door shuts. ELDRITCH meows.

SHADOW

Pushover.

KALILA

Oh, shut up.

SHADOW

You are considering her proposal though, right?

ELDRITCH meows.

KALILA

No! Are you kidding? They're just going to use me again.

SHADOW

It's what you want, though. C'mon. You constantly complain about clients. Their particulars. Their demands...and for such low return on investment. And also your neighbors walk really loudly.

ELDRITCH meows.

Wouldn't it be easier if you had some security?

KALILA

Yeah. It would. At the same time, I'm not going to go back to a coven that didn't value me in the first place. You were the one to push me out. Why are you so eager I go back now?

ELDRITCH meows again and hisses.

Sorry, Eldritch, what was that?

ELDRITCH chirrups and the TV begins to sputter on, changing channels until it hits a news station.

COOKING CHANNEL. MUSIC - UKERIFF BY ASA

CHEF

If you don't have troll flowers at home, store bought is fine--

CLIP CUTS. MUSIC CHANNEL: MUSIC - HOLLYWOOD TRASH by HIRO

CUT OUT HIRO MUSIC, CUT IN NEW STATION WITH MUSIC: WHITE FILAMENT BY BLUE DOT SESSIONS

REPORTER 1 (on site)

--(We are still) learning more from witnesses. A number of sirens have fled to the banks closest to the South, where this...this event seems to stop.

REPORTER 2 (in studio)

Again, we have Steve Romero on the scene of what appears to be a massive magickal event near the Brushland River. Steve, we know glamour is a strong suit of the Fae, but can you describe the suspected culprits of this unprecedented breach of border law?

REPORTER 1 (on site)

Well, Amy, it appears to have been the work of a small group of individuals. They were certainly hard to see, they fled the scene almost as soon as I arrived. But our sources have confirmed that a number of Fae and possibly changelings were in the area at the time. Witnesses who were at the park near the river say that there was a ripple starting from the Eastern riverline that moved southwards, towards Southside. Police and their witch attachment have been keeping people away from the new Fae border. We aren't sure how dangerous it is to go near, but there seems to be your standard enchantments woven into the land itself. We can still see beyond the event, much like we've been able to see the Fae hill on the other side of the river. But like many others have reported before me, the Fae magic makes the trees more reactive to human touch and time gets warped even from a short distance from the border. A few witnesses have said they were drawn to the border almost immediately. Police Chief Bruce Newton will be making a statement shortly, likely regarding the threat this new expanded border poses to the citizens of Brushland.

REPORTER 2 (in studio)

It's certainly a concerning development. Have you heard anything

from witnesses or police about a possible connection to the latest drama with the Coven and their support of the changeling repatriation initiative?

REPORTER 1 (on site)

Yes, Amy. A few of the witnesses I talked with were afraid that this is the next step in other Iron War. Now, there hasn't been any violence. Most of the people I talked with feel like this is more of a power move by the Fae to challenge the actions of the Coven. Their magick stopped at the river after all.

MUSIC FADES OUT.

REPORTER 2 (in studio)

Thank you, Steve. I've just been told we have High Priest Hector Ivory on the line. Good afternoon, Hector.

HECTOR

It's been an afternoon for sure, Amy.

REPORTER 2 (in studio)

It certainly has. Can you tell us more about the Coven's reaction to this event? Are you concerned that this is an escalation beyond rhetoric? Considering the already charged policy conversation between the leadership of Brushland and the fae, I mean?

HECTOR

Well, there is clearly a threat to the community here. This Underground, a group of fae and changeling extremists, they have stepped beyond their radical messaging to the people of this city and have now encroached on sovereign land. The Coven calls on the government to take immediate steps to push back this awful magickal attack on the city.

Brushland is already struggling with an influx of werewolves, immigrants, changelings, and under-qualified workers. Our resources are stretched thin. This is the straw that breaks the camel's back, if I can be so bold. It is unacceptable.

REPORTER 2 (in studio)

What about the Fae leadership? Have you received any communication from the King or Queen?

HECTOR

No. And we don't expect to, to be perfectly honest. They likely condone this act. The Coven would love to sit at a table and talk about their supposed grievances civilly. We made some progress last year, but I think we've passed that point now.

REPORTER 2 (in studio)

You mentioned immediate steps the government can take to address the situation. What is the Coven proposing, exactly?

HECTOR

Well, there are a number of options to consider. Securing the border, of course, is one option. The Coven is talking with Elders who have experience implementing high-level warding on the Arizona border. However, those were largely for human illegal immigrants--not fae and changelings. We would need additional support from witches who have experience with fae magick. Another option is legal. If changelings are so keen on being back with their people, we should make it easier for them instead of giving into rhetoric and dangerous acts like what we've seen today.

REPORTER 2 (in studio)  
You're suggesting deportation.

HECTOR  
No, no, no. Of course not. Simply put, our system for identifying and handling changelings is broken. For those who cannot assimilate and live according to our laws, yes. Deportation should absolutely be on the table. For those who are not comfortable here, they should have an easier time going to a place where they would be more comfortable instead of joining into groups like the Underground.

REPORTER 2 (in studio)  
Thank you for your time, High Priest. We are now turning to our magick policy consultant, Dr. Harriet Foxglove...

KALILA shuts off the television, picks up her phone and starts dialing. She's breathing heavily.

SHADOW  
What are you doing? You don't think Gloria isn't already all over this?

KALILA  
If she knew about what the Coven wanted from me, and what the Coven was planning with the changelings, she should have told me.

SHADOW  
Ah, an interrogation. This I can get behind.

KALILA  
Gods, she's not answering her phone.

SHADOW  
Try the library?

KALILA

Right.

KALILA dials again. The phone rings, and HEATHER LOVELY picks up.

HEATHER

Brushland Central Library. How can I help you?

KALILA

Oh! Heather, is Gloria around?

HEATHER

She went out for lunch, she'll be back soon but--are you okay? What's...oh. Oh wow, girl, you are a mess right now. Did Gabrielle really say that to you? Kalila, you know she's trying to use you. And this fae border thing is not your fault, don't blame yourself. Clarence is grown, he can make choices for himself. You can only be what you are, a loving friend.

KALILA

Heather!

HEATHER

You know I can't help it, sweetie. Psychic powers don't just turn off. My advice? Go find Desiree, gather up your friends. Especially Clarence, he's probably not in a good place right now. This storm is not going to pass any time soon. I'll let Gloria know you called if she hasn't seen your missed call already. And don't go blaming her for this either. You have no idea what she's been doing to protect you.

KALILA

I...um. Are things good over there?

HEATHER

It's fine. And just a reminder, just in case...this is a safe zone, alright? We've got magick here stronger than you think.

KALILA

Oh. Okay. I'll...I'll let you go. Thanks for picking up.

HEATHER

Just doing my job. Answering the call to those who need it.

KALILA

Right...

HEATHER

And Kalila?

KALILA

Yeah?

HEATHER

You don't need approval from anybody. You're exactly where you need to be. Oh! Say hi to Shadow for me! Bye!

KALILA

Bye...(hangs up). Guess I should call Desiree.

SHADOW

(mostly to herself) You don't talk with Heather much, do you?

KALILA

No. Why?

SHADOW

Hmm? Oh. No reason. Just think you should spend more time with people who can see right through you like that. Go ahead. Call Desiree. Actually...text her. She might be busy.

KALILA

Yeah...yeah, I should. (coughs as she types)

FADE IN: VEINS OF SILVER - BLUE DOT SESSIONS

SHADOW

(clears throat, testing) Okay. Are we good? Perfect. Just stay settled in the dark, my dear Kalila. I'll handle the rest. No need to get your hands dirty here. No need to seek out approval from some authority figure, be it Gloria or Gabrielle or even the gods. You may not want to get involved, but the storm is here. You can't do anything *but* be involved. So here we go. I'll be the brave one. I will take the first step. I don't need approval. I never have.

So.

Let's try something...new. (turns into Kalila's voice) Excellent. It's working. Okay. Let's learn something, hmm? And let's have some fun doing it.
