## Minutes Special Meeting September 24, 2025

Chair Jay Ferreira called the meeting to order at 6:20 and took roll call.

Chair Ferreira explained that the purpose of this meeting is to approve the eligibility list of FY26 projects. Members present reviewed the list and raised questions.

## The 16 applications were:

- 1. St. Paul's Church Window Restoration
- 2. Wistariahurst Butler's Pantry
- 3. Holyoke Merry-Go Round Horses
- 4. Holyoke Health Center Window Restoration
- 5. Nick's Nest Chicago Band Box
- 6. War Memorial Foundation, Walls, Lighting and Audio Equipment
- 7. City Hall Granite Steps Study
- 8. City Hall Steps Restoration.
- 9. City Hall Stained- Glass Windows- final section
- 10. Anniversary Hill Ball Fields
- 11. Springdale Park Restrooms and Golf Cart
- 12. Bonin Field Safety Measures
- 13. Scot's Tower Restoration
- 14. Community Gardens
- 15. Pouliot Pool Improvements
- 16. Roberts Field Sports Complex Upgrades

After review and discussion, it was determined that three projects did not meet the eligibility requirements under state and local standards, St. Paul's Church windows because they depict

religious iconography, the War Memorial audio system is not historic and the Springdale Park Golf Cart application is not eligible under and CPA guidelines.

A motion to approve the eligibility to apply for CPA funds for all of the projects except 3 that were deemed ineligible, St. Paul's Windows, Springdale Park golf cart and the War Memorial Audio system with the additional caveat that the Nick's Nest Chicago Band box will have to pass Holyoke Historic Commission review was made by Ferreira and seconded by LaRose. The motion passed unanimously.

A motion to <u>extend the deadline</u> for the full application to Friday, November 7, 2025, including a request that the Chicago Band Box applicants present their project for review to the Historic Commission by October 24, 2025 was made by Falcetti and seconded by LaRose. The motion passed unanimously.
