Abstracts are made in 2 languages, English and Indonesian

INTRODUCTION

In Introduction, Authors should state the objectives of the work at the end of the introduction section. Before the objective, Authors should provide an adequate background, and theoretical frameworks which are used in order to discuss the problems as the objective of the research to show which is the best of previous researches, to show the main limitation of the previous researches, to show what do you hope to achieve (to solve the limitation), and to show the scientific merit or novelties of the paper. Avoid a detailed literature survey or a summary of the results. The article should be between 10-13 pages, single spaced, 11-point Times New Roman font, excluding references and appendices. Use no indent for the first paragraphs and do not leave a space between paragraphs. The following paragraphs is indented first line 0.5cm.

In Methods, Authors should state the methods which were used in the research by very short literature survey in order to record the existing solutions/method.

RESULT AND DISCUSSION

Results should be clear and concise. In the Discussion, it is the most important part of your article. Make the discussion correspond with the finding but do not reiterate the discussion.

CONCLUSION

Conclusions should answer the objectives of the research. Tells how your work advances the field from the present state of knowledge. Without clear Conclusions, reviewers and readers will find it difficult to judge the work.
