- PAT (Puppy Aptitude Test) is open to puppies 4 months to 9 months of age.
- All dogs six months of age and older who have not yet earned a title will start in Level I.
- After earning a title in Level I, the dog can progress (move up) to Level II and also continue to compete during the same trial for Level I Q's to earn a Level 1 X title.
- Check the Level(s) you want to enter for that day for that class.
- Check each of the trials for each class that you want to enter that day. You can enter none, one, all and any combination for each day/class. There are no resets for Level III.
- Class order will be determined and sent out in an email prior to the event.
- **Make sure to write your dogs name and NASDA number on each page of the entry form to keep them together**

Awards:

Ribbons are awarded for qualifying score, High in Class. & New title ribbons will be awarded. We will have a judges choice award for each day. Awards will be placed on table in building and scores posted on the wall. Ribbons will be self serve except for title and judges awards.

Venue:

Exhibitors will be crating in their vehicles. **Ice-Bern Farm LLC** reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog. Absolutely No alcohol or drug use allowed during the trials. If suspected, you will be asked to leave refund will be issued and you will not be permitted at future events. THERE IS NO SMOKING ON THE PROPERTY.

Notice to Exhibitors:

- Bitches in season are permitted, they will run last and in pants. Please potty her in authorized potty area for BIS.
- Refunds will be mailed 7 days after the event.
- No refund for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused, or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.

- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area.
- Please be courteous and pick up after your dog. There is a designated **potty area. Remember any part of the grounds could be come a search area so do not just let your dogs potty wherever..**
- All entries must be accompanied by entry fees to be valid.
- A declined payment or returned check does not constitute a valid entry. There will be a \$50 fee for any returned check or payment. Checks must be made payable to **ICE- BERN FARM LLC.**
