Description: Four boxes and 10 card file drawers of transcribed archival materials relating to Lake Champlain and its significance during the Revolutionary War and the surrounding time period.

Significance: This collection provides a considerable amount of documentary information about the Revolutionary War in and around Lake Champlain. Providing a comprehensive picture of military activities, the material highlights the strategic and commercial importance of Lake Champlain in the era. The documents were transcribed by Oscar Bredenberg from originals found in U.S. and Canadian archives. He then compiled much of the material by date, producing a useful and comprehensive chronological survey of battles and naval engagements in the Champlain Valley.

Historical note:

Oscar E. Bredenberg, a business manager and amateur historian, was born April 9, 1893, in Brooklyn, New York. He lived most of his life in Champlain, New York. A veteran of World War I, he married Blandine Sturtevant from Dixfield, Maine in 1919. They had two children, Robert and Elizabeth.

While still a teenager, Oscar started a ski manufacturing business at home with his brother, Henrick Bredenberg. As the business grew, making a brand of skis called Broadmount, Oscar left to take a job at the Sheridan Ironworks where his uncle Alfred Bredenberg was an engineer. Later becoming plant manager there, Oscar retired in 1958 after 49 Years with the company.

After retirement, he pursued his interest in the Revolutionary War, focusing on action around and on Lake Champlain in New York, Vermont, and Canada. During the summers of 1960-1961, he was part of a small group that excavated the sunken remains of the *Congress* in Arnold Bay, Vermont. His most important work was his research at archives in Canada and the United States, where he identified and transcribed all or portions of documents relevant to his subject. He also used published volumes of Revolutionary era documents to supplement his research. Compiling his transcriptions in chronological order, he created a documentary account of military activities in the Champlain Valley.

Bredenberg wrote articles based on his research. They appeared in publications of the Clinton County Historical Association and the Fort Ticonderoga Museum.

In the 1950s, he built a summer home at Block House Point, North Hero, Vermont. Historically, the site had a blockhouse that was used during negotiations between the representatives of the British government and the Republic of Vermont near the end of the Revolutionary War. Bredenberg designed the exterior of his house to look like the original blockhouse. The site also has an historical marker commemorating the British Government/Republic of Vermont meetings.

Oscar Bredenberg died February 19, 1970, and was buried in Champlain, New York.

Scope and Content:

The Oscar Bredenberg Papers highlight the strategic importance of Lake Champlain and the Champlain Valley during the Revolutionary War. The collection contains transcripts of complete and/or excerpts of documents relating to military activities on and around Lake Champlain in Vermont, New York, and Quebec. There are also a few original revolutionary era documents. The transcripts created by Bredenberg are mostly undated but are likely from the 1950s and 1960s when he did his research on the Revolutionary War. There are a handful of photocopies of original documents regarding the Odell Family. Some, but not all transcripts include references to where the original documents are located.

Using a variety of sources, Bredenberg was able to compile a complete picture of day-to-day action in the Champlain Valley during the war. His research included work in various collections at the National Archives in Washington, D.C., the George Washington papers, as well as historical maps at the Library of Congress in Washington, D.C., the Frederick Haldimand papers at the Library and Archives Canada, and collections of the Vermont Historical Society in Montpelier, Vt. In addition to these and other archives, Bredenberg used some published sources to compile his transcripts and notes regarding the Revolutionary War. Unfortunately, he was inconsistent and/or vague with citations. In many cases his sources are not identified or incomplete.

These papers are divided into 5 series: I. Naval action, Soldiers, and Spies, II. Day by Day Action, III. Significant Individuals and History of the Valley, IV. Publications, V. Index Cards. They are arranged largely in the same order as they were when given to the Bixby library. The papers have been removed from their original notebooks and placed in folders for preservation purposes.

Series I: Naval Action, Soldiers, and Spies

This series tells the story of the back-and-forth control of Lake Champlain. When the war began, the British occupied several forts along the lake, controlling the flow of ships and supplies. One of the first naval battles of the Revolutionary war, known as the Battle of Valcour, is documented in Bredenberg's carefully compiled transcripts, along with subsequent naval fights on the lake. Included is information about several ships, including British ships captured by colonial troops, the *Katherine*, which was renamed, *Liberty*, the *Betsy*, renamed Enterprise, and the *Royal Savage* among other vessels. It also contains transcripts of documents relating to Pliny Moore, a military officer and later founder Champlain, N.Y., as well as material on individual military pensioners, deserters, and loyalists.

Series II: Day by Day Action

This series contains a comprehensive account of day-by-day action in and around the Champlain Valley. It consists of Bredenberg's transcripts taken from documents such as letters and reports recording military and naval activities.

An index to this series is available in the index card series of the Bredenberg papers. Index entry references that begin with an X or XX refer to the material in this series.

Documents in this series were originally housed in Bredenberg's notebooks labelled 1-24. They are available in digital format <u>here</u>.

Series III: Significant Individuals and History of the Valley

The material in this series focuses on individuals and local communities. Some of them supported the colonial cause while others were loyalists and acted as soldiers and/or spies for the British. There are

transcripts of documents relating to the *Liberty*, a naval vessel, as well as notes about the town of Skenesboro, now Whitehall, N.Y., and New York's Washington County. In addition this series contains photocopies and some tracings of historical maps of Lake Champlain.

Series IV: Publications

This series contains articles and short publications. Most pertain to topics of interest to Oscar Bredenberg including the Battle of Plattsburgh, N.Y. and the Civil War era raid at St. Albans, Vermont. Other publications give brief histories of the towns of Shaftsbury and Shelburne in Vermont, and Cumberland Head and Champlain in New York.

Series V: Index Cards

Bredenberg created a card index to personal names and places mentioned in the transcripts he made as well as in some published sources that he used in his research. Many of the index cards refer to a numbering system that he assigned to the transcripts. Using an X, XX, or Z preface, he numbered the pages by date. They correspond to the material arranged by date order in Boxes 1 and 2 of the collection. Other index card references use incomplete or obscure abbreviations.

Employing his own abbreviations when citing sources on these cards, Bredenberg seems to have left us no complete record of all the documentary sources he consulted. However, the majority of references, using an X or XX before a date, refer to his chronological compilations found in Boxes 2 and 3 of this collection. There is an orange index card at the front of the first card drawer that lists his incomplete source information.
