Use a variety of primary and secondary sources to deepen your understanding of the partition of Africa.

Process

Analyze the following sources. If you are using these sources to respond to an essay prompt, you should <u>underline</u> or <u>highlight</u> any evidence that will support your claim. You can also use the Quick Sourcing Tool.

Document 1

This is an excerpt from an 1877 essay by the prominent British politician and businessman, Cecil Rhodes (1853–1902).

I contend that we English are the finest race in the world, and that the more of the world we inhabit, the better it is for the human race. Just fancy those parts that are at present inhabited by the most despicable specimens of human beings. What a change there would be if they were brought under English influence. Look again at the extra employment a new country added to our dominions provides for us. I contend that every acre added to our territory means the future birth to some more of the English race who otherwise would not be brought into existence. Added to this the absorption of the greater portion of the world under our rule simply means the end of all wars. Having these ideas what scheme could we think of to forward this object.

Document 2

Jules Ferry (1832–1893) was prime minister of France (1880–1881, 1883–1885) when he delivered these comments as part of a speech in 1884.

The policy of colonial expansion is a political and economic system ... that can be connected to three sets of ideas: economic ideas; the most far-reaching ideas of civilization; and ideas of a political and patriotic sort. In the area of economics, I am placing before you, with the support of some statistics, the considerations that justify the policy of colonial expansion, as seen from the perspective of a need. [This need is] felt more and more urgently by the industrialized population of Europe and especially the people of our rich and hardworking country of France: the need for outlets [exports]. ...

Gentlemen, we must speak more loudly and more honestly! We must say openly that indeed the higher races have a right over the lower races. ... I repeat, that the superior races have a right because they have a duty. They have the duty to civilize the inferior races. ... In the history of earlier centuries these duties, gentlemen, have often been misunderstood; and certainly when the Spanish soldiers and explorers introduced slavery into Central America, they did not fulfill their duty as men of a higher race. ... But, in our time, I maintain that European nations acquit themselves with generosity, with grandeur, and with sincerity of this superior civilizing duty.

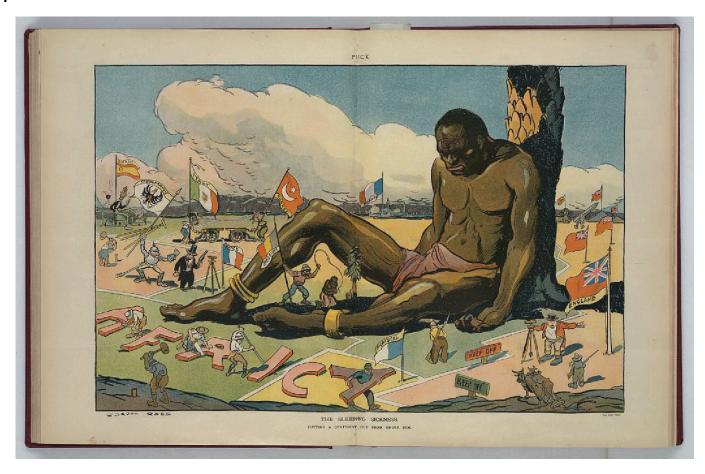

Document 5

This excerpt contains the introduction and a portion of section six from the General Act of the Berlin Conference on West Africa, February 26, 1885.

General Act of the Conference at Berlin of the [representatives] of Great Britain, Austria-Hungary, Belgium, Denmark, France, Germany, Italy, the Netherlands, Portugal, Russia, Spain, Sweden and Norway, Turkey and the United States respecting: (1) Freedom of trade in the Basin of the Congo; (2) the slave trade; (3) neutrality of the territories in the Basin of the Congo; (4) navigation of the Congo; (5) navigation of the Niger; and (6) rules for future occupation of the Coast of the African Continent, in the Name of God Almighty. ...

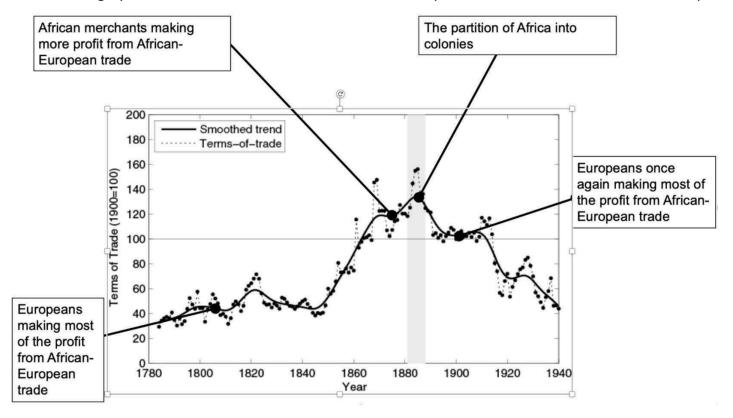
CHAPTER VI: Declaration Relative to the Essential Conditions to be Observed in Order that New Occupations on the Coasts of the African Continent May Be Held to be Effective ...

ARTICLE 34: Any Power which henceforth takes possession of a tract of land on the coasts of the African continent outside of its present possessions, or which, being hitherto without such possessions, shall acquire them, as well as the Power which assumes a Protectorate there, shall accompany the respective act with a notification thereof, addressed to the other Signatory Powers of the present Act, in order to enable them, if need be, to make good any claims of their own.
