RAD Sudhir | 5 Minutes | Information/Discussion

The Region VI Delegate Assembly shall be reminded about the SSCCC-approved Community Agreements.

The SSCCC-approved Community Agreements were read and discussed by the Region VI Executive board and Delegates.

B. Delegate Roundtable

Regional Officers & Delegates | 15 Minutes | Information/Discussion

This will be a time for the Region VI Delegate Assembly to introduce themselves and to discuss various aspects of the organization and leadership over the past month.

The Region VI Executive Team and Delegates roundtable were shared. This provided an opportunity for individual introductions, updates on recent events, and ongoing initiatives from the past month.

III. BUSINESS

A. Delegate Orientation

RAD Sudhir & SI Kim | 30 Minutes | Information/Discussion/Action

The Region VI Delegate Assembly will receive information and discuss delegate responsibilities, including delegate reports, committee reports, and SBA reports.

RAD Sudhir and Student Intern Kim led the Delegate Orientation, providing an overview of the SSCCC, its pillars, and the roles and responsibilities of delegates. The presentation covered key topics such as delegate duties, mandatory regional meetings, reporting requirements, and a detailed breakdown of regional officers' responsibilities and committees.

Student Intern Kim also introduced the SSCCC Conferences; the Advocacy Academy which is happening November 22-24, 2024 and General Assembly which will be held on April 04-06, 2025. While RAD Sudhir emphasized that delegates are eligible for stipends provided they fulfill their duties, noting that any unmet obligations would result in deductions.

Student Intern Kim presented his monthly report card process, as well as discussed resolutions. Lastly, RAD Sudhir and Student Intern Kim addressed the importance of compliance with the Brown Act.

Cuesta College raised a concern regarding stipend deductions in the event that both the delegate and alternate delegate are unavailable. LAD Pai clarified that stipends would still be deducted, even if the absence is due to a course conflict beyond the delegate's control. VPRA Alexander expanded on this, noting one alternative; if both the delegate and alternate are unavailable, the President of the student body may step in to represent the campus, provided they are neither a delegate nor a regional officer. In such cases, the President would be able to act as a voting member.

Cuesta College further inquired whether a substitute could be designated if the President is already the delegate and the alternate is as well not available.

VPRA Alexander explained that only the Delegate, Alternate, and President are authorized to represent a campus, emphasizing the importance of having these roles filled by different individuals.

Ventura College raised a question about the reimbursement process. RAD Sudhir provided clarification on reimbursement for travel for event participation and delegate assemblies, while noting limitations on expenses such as fuel or food. She mentioned that further details would be shared via email.

B. Special Election

RAD Sudhir | 30 Minutes | Discussion/Action

The Region VI Delegate Assembly will hold a special election for open Region positions.

RAD Sudhir presented the candidates who had submitted their candidate statements; Moussa Haj Ghaban from College of the Canyons, Ada Muzoglu

from Moorpark College, and Renelyn Wilson from Antelope Valley College. Following this, RAD Sudhir opened the floor for additional nominations. Executive VP Simon outlined two processes for candidates who had not submitted their candidate statements and eligibility/verification form, explaining that individuals could either be nominated by a delegate, with a second required to accept the nomination, or they could self-nominate and also require a second from a delegate.

With no further nominations from the floor, RAD Sudhir closed the nomination period and invited each candidate to introduce themselves, share their goals for the position, and discuss their proposed initiatives.

After the candidates' introductions, RAD Sudhir invited them to the front and opened the floor for questions:

1. What is your understanding of the duties of a treasurer, and have you reviewed the responsibilities of the role?
2. What is your stance on AB 1705? (LAD Pai provided a brief description of AB 1705).
3. How would you utilize the treasurer position if elected, and what steps would you take to fulfill your goals?

RAD Sudhir then proceeded with a roll call election for the candidates.
