Appendix A:

AT ANY TIME DURING THE MEETING...

- **QUESTIONS** You may interrupt to ask a question by saying, "I have a question" or "Point of Information." Your question must be answered before the meeting continues.
- **POINT OF ORDER** You may interrupt if you think the meeting is being conducted improperly by saying, "**Point of Order**," and stating your complaint. The Chair must address your complaint and take appropriate action before the meeting continues.
- **OVERRIDE THE CHAIR** You may challenge a decision made by the Chair (ie a time limit, ruling, other decisions) by saying, "I move to override the Chair's decision." An immediate vote is taken without discussion, & a two-thirds majority overrides.
- **30 SECONDS** If a member(s) engages in unsafe behavior by not respecting the boundaries of others, or someone perceives that to happen, any member may call for a **"Time out"** or **"Thirty seconds."** Everyone ceases talking and spends time seeking guidance from Higher Power. After 30 seconds, someone calls "time," and members may choose to say the Serenity Prayer before resuming the meeting.

Saturday

OLD BUSINESS

(5 min for each motion)

Appendix A: Old Business is made up of motions tabled from previous intergroup meetings.

- a. Chair restates the motion at hand to be sure it is understood.
- b. Chair conducts pro and con discussion (approx. 1 min arguments).
- c. Chair may extend discussion time, or any member may request an extension of time from the Chair.
- d. Anyone may move to end discussion at any time by saying, "I call the question." A vote whether to end is taken immediately, & 2/3 majority rules.
- e. When discussion has ended, either by a call for the question vote or automatically by expiration of allotted time, the Chair calls for 30 seconds of silence, then conducts a vote on the motion at hand.

TABLED FROM LAST MONTH:

I motion we make an In-Person Set Up/Greeter position while we try out hybrid, position would last 3 months at a time. They would:

- 1. Arrive early, set up the room, and join the Zoom meeting
- 2. Welcome in-person attendees, especially Newcomers
- 3. Try to find a person to cover if their plans change and inform lacc@lacoda.org if there's no greeter cover Ruth

Austin- Amend to that I put in the script- who will go in-person next month? And they have to get it covered or tell us if they can't come, only one month commitment. Sharon seconds. Put it early in the script with NEXT MEETING DATE ANNOUCENMENT, if no one, then at the end of reports ask again. Then ask, does anyone have time to contact the webmaster to say not to come in person that month if no one volunteers? 5 of 5- motion PASSES

Rationale: It's not in anyone's job description to remember to ask if anyone is hosting in-person. Lloyd had been coming in-person but won't be able to attend intergroup anymore because of a schedule change (he's still doing Treasury duties).

Last month, a newcomer came and no one was in-person to greet them. Before that, it had been working out, but maybe there's a way to set up something where we all communicate a little more to help it keep working out. Doesn't need to be super formal, motion is to bring up the concept.

The old version of this motion was to give someone the responsibility of finding a different person each month to volunteer to come in-person and to remind that person. (Like a speaker seekerish

thing.) Could be amended that I put in the script- who will go in-person next month? And they have to get it covered or tell us if they can't come. I'm open to whatever!

Technically, we're still "trying out" hybrid. So this is a trial position too? If we commit to hybrid and this position, we'll need to add it to the Guidelines later.

Notes from April:

DISCUSSION in APRIL: Sharon likes the idea and volunteers to take the 1st 3 months. Someone asked it to be tabled voting on this new position since we are in the process determining where we will be and the meeting will be over soon so we don't want to rush. THIS IS BEING TABLED.

NEW BUSINESS

(5 minutes for each motion)

Appendix A: New Business is made up of new motions about proposed sub-committees, activities, events, expenses, items for the monthly mailing, new policy or procedures, changes to existing policy or procedures, etc. **NEW BUSINESS MUST BE PRESENTED IN WRITING TO THE CHAIR BEFORE THE START OF THE MEETING. INCLUDE YOUR NAME.** [lacc@lacoda.org or chair@lacoda.org]

- a. All new business must be presented in the form of a motion, which is a yes-or-no proposition beginning with the words, "I move that..." or "Motion, that..." If preliminary discussion is needed to clarify a motion, it should take place outside the meeting, not during the limited meeting time.
- b. The Chair and Treasurer may immediately kill the motion if it is determined to be invalid, or if the funds or means needed are not available.
- c. Every motion must be seconded before discussion begins, to ensure that at least one other member wants to discuss it.
- d. When a motion is seconded, the Chair restates the motion.
- e. The Chair opens discussion by asking for an opening argument (1 minute).
- f. The Chair conducts pro and con discussion (~1 min arguments).
- g. The Chair may extend discussion time, or any member may request an extension of time from the Chair.
- h. Any voting member may move to table the motion at any time. A vote whether to table is taken immediately and majority rules.

i. Any member may move to end discussion at any time by saying, "I call the question." A vote whether to end discussion is taken immediately, and two-thirds majority rules.

j. When discussion has ended, either by a call for the question vote or automatically by expiration of allotted time, the Chairperson calls for 30 seconds of silence, then conducts a vote on the motion at hand.

The meeting will end at 10:45 am, and all Old and/or New Business not addressed by that time will be added to the next LACC Agenda as Old Business.

Motion 1 from Ruth:

I motion we move permanently to St. Bede's (paying \$25 per month for rent each month) and continue to pay \$25 per month extra for SHARE for storage for July, August, and September to slowly move literature over, see what doesn't fit, and make decisions about it over time.

Re: tues women's meeting GCed (group-conscienced) to let us use the equipment

a speaker- \$30,

a camera- was donated to them but it'd be around \$30,

an adapter to plug everything into the laptop- \$20.

TV belongs to church.

We can use the equipment and if we break it, we're responsible for it.

We use our personal laptop.

We're sharing the storage space with Tues Women's meeting. It's an annual fee of \$60- the women's meeting already paid this for this year.

Con: Austin- pro the motion but it's not the most central location

Con: Ruth- pro the motion, but good to know what we're consenting to- there's a key that multiple people have access to that unlocks our cabinet with the literature

Austin: if someone steals lit, they really need it

Sharon: They'll change the lock and only give it to us, the tues meeting and the man at the church, so those are the people who would have the key to our literature

Arthur: Is it possible to get our own cabinets? It's good to be self-supporting

Sharon: I'll ask

5 of 5 - unanimous- passes

Motion 2 written by Group last month:

We motion to formally plan how we will distribute the remaining third edition Workbooks in our Literature inventory It would go as follows:

- 1. One-third of inventory would be sold at a discount (from \$13 down to \$6 per book) and would be sold in-person to fellows in program
- 2. One-third of inventory would be sold at a discount (from \$13 down to \$6 per book) and would be sold through direct outreach to for-profit hospitals & institutions
- 3. One-third of inventory would be donated at no cost through direct outreach to non-profits and government entities such as prisons

Amendment by Arthur, seconded by Ruth- add strikethroughs for clarity

Amendment by Ruth, seconded by Austin- Stick to these percentages for 6 months 5 of 5 passes
