1. Entries in Livestock Departments close July 18 at 4 p.m.

3. Exhibitors in all departments must purchase exhibitor's ticket for \$17.00 Exhibitor's tickets not transferable. \$17.00 ticket will allow unrestricted entry to Fairgrounds at all times. Make checks payable to Wisconsin Valley Fair.
4. When making entries, blanks must be filled out completely, giving name and register of every animal - in groups as well as individual Divisions. No tests will be performed after arrival at the fair.

General Rules and Regulations

Livestock Entries

1. Registered purebred status shall be documented by a certificate of registry from the appropriate breed association or society or by a copy of the application for registration. Certificate of registry will be required before stock is taken into the judging ring.
2. No entries will be accepted in Livestock or Poultry Divisions that are purchased after July 1st of the current year
3. Exhibitor will be required to furnish their own feed and bedding

Premiums

4. No special premiums will be awarded in any department unless specifically stated
5. Where only one exhibitor is competing in any Division, judge may recommend no premium, or first, second, third or fourth premium, as merit warrants
6. Should any premium award be made on false evidence or representation, or violation of rules of the Society, prize money awarded that entry shall be forfeited to the Society

General definitions

7. • Department - as it relates to the organization or structure of fairs means an animal species, production group, or other principal subdivision of a Fair
*Division - an age group classification within a fair department; for example, junior, open Division or senior citizens.
*Division - a breed, type of produce, crop or food, a specific age or educational grade group in which exhibits may be entered
*Class - a specific age or sex grouping of animals, crop variety or style of exhibit

Superintendents

8. Superintendents are vested with full responsibility and charge of exhibits in their departments and shall see that all rules and regulations pertaining to entries and exhibits are complied with
9. Superintendents shall immediately report to the Fair Administrator any irregularities coming to their attention, or any matter that may require immediate consideration
10. No superintendent or other employee/volunteer shall offer advice or suggestions to any judge as to the merits of any exhibit
11. No superintendent may exhibit in the department in which they are working

Protests

12. Protests upon any grounds whatsoever, and against any employee, with exception of judges, must be filed in writing with the superintendent of the department on the same day such protested action may be taken. Such protest will then be presented to the Board of Directors at its first meeting, and the aggrieved person will be given the opportunity to be heard.

Exhibits

13. No exhibit shall be removed from the grounds prior to the hour of 5 p.m. Sunday. In all cases, claim checks must be presented before exhibits are released.
14. The Society agrees to exercise every possible precaution in safeguarding exhibits but assumes no liability whatsoever for any loss arising from fire or theft, or for any damage/injury that may be incurred
15. The Society reserves the right to reject any exhibit. Should any exhibit require more than ordinary space, arrangements for entry must be made at least five days in advance of the opening of the Fair.
16. All persons entering exhibits bind themselves to abide by the rules and regulations adopted by the Society relative to entries, exhibits, judging, and payment of premiums and general conduct of the Fair.
17. Exhibitors making entries and not exhibiting shall forfeit all fees for stalls, pens or space or exhibitor's tickets

Exhibitors Liability

18. Anyone exhibiting at the Wisconsin Valley Fair will be responsible for any damages in case of accident or injury to anyone as a result of his or her exhibit

Administrator's Office Hours

19. The Administrator's office is in the Exhibition Building at the fairgrounds. Beginning early June through the completion of the Fair, office hours will be from 9 a.m.- 4 p.m. Monday – Thursday and 9 a.m.- noon on Friday. Personal interviews may be done by appointment at other times. Times are subject to change.
20. All communications should be addressed online by visiting www.wisconsinvalleyfair.com or e-mailing jodi@wisconsinvalleyfair.com.

Those participating in the Wisconsin Valley Fair may request reasonable accommodations for disabilities by contacting the Fair Administrator.. At least one month in advance is suggested. The administrator will contact the participants as soon as possible to discuss the requests for accommodation and will notify the appropriate county fair officials of accommodations that have been approved.

Open Division General Rules and Instructions

1. Open Division Exhibits are open to any woman, man or child living in Marathon and adjoining counties. Entries accepted 10 a.m. - 7 p.m. on the first day of the fair.
2. All exhibitors are required to purchase a Season Exhibitor's Ticket. Exhibitor tickets must be purchased from the fair office prior to 4 p.m. on the Friday before the Fair. Pre-registration is required. If you pre-register before July 18, your exhibitor's ticket and entry tags will be mailed to you.
3. You may take your exhibits and entry tags directly to the department. Departments are located in the Southeast and Southwest wing of the Exhibition Building.
4. Total number of exhibits is limited to 50 per person (total across all departments). Poultry Department entry limit is 15.
5. Open Division Exhibits must be in place by 7 pm on Tuesday. All exhibits must remain in the building until 5 pm on Sunday. Exhibits must be picked up by 7 p.m. on Sunday. Any Exhibits left after Sunday, become property of the Wisconsin Valley Fair.
6. Judging in all departments except Department 22 - Woodworking, will be judged on Wednesday, beginning at 9 a.m. Woodworking will be judged on Tuesday evening once all entries have been placed. Judges are instructed not to award premiums on unworthy articles or articles borrowed or purchased. You are invited to view the judging and ask questions at appropriate times. However, hecklers will be disqualified.
7. No article exhibited in previous years will be accepted. Articles must be made since the last Wisconsin Valley Fair.
8. All exhibits must be the result of labor of the person exhibiting. Proof of this fact may be demanded if any exhibits are questioned and ruled out of competition by the superintendent and fair administrator if proof is not satisfactory.
9. No more than one entry will be permitted per Class number by one exhibitor. Entries may be made in several categories. If any article is entered under the wrong Class number and the mistake is discovered before the judging, the superintendent may make proper correction in the entry.
10. No article will be accepted for exhibit unless it fully complies with specifications and rules governing exhibition and competition in this department
11. No eating, drinking or smoking while sitting at the judging tables
12. Entries may not be handled by the public
13. The Wisconsin Valley Fair and its personnel are not liable for any damage or loss to an exhibit. All exhibits will be handled in a professional matter.

State of Wisconsin Department of Agriculture, Trade and Consumer Protection Rules and Regulations ATCP 160 Premiums and Exhibits

Subchapter I - General

Requirements and

DefinitionsATCP160.01Definitions

As used in this chapter:

- (1) "Division" means a grouping in which exhibits may be entered, including an animal breed or age group for animal exhibits; a type of produce, crop or food; or a specific age, age group or educational grade level of exhibitor.
- (2) "Department" as it relates to the organizational structure of a fair, means an animal species, production group, or other principal classification of exhibits. As used in any other context, "department" means the state of Wisconsin department of agriculture, trade and consumer protection.
- (3) "Division" means one of three exhibitor group classifications for a fair and is limited to junior division, open division and senior citizens division.
- (4) "Class" or "Class number" means the numerical designation assigned by a local fair for a specific category of exhibits within a Division.
- (5) "Premium" means a monetary prize that a county or district fair awards to an exhibitor after judging all competing exhibits in the Division to which the premium pertains.

ATCP160.02PremiumRequirements

(1) General

- (a) The state aid authorized by s. 93.23 (1), Stats., may be paid on total premiums paid by a county or district fair, net of any amounts that the county or district fair deducts from total premium payments. The department may withhold state premium aid from any fair which does not enforce the animal health provisions required under ch. ATCP 10 for all Divisions of livestock exhibited at the fair. State aid will be paid only on premiums actually paid by bank check or draft.
- (b) No deductions may be made from premium money won by an exhibitor. Premiums may, however, be withheld where exhibition rules established by the fair association are violated. A written statement of violation shall be submitted to the department to justify action taken by a local fair.
- (c) Premiums offered shall be definite in amount. No decrease or increase in published premiums may be made because of the financial condition or the organization or for any other reason. (d) State aid may be paid on no more than two premiums awarded an exhibitor under one premium or Class number in open division individual livestock Divisions, except poultry and rabbits, and no more than one premium in

(e) No county or district fair may receive state aid for a premium awarded to any exhibitor in the open division if that exhibitor entered the same exhibit in the junior division at the same county or district fair. This paragraph does not apply if the exhibit was entered in the junior division only as part of a herd group, carcass Division or performance Division.

(f) No state aid will be paid on the cost of ribbons, cups, trophy prizes or entertainment contests.

(2) Premium Lists

- (a) Premiums for which state aid is requested by county and district fairs shall conform to the uniform premium list and other requirements set forth in these rules. Fairs requesting state aid for net premiums shall submit to the department a printed copy of the premium list used at the fair, as required under s. ATCP 160.92 (3) (c).
- (b) The officers of each fair shall mail a copy of the premium list to other associations, societies, or boards conducting a fair in Wisconsin upon request.
- (c) Sections ATCP 160.01 through 160.07 and 160.91 shall be published in premium books used by a fair for which state aid is requested.

(3) Entry Fees

(a) A county or district fair may charge an exhibitor an entry fee. The entry fee may not exceed 10% of the sum of all premiums offered to exhibitors in the same Division for which the entry fee is charged. In lieu of an entry fee, a county or district fair may charge stall rents for horses, cattle, sheep, goats, swine, poultry, rabbits or pets. Stall rents shall not exceed \$1.50 per single stall or animal or \$3.00 per box stall for horses; \$1.00 per single stall or animal or \$2.00 per box stall for cattle; or \$0.50 per animal or \$2.00 per pen for swine, goats or sheep. A standard pen for swine, goats or sheep is approximately 64 square feet. Cage rents may not exceed \$0.50 per head for poultry, rabbit or pet exhibits.

(b) Exhibitors in educational and school departments shall not be required to purchase an exhibitor's ticket. Any other exhibitor may be required, if no entry fee is charged, to purchase an exhibitor's season ticket at a price not to exceed that charged for a non-exhibitor's season ticket.

(4) Split Fair Dates

(a) For purposes of this subsection, "split fair dates" occur when a fair organization judges exhibits or contests and pays premiums at more than one time or at more than one location during the calendar year.

(b) Except as provided under par

(c), the department may not pay state aid for a fair having split dates unless the department gives advance written approval for a split fair. The department may approve split fair dates only if the fair organization justifies the split dates based on extreme hardship. If the department approves split dates,

all blue ribbon winners shall repeat their demonstrations or exhibits at the regular fair dates unless the department grants a hardship exemption. An exhibitor may use audio-visual media, still photography or an educational display to repeat a demonstration or exhibit.

(c) The department may pay state aid for the following exhib its or contests in a fair having split dates, regardless of wheth- er the department approves those split dates in advance: 1. Clothing revue 2. Demonstrations 3. Favorite foods revue 4. Dogs 5. Small animals 6. Rocketry 7. Shooting sports

ATCP160.03- Exhibition requirements

A county or district fair shall meet all of the exhibition requirements of this section to be eligible for state premium aid.

(1) No fair society or other organization sponsoring a county or district fair shall require an exhibitor to become a member of the organization in order to enter an exhibit at the fair, nor shall the sponsoring organization make any deduction from an exhibitor's premium as a donation to the fair society, or require an exhibitor in any other way to make a donation to the society.

(2) State aid may not be approved for out-of-state exhibits or for separate Divisions of local and non-local exhibitors. Aid may not be approved for payment of premiums to an exhibitor having an out-of-state address but claiming Wisconsin resi- dency unless the fair secretary provides the department with an affidavit that the exhibitor's residence is geographically located within the state.

(3) State aid may be paid only on articles or animals actually on display in an exhibit building or actually shown in the show ring on regular fair dates unless approval for split fair dates is obtained under s. ATCP 160.02 (4). State aid may not be paid on Dairy Herd Improvement Association records, transportation aid, production contests or other special educational exhibits unless prior approval is obtained under s. ATCP 160.04 (8).

(4) State aid may not be paid on exhibits removed from the fairgrounds before 4 p.m. of the last day of the fair, or such other later time as may be specified by the fair, without prior approval of the department. Authority for earlier removal may be granted by the department in case of meat animal sales or other special Divisions, if requested before the beginning of the fair. In other hardship cases, approval may be granted by the local fair. Exhibits

in dog obedience and small animal pet Divisions may be judged during the regular fair but are not required to remain present during the entire fair. The local fair may prescribe the length of time junior fair exhibitors of horses shall keep their animals on the grounds.

ATCP160.04 Junior Fair

(1) In the junior fair division, the department may pay state aid on prizes offered to exhibitors who are under 20 years of age on January 1 of the current fair year. A county or district fair board may establish subgroups within a junior fair entry Division based on the exhibitor's grade in school. The department may not pay state aid on prizes for club parades, club floats, song contests, or a project which is not an exhibit or demonstration at the fair.

(2) All exhibitors in the junior fair division shall be members of 4-H, FFA, FHA-HERO, Scouting programs, breed groups, or any other recognized youth organization under adult leader- ship and with an education program approved by the local fair.

(3) Exhibits in the junior fair shall be a result of the exhibitor's own labor and may include a study, merit, or other special proj- ect, a skill area or a supervised occupational experience in which the exhibitor is regularly enrolled.

(4) State aid may be used for the payment of no more than one premium awarded an exhibitor under any one premium or Class number in the junior fair division, except when awarded as part of a group in livestock exhibits or in showmanship.

(5) Premiums in the educational department shall be paid directly to the exhibitor who made the exhibit and not to the school or teacher, except for group premiums offered to inter- school competitive Divisions. No aid may be paid on educa- tion department premiums unless a complete list of exhibi- tors and a complete set of judges' sheets for the education department, similar to those required in other departments, is filed with the department. All educational exhibits shall be displayed at the fair regardless of whether they are judged prior to or at the fair.

(6) If 16 or more animals, items or articles are entered in any junior fair Division, the Division may be divided into two or more approximately equal groups according to weight, age or other identifying characteristic and each group judged as a Division.

(7) Special educational exhibits may [be] established if the proposal is presented to the Wisconsin association of fairs before October 1 of the year preceding its proposed estab- lishment and the exhibit is approved by the department.

(8) Within any junior fair department under subch. IV, a county or district fair may establish special Divisions where none are specified under subch. IV. Special Divisions may include Divisions for grade and crossbred females in the beef, swine, sheep and horse departments. Premiums for special Divisions created under this subsection shall be equal to premiums for comparable Divisions established in the same department under sub ch. IV.

ATCP160.05 Open division

(1) The total maximum premiums set forth for all places in any open division livestock Division, excluding poultry and rabbits, may be divided into premiums for a greater number of places, but the maximum premium offered for any additional place shall not be higher than the maximum for last place in the Division.

(2) State aid for premiums awarded for horses in open division Divisions shall be limited to horses which are owned by the exhibitor.

(3) All animals in any open division shall be owned by the exhibitor, except as provided in s. ATCP 160.09.

ATCP160.06 Senior Citizens division; general requirements

(1) The age of exhibitors in the senior citizens division is limited to persons 62 years of age or over.

(2) Exhibitors in the senior citizens division may not enter identical items or articles in both the senior citizens division and the corresponding Divisions of the regular open division.

ATCP160.07 Divisions; general requirements

(1) Divisions may be combined if the number of entries in several single Divisions is insufficient. If any Divisions are combined, state aid shall be limited to the maximum total premiums listed for a single Division of animals, items or articles in that department.

(2) (a) Except as provided under par. (b), no county or district fair may receive state aid for premiums awarded for sexually intact male dairy cattle, beef cattle, sheep, goats, swine or horses unless those animals are registered purebreds. Registered purebred status shall be documented by a certificate of registry from the appropriate breed association or society, or by a copy of the application for registration.

(b) Paragraph (a) does not apply to dairy cattle exhibited at a county or district fair if a national breed association certifies that those dairy cattle are recorded in that breed association's qualified herd book which records the genealogy of that breed.

(3) Any animal entered as part of a group Division may also be exhibited in a Division for individual animals.

(4) Boars may not be entered as an exhibit in the swine department unless their tusks have been removed.

ATCP160.91 Judging regulations

(1) Judging shall be done at county and district fairs by individuals who are registered with the department and who have knowledge, training or experience in the specific Division

or Divisions to be judged as determined by the department. Judging shall be done in accordance with the requirements of

s. ATCP 160.92 (3) (a). In no case shall any person who is an officer or director of a fair be eligible to judge exhibits at such fair; nor shall any person interested directly or indirectly in exhibits shown in any department of a fair be eligible to judge articles or animals in that department.

(2) Each judge at a county or district fair shall be provided with a copy of the fair's premium book or list of entry Divisions at least seven days prior to the opening date of the fair. (3)

No animal or article, irrespective of the number of entries in the Division in which it is entered, shall be awarded a higher rating than its merit would entitle it to in comparison to the standard of perfection in the Division.

(4) (a) No state aid will be paid on premiums awarded under the Danish system in any Divisions except in the junior and educational departments.

(b) When Divisions in the junior and educational departments are judged according to the Danish system, four group placings shall be awarded in any Division. When there are less than eight exhibitors in the Division, there shall not be more than two in the first group, not more than four in the first two groups and not more than six in the first three groups. If there are eight or more entries in the Division, there shall not be more than 25 percent in the first group, not more than 50 percent in the first two groups, and not more than 75 percent in the first three groups. (c) The number of awards in the last group placing may be increased to the extent necessary to give awards to all exhibitors.

(5) If any Division of exhibits at a county or district fair is judged according to the regular system, the judges for that Division may give only one first-place, one second-place, one third-place and one fourth-place award in that Division.

Wisconsin State, County and District Fairs Animal Health Rules and Regulations

Summary

If a fair or livestock exhibition lasts more than 24 hours, the sponsors shall appoint a licensed veterinarian to conduct a daily inspection of all livestock at the fair or exhibition. The veterinarian shall review all records and test results required under ATCP 10.87. If a fair or exhibition lasts less than 24 hours, all records or test results required by ATCP 10.87 shall be reviewed by a licensed veterinarian or by the show chairperson. Records shall include exhibitors name and address, identification of animals exhibited including number, type and description, documentation to show compliance with disease testing and other health requirements, and the livestock premises code, if any, of the premises from which the animals originate.

This is a summary of DATCP animal health requirements for fairs and exhibitions only. These requirements may change due to animal disease emergence in Wisconsin or other states, for example, vesicular stomatitis in the western states. It is always advisable to check the Wisconsin Division of Animal Health website for current import requirements when planning to exhibit animals from outside the state of Wisconsin: http://datcp.wi.gov/Animals/Animal_Movement/index.aspx. You may also call 608-224-4874 for the import requirements. Animals meeting exhibition requirements may not meet all import or movement requirements for other purposes.

Animals that show evidence of having contagious or infectious diseases may not be commingled (or housed/kept) with other animals at a fair, show, or other exhibition in such a way as to allow disease to spread. Such animals should not attend the fair, show, or exhibition. Animals may be denied entry if they arrive at these events with contagious or infectious diseases, isolated and/or removed if they develop disease after arriving, or be subject to other action as would be necessary to control disease. Bovine animals with ringworm, mange, warts or scab will be removed from the fair or exhibition premises, unless the veterinarian in charge finds warts or ringworm lesions are incapable of transmitting disease.

Cattle and Bison

Cattle from within Wisconsin:

There are no test or health document requirements for Wisconsin cattle. However, fair management is responsible for maintaining records for five years of persons who have exhibited at the fair, the livestock premises code, if any, and the identification of animals shown. Entry blanks submitted and signed by exhibitors, including one of the forms of identification listed above will fulfill the exhibitor requirements.

Cattle from outside Wisconsin must:

Be accompanied by certificate of veterinary inspection (CVI) documenting official animal ID and all required tests and certifications, have at least one form of official individual ID (including steers). Meet all of Wisconsin's normal requirements for import (see https://datcp.wi.gov/Pages/Programs_Services/CattleBison.aspx). Steers are exempt from any brucellosis test requirement.

Cattle from Brucellosis Certified Free herds in Division A states may enter Wisconsin without a prior brucellosis test if the certified herd number and the last test date appear on the certificate of veterinary inspection.

Acceptable animal IDs for all cattle from outside Wisconsin:

- (1) An official metal ear tag
- (2) A breed registration number
- (3) A breed registration tattoo, or
- (4) Other identification approved by the department. For steers, either an official identification as listed for breeding

All cattle originating from Modified Accredited Advanced states, or states that Wisconsin treats as MAA because of diagnosed cases of bovine tuberculosis, shall have a negative tuberculosis test within 60 days of import. Call the

Division of Animal Health for a current listing of these states.

Cattle imported from states not recognizing Wisconsin's Tuberculosis Free status shall be required to have a negative tuberculosis test for cattle within 60 days of import. Cattle originating from Tuberculosis Accredited Free herds (except Michigan) may enter without a prior tuberculosis test if the accredited herd number appears on the certificate.

Cattle from Michigan's Modified Accredited Zone

(for cattle from Michigan's TB Free Zone, see requirements by state above) also need:

- (1) Import permit,
- (2) To originate from a herd that has a negative whole-herd TB test within 12 months before arrival in Wisconsin that includes all animals 1 year and older,
- (3) Negative individual TB tests within 60 days before entering Wisconsin,
- (4) To return directly to the state of origin after the show, and there must be a statement on the CVI that they will be doing so.

Cattle from Canada may be exhibited in Wisconsin if they meet current federal requirements to cross the international border

Swine

Commercial swine moving within Wisconsin to a fair, exhibition, and show must have the following:

Certificate of veterinary inspection (CVI) with the complete physical origin and physical destination address and the following information:

Official identification is not required unless required by individual fairs/exhibitions/shows.

Statement that a veterinarian has inspected the entire herd of origin within the past 30 days before the show and that no apparent disease was present at the time of inspection.

For terminal shows no testing is required.

For nonterminal shows testing for Porcine Reproductive and Respiratory Virus (PRRS) and Swine Enteric Coronavirus Disease (SECD) is required as follows:

If Negative tests of herd of origin within 90 days prior to movement, pigs can move to fairs or shows as noted above. Documentation of the negative test results must be made available upon request. Test results, test type, and date of testing need to be included on the CVI.

If Positive tests for either PRRS or SECD of herd of origin within 90 days prior to movement, the herd will be quarantined until a herd plan is established and approved. Swine may be able to move to the fair or show in accordance with the herd plan. Include the test results, test type, date of testing, and Herd Plan number on the CVI.

Swine from outside Wisconsin need:

A certificate of veterinary inspection that includes the following: a statement of the PEDv status of the herd of origin (if known), a statement of the PRRS status of the herd of origin (if known), a statement that the veterinarian has inspected the entire herd of origin within the past 30 days and that no apparent disease was present at the time of inspection, and official identification number

Acceptable methods of ID for swine are:

- (1) USDA silver ear tag
- (2) USDA 840 ear tag, either visual or RFID
- (3) Breed association tattoo if the pig is a purebred and the tattoo is registered
- (4) An ear tag with the premises identification number and a unique identifier
- (5) Ear notch (if the pig is a purebred and the notch is registered)

Sheep and Goats

Sheep and goats from within Wisconsin need:

If sexually intact, need official individual ID at any age; If not sexually intact, need official individual ID if they are 12 months or older; Official ID includes scrapie ear tags or tattoos, USDA 840 ear tag, approved microchips if a reader is available and if accompanied by breed registration papers in the owner's

name, or breed association tattoo if accompanied by registration papers in the owner's name; Cannot be under restriction for movement to fairs and shows

Sheep from Outside Wisconsin need:

Certificate of veterinary inspection and official individual ID: scrapie ear tags or tattoos, USDA 840 ear tag, approved microchips if a reader is available and if accompanied by breed registration papers in the owner's name, or breed association tattoo if accompanied by registration papers in the owner's name Goats

Goats from Michigan's TB Modified Accredited Zone also need:

- (1) Import permit
- (2) to originate from a herd that has a negative whole-herd TB test within 12 months before arrival in Wisconsin that includes all animals 1 year and older
- (3) Negative individual TB tests within 60 days before entering Wisconsin
- (4) To return directly to the state of origin after the show, and there must be a statement on the CVI that they will be doing so

Equine

Equine animals from within Wisconsin need:

Documentation of a negative EIA test done within the previous 12 months, which clearly identifies the animal by complete description, digital photographs, or an approved microchip (if a reader is available). Documentation may be: (1) Official test report VS 10-11, or (2) USDA-approved electronic test form, (3) Global Vet Link EIA electronic form, or (4) Certificate of veterinary inspection with the test results listed

Equine Animals from Outside Wisconsin need:

- (1) Certificate of veterinary inspection (CVI) which clearly identifies the animal by complete description, digital photographs, or an approved microchip
- (2) Negative EIA test done within previous 12 months that is reported on the CVI

Equines from Minnesota are exempt from the CVI requirement if:

- (1) Ownership does not change while the animal is in Wisconsin
- (2) The animal remains in Wisconsin no longer than 7 days
- (3) Proof of a negative EIA test in previous 12 months accompanies the animal

Exotic ruminants

Note: Exotic ruminants are ruminants that are not native to Wisconsin, and are not cervids – for example, Old World camels, yaks, water buffalo, pronghorn antelope, giraffes, and non-domestic sheep and goats

Exotic ruminants from within Wisconsin have no requirements.

Exotic ruminants from outside Wisconsin must have:

- (1) Certificate of veterinary inspection (CVI)
- (2) Official animal ID (one of the following)
 - a. Approved USDA ear tag number
 - b. Microchip number
 - c. Breed association registration number
 - d. Breed association tattoo
- (3) Import permit
- (4) Proof written on the CVI that they meet requirements for:
 - a. Bovine TB – negative test required within 60 days before entry
 - b. Brucellosis – negative test required within 30 days before entry

Please call 608-224-4872 beforehand to determine which TB test to use. Please contact your county and local municipality for any restrictions.

Open Class

Poultry and waterfowl

(Pigeons are not considered poultry for fairs and shows)

Poultry and Waterfowl from Within Wisconsin

These animals require:

- An NPIP certificate stating that they originate from a US. pullorum-typhoid clean or NPIP affiliate flock, or
- Documentation of being a Wisconsin Tested Flock or Wisconsin Associate Flock, or
- If they are sexually mature, individual wing or leg band ID and a negative test for pullorum-typhoid (and Mycoplasma gallisepticum for turkeys) within 90 days before arrival at the show

Poultry and Waterfowl from Outside Wisconsin

These animals require a certificate of veterinary inspection or equivalent that states:

- They originate from a flock classified pullorum-typhoid clean under NPIP or an equivalent state program, or
- If they are sexually mature, that they have tested negative for pullorum-typhoid (and Mycoplasma gallisepticum for turkeys) within 90 days before arrival at the show. These birds also need wing or leg band ID.

**** These photocopies will be submitted with the exhibitor's entry form, and will NOT be returned to the exhibitor.**

Requirements are subject to change as conditions warrant.

Small animals: Dogs, Domestic Cats, and other household pets

(ferrets, pet birds, rabbits, gerbils, guinea pigs, hamsters, domestic mice and rats)

Note: These rules do not apply to animals that are part of menageries. For those rules, see below. Pot-bellied and miniature pigs fall under rules for swine.

Dogs from within Wisconsin that are 5 months or older need proof of current rabies vaccination.

Cats and other household pets from within Wisconsin have no requirements.

Dogs and cats from outside Wisconsin that are 5 months or older need to be vaccinated for rabies by a licensed veterinarian, and regardless of age, need certificates

of veterinary inspection stating the age of the animal and for animals 5 months and older the date of last rabies vaccination and revaccination due date

Other household pets from outside Wisconsin need certificates of veterinary inspection (CVIs) but have no testing or vaccination requirements.

Small animals from other nations need to meet requirements of the U.S. Department of Agriculture (608-662-0600) and Centers for Disease Control (1-800-232-4636).

Exotic small animals (any species not covered by "small animals" above), exotic large animals, and other wild animals

Note: Local jurisdictions may have requirements beyond the state requirements listed here.

Animals from within Wisconsin do not have any requirements as long as they are legally possessed in Wisconsin.

Animals from outside Wisconsin generally have no testing or vaccination requirements, but do need:

- Certificate of veterinary inspection (CVI)
- Import permit number

Note: Some animals may not be brought to Wisconsin. These are North American prairie dogs and the following African species: tree squirrels, rope squirrels, dormice, Gambian giant pouched rats, brush-tailed porcupines and striped mice.

Circus, rodeo, racing and menagerie animals

Note: Local jurisdictions may have requirements beyond the state requirements listed here.

Animals from within Wisconsin must meet vaccination and testing requirements for their species. See these requirements earlier in this document.

Animals from outside Wisconsin need certificates of veterinary inspection and vaccinations and tests required for their species. See these requirements earlier in this document.

They also need import permit numbers if they are:

- Circuses and individual circus acts
- Rodeo stock other than individual participants' horses
- Multi-species menageries (defined as any animals kept in a collection primarily for purposes of exhibition or competition)

- Petting zoos

They do not need import permit numbers if they are:

- Rodeo horses owned by individual participants
- Single-species groups

Note: Some animals may not be brought to Wisconsin. These are North American prairie dogs and the following African species: tree squirrels, rope squirrels, dormice, Gambian giant pouched rats, brush-tailed porcupines and striped mice. Others may require permits from the Department of Natural Resources. See <http://dnr.wi.gov/org/land/wildlife/captive/captive.htm>.

Guidelines for housing and managing animals:

The State Veterinarian recommends that exhibitors:

- Vaccinate breeding cattle against bovine viral diarrhea (BVD) at least 30 days before the event
- Test cattle for BVD-PI by immunoperoxidase test, and bring them to shows only if they test negative
- Test cattle for Johne's disease by ELISA test, and bring them to shows only if they test negative
- Clean and disinfect vehicles used to transport animals to and from the show, and vehicles used at the show, before and after the show
- Isolate exhibited animals returning to their farms or animals purchased at the show for 21 days before mingling them with other stock

The State Veterinarian recommends that show organizers:

- House cattle separately from South American camelids and other exotic ruminants
- House cattle separately from small ruminants, especially sheep
- House ostriches, emus, rheas and cassowaries separately from domestic poultry
- House swine separately from any other mammals
- Include a space for the premises registration code on livestock entry forms
- Provide hand-washing stations near all livestock facilities
- Provide individual watering and feeding troughs rather than common ones

Unloading

Poultry will be accepted from 1 p.m. to 7 p.m. on Tuesday, the first day of the fair following instructions distributed to exhibitors prior to the fair. Poultry must be checked in by the superintendent prior to unloading. **The person bringing the exhibit to the Fairgrounds should have all pertinent health and identification papers with him/her.**

Rules Governing Exhibits

- Coop Rental - \$0.50 per bird. Exhibitors will be required to feed and water their own birds and provide cups and feed for the same.
- Definition
 - Hen (hatched prior to January 1 of exhibit year)
 - maleerel (hatched after January 1 of exhibit year)
 - Pullet (hatched after January 1 of exhibit year)
 - Young Duck and Drake (hatched after January 1 of exhibit year)
 - Young Goose and Gander (hatched after January 1 of exhibit year)
- Any bird in any designated variety cannot be entered in any other breed
- All birds exhibited must have been reared by exhibitor
- All exhibits must be left in building until 5 p.m. on the last day of the Fair (Sunday). No exhibits will be released before that time.
- All birds must be marked with a numbered leg band and the number must appear on the exhibitor's tag
- Judges are instructed to award premiums solely upon individual merit, regardless of number of entries. In other words, birds must qualify for first premium even though there may be no competition. No premiums shall be paid because of disqualification due to lack of merit.
- The American Standard of Perfection shall govern all judging
- Not more than one prize shall be awarded an exhibitor under any designated Class number and only one prize in group Divisions. No more than one bird may be entered under any one Class number.
- Total number of exhibits limited to 15 per exhibitor for Department 7
- Poultry includes all species of fowl, wild and domestic, including pigeons

- An NPIP certificate stating that they originate from a US. pullorum-typhoid clean or NPIP affiliate flock, or
- Documentation of being a Wisconsin Tested Flock or Wisconsin Associate Flock, or
- If they are sexually mature, individual wing or leg band ID and a negative test for pullorum-typhoid (and Mycoplasma gallisepticum for turkeys) within 90 days before arrival at the show

Poultry and Waterfowl from Outside Wisconsin These animals require a certificate of veterinary inspection or equivalent that states:

- They originate from a flock classified pullorum-typhoid clean under NPIP or an equivalent state program, or
- If they are sexually mature, that they have tested negative for pullorum-typhoid (and Mycoplasma gallisepticum for turkeys) within 90 days before arrival at the show. These birds also need wing or leg band ID.

Requirements are subject to change as conditions warrant.

These photocopies will be submitted with the exhibitor's entry form, and will NOT be returned to the exhibitor.

- **Birds must be free of Lice.** Birds with lice will be sent home. No poultry, of any type or Division, showing any evidence of disease may be exhibited at any Fair. If at any time any fowl in this group shows evidence of a contagious or infectious disease, it shall be removed from the exhibit and slaughtered or quarantined as directed by the Wisconsin Department of Agriculture, Trade and Consumer Protection. All poultry exhibited may be subject to quarantine and slaughter, if any infectious or contagious disease is discovered among any of the poultry in the exhibit.
- All animals in any open Division shall be owned by the exhibitor

Rules Governing Exhibits

- Rabbits will be accepted from 1 p.m. - 7 p.m. on Tuesday, the first day of the fair following instructions distributed to exhibitors prior to the fair. All health papers must be presented to appropriate authorities prior to unloading of animals. Rabbits must be checked in by the superintendent before you put your rabbits in the cages. No ribbons or premiums will be awarded if not checked in.
- Exhibitors must be present and stand beside their cage at the time of judging
- No diseased rabbit will be allowed to exhibit. Exhibitors should check rabbits for ear canker before bringing to the fair. Diseased rabbits must be removed immediately.
- Hutch rental: Single rabbit \$0.50. The fair will provide pens. Exhibitors will be required to feed and water their own animals and to provide cups and feed for the same.
- All animals in any open Division shall be owned by the exhibitor
- All rabbits will be judged under the latest revised Standard of American Rabbit and Cavy Breeders Association, Inc.
- Not more than one prize shall be awarded an exhibitor under any designated Class number. No more than one rabbit may be entered under any one Class number.
- Identification of ownership. A permanent tattoo in the left ear is the preferred method of animal identification. An identification number with a marker is acceptable. Please make sure that the number is always readable. Remark the left ear if it rubs off. Please use a unique identification number such as your exhibitor number and a prefix. Example, you show three rabbits A0071, B0071, C0071.
- Rabbit boxes or carrying cages must be removed from the barn during the Fair
- Exhibitors must feed and water their own animals and provide utensils for the same. Crocks or water bottles are required. No watering utensil that can be easily dumped over or chewed up will be allowed. If your rabbits are used to crocks at home, do not switch to water bottles for the fair. The rabbit will not know how to get water. Rabbits must have clean water and clean cages at all times. No bedding provided.

Fur bearing Animals

Rabbits and other fur bearing animals showing evidence of specific disease cannot be exhibited at any Fair. If at any time an animal in this group shows evidence of a contagious or infectious disease, it shall be immediately removed from the exhibit and slaughtered or quarantined as directed by the department. No diseased rabbits will be allowed to exhibit. Exhibitors should check their rabbits for ear canker before bringing them to the Fair. Diseased rabbits must be removed immediately.

Judging will begin on Wednesday of fair week at 9 a.m.

All entries must be grown by the exhibitor and any exhibitor must be prepared to sign an affidavit where a question of doubt arises as to proof of this fact. Refusal to comply with rules will be deemed grounds for disqualification for premium competition. In event any such entries are made, and not discovered until later, payment of premium will be withheld and same shall be forfeited to the Society.

One "Best of Show" ribbon will be awarded for each Division as judge sees fit.

Rules Governing Exhibits

Sheaf Grains, Hay and Corn

- Special care should be exercised in preparing exhibits for the following Divisions, and the instructions given herewith should be followed
- **Grains and grasses should be bundled two inches in diameter at the upper band, and legumes in bundles three inches in diameter at the lower band. Legumes must be thoroughly cured.**
- Stalks of corn should be the type from which experienced and careful growers would select ears. They should be of uniform height and size and have developed ears.
- **Ears should be from 3 to 3 ½ feet from butt of stalk, and shanks should be of uniform length.** Too long or too short shanks are objectionable. Ears should be of good seed type, uniform in size and formation, free from mixture and fully mature in every detail.
- Good hay is leafy and of good color with fine stems and must be entirely free from mold
- **Hay exhibits must be thoroughly cured and taken from the mow, no specifically prepared samples will be accepted**
- Exhibitors are urged to keep these suggestions in mind when preparing entries as the requirements outlined are important factors in determining final placings. **List the name of every variety on the front of the entry Tag** (Division A)
- Also refer to General Rules and Regulations

Potatoes

- Exhibits should be uniform size
- Be free of scab, with minimum deep eyes
- Also refer to General Rules and Regulations

Vegetables

- Exhibits should reflect uniformity in size. **Prepare vegetables according to UWEX Publication #A3306 "Exhibiting and Judging Vegetables" (Division B)**
- Exhibits should be free of blemishes
- Exhibits should be displayed in manner prescribed
- Wisconsin Valley Fair will provide plates or trays for exhibits except for exhibits required to be displayed in water, these are to be furnished by exhibitor
- **Vegetables will be thrown away at the end of the Fair**

Fruit

- All apples to be shown on plates of **at least four specimens**, except as otherwise noted
- Paper plates will be provided by the Society
- **Crab apples are to be displayed in plates of 10**

- No artificial or commercial flowers, leaves, fruit, branches, figurines, etc. to be used in arrangements or displays. Their use will disqualify the exhibit. The only exception - figurines may be used in terrariums.
- In cut flowers and stems, the container should neither add nor detract from perfection of specimen. The exhibit may contain some foliage above water only. Clear glass jars or bottles half filled with sand, water added, serve well (weight prevents tilting).
- Dried arrangements and houseplants may be exhibited only once. They may not be re-entered if exhibited in previous years.
- Arrangements can not include invasive/endangered materials (such as bull thistle)
- One "Best of Show" ribbon will be awarded for each Division as judge sees fit

1. All food preservation exhibits must follow research-based and laboratory tested recipes/directions. For UW Extension canning directions see the following web site: food safety. wisc.edu or contact the Marathon County Extension Office (715-261-1230) for current publications. The National Center for Home Food Preservation at <http://www.uga.edu/nchfp> is another source for tested recipes.
2. All foods must have been preserved since last year's fair.
3. All jars must be clean, sealed and in excellent condition.
4. Fruits, vegetable, pickles must be canned in standard pint or quart clear canning jars and two-piece vacuum lid. Note: Use only jar sizes recommended by tested directions.
5. Jam and Jelly must be in one-half pint clear standard canning jars with two-piece vacuum lid. Paraffin sealing is NOT allowed.
6. Freezer jams and jelly CANNOT be entered.
7. Rings on the jars are to be removed by the Exhibitor at the time of entry.
8. All jars must be labeled, label approximately 2"x3" that includes:
 - a. Names of Product:
 - b. Date Processed:
 - c. Type of Pack: Hot Cold
 - d. Boiling Water Bath Time:
 - e. Stream Pressures in 5 or 10lbs: Time processed

Rules Governing Exhibits

- All rules apply to this department
- All baked goods (except pie crusts) must be removed from the baking pans
- Superintendent has the privilege of removing deteriorated food
- Judge has the privilege to cut and/or taste all foods if desired
- No commercial mixes may be used
- Include recipe which is protected with a clear covering. Recipes should be printed or typed on 3"x5" card. Use the front of the recipe cards only. One or two cards may be used.

- Display: Cakes - 4" x 4" corner piece, unfrosted Bars and cookies - plate of three unfrosted

Canned Foods

- All canned food must be in standard quart and pint jars of clear glass with a two-part self-sealing lid. A two-part lid is a standard metal canning ring and a standard metal lid. Remove rings for exhibiting.
- Jellies must be sealed in standard covered jelly jars with a two-part self-sealing lid, or in a standard canning jar with a two-part self-sealing lid. Remove rings for exhibiting. Paraffin not accepted. Process in boiling water bath 10 minutes.
- Judge has privilege to open jars as desired
- A label must be attached to each jar telling method of processing. The time in the boiling water bath and pressure canner should be noted on the jars. Pressure canning or hot water baths are methods of processing. State pounds of pressure used for pressure canning. Use small labels. Freezer jam not eligible.
- Contents of relishes should be noted on the jars
- Tomatoes processed in a boiling water bath should note additive and amount used
- Exhibit must have been preserved within the last year
 - Members of the same family can exhibit under the same Class number. Each family member must prepare their own entry.

Jellies and Jams

- All jellies and jams must be in a standard jar with a two-part self-sealing lid or in a standard canning jar with a two-part self-sealing lid. Paraffin not accepted.
- Process in boiling water bath 10 minutes.
