Please provide a **Certificate of Insurance** showing **General Liability**, **Automobile Liability**, **Professional Liability** (Errors & Omissions), **Technology/Cyber Liability**, **Workers' Compensation**, and **Excess or Umbrella Liability coverages**, <u>as applicable</u> to your business operations or facility use with LCPS. Minimum limits of liability shall be \$1,000,000 per occurrence and aggregate.

The Certificate of Insurance shall designate "Loudoun County School Board, Loudoun County Public Schools and associated Parent Teacher Associations and Organizations" as the Certificate Holder and as an Additional Insured under the Commercial General Liability and Excess/Umbrella Liability insurance policies.

Additional Insured status shall be provided using the Additional Insured-Designated Person or Organization Endorsement (or similar

endorsement to the policy). Coverage shall apply as the School Board's interests may appear with or without a written contract.

Provision of currently dated insurance certificates and endorsements will allow your firm or organization to contract with all Loudoun County Public Schools that wish to utilize your equipment, products, or services. It is expected that **updated certificates of insurance and endorsements** will **automatically be provided to LCPS** upon the insured's renewal. Please send the documents to:
