Explanation:

These Bills prohibit the President from using the Armed Forces to conduct a first-use nuclear strike without a congressional declaration of war expressly authorizing such strike. "First-use nuclear strike" means a nuclear weapons attack against an enemy that is conducted without the President determining that the enemy has first launched a nuclear strike against the United States or a U.S. ally.

The decision to launch a nuclear strike is currently a two-man system with The President and the Secretary of Defense.
