

## Food is Made to be Eaten Video Series – Promotional Toolkit

Thank you for supporting the Food is Made to be Eaten video series, developed by NRDC. The videos feature Chef Tom Colicchio with the goal of encouraging food donation by chefs, restaurants, caterers, and other food businesses. Safe food donation has been protected from liability for decades through the Bill Emerson Good Samaritan Act. In January 2023, because of the work of a strong coalition of nonprofits, businesses, and lawmakers, the Bill Emerson Act was expanded and improved by the passing of the Food Donation Improvement Act. These videos focus on a few different potential donation opportunities to provide information about liability protections updated by the Food Donation Improvement Act and aim to clarify when chefs and food businesses can safely donate. We envision that municipal staff can use these videos in their engagement with food businesses; nonprofit food rescuers can use these videos in their correspondence with potential donors; and food businesses can use these videos to educate their staff.

Safe food donation has been protected from liability for decades based on the Bill Emerson Good Samaritan Act. The Food Donation Improvement Act, passed in January 2023, expanded liability protections in the Good Samaritan Act for food donors in two, new important ways:

- Liability protections now cover qualified direct donors (e.g. schools, restaurants, caterers, grocery stores, farmers) who donate good food directly to individuals or groups other than nonprofits. Previously, liability protections were only afforded to qualified donors if they donated the food to a 501c3 organization.
- Liability protections now cover nonprofit organizations and others that provide donated food products at a low price (an amount that covers the cost of handling, administering, and distributing the food). This means that food pantries and other food distribution sites have the option to charge a small amount of money for food to help cover their operational costs.

To help spread the word about the liability protections that exist for food donors and to encourage more donation, the Natural Resources Defense Council developed a series of short informational videos featuring chef Tom Colicchio.
