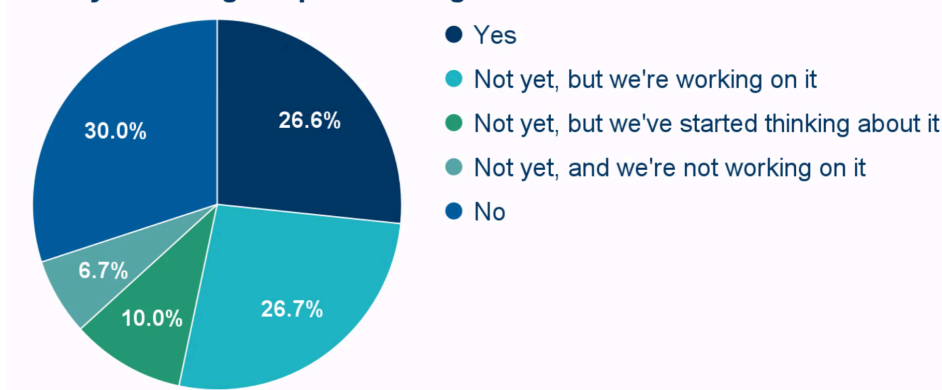

- We are looking to find out how colleges use modalities to apply fees, communicate to students, report data, etc.
- The goal is to update current terms and determine if we need to add missing modalities to the data governance glossary – translating to ctcLink. For example, is there a need for a new hyflex modality to be added to the glossary/ctcLink?
- We'd love your help.
- A [Modalities Spreadsheet](#) was created that you all can edit. At the bottom, there is a tab for each current modality.
- **ACTION:** Please go to each tab, find your college in the left column, and tell us whether you use that modality at your college, how you use it, and any impacts there are for its use – for example, this modality is used to apply a fee to support the eLearning department at our college. Please put as much detail as possible.
- Feel free to share this link with others at your college that may have additional information about this that you are aware of (schedulers, registrars, financial aid staff, etc.). For example, feel free to share this financial aid staff, as they may indicate ways that modalities impact registration and student funding opportunities (e.g., international student visas are impacted by the number of fully online courses they take).
- The purpose of this activity is so we have a complete understanding of how modalities are used and the impact it would have if we recommended changes to it.
