## Mission

Why is this particular Voter Scorecard needed, important, or helpful?

- 1. Addresses the Need for Consolidated Information: In the May 2020 local primary election, only 26% of eligible voters from ages 18-34 cast their vote. According to Youth Service America, 38% of voters aged 18-29 indicated they were not involved in politics. The number one reason those who did not cast a vote was, "too busy, conflicting work." In order to select a preferential candidate, voters must invest time sifting through the disaggregated information available online, after skimming through the limited information presented in the voter packets distributed by the government. Our Voter Scorecards break this barrier by distilling this information for voters.
- 2. Wider Scope than Other Voter Guides: Our Voter Scorecards differ from other voter information resources, in that we compile information on all local candidates, instead of only the more well known seats. This is especially needed because in smaller county elections and/or elections dominated by incumbents, information on opposing candidates is harder to find and occasionally requires contacting the representative themself to learn their platform. Also, resources only rate candidates/ compile information based on prior votes on legislation, which is not available for candidates who haven't served in office before. In our research methodology, we consider candidate statements, candidate website platforms, related work experience, and social media content shared.

#### Can't find your district's Scorecard?

Due to limited resources, we prioritized races without an incumbent (elections where neither candidate has held the office before, and/or never held public office before) to ensure voters can make informed choices when choosing between candidates who don't have a publicly available voting record.

# Definitions & Research Methodology:

We've included relevant research, as it relates to the following four core values. We evaluate each Candidate's statements (via their website, interviews, news articles, Facebook, etc), votes cast, legislation sponsored and past professional/volunteer experience.

#### Core Values:

#### Education:

Subtopics: school choice, school funding, students, teachers, education, and education topics

#### • Environment:

- Subtopics: energy, environmental restoration, environmental protection, and the use of natural resources, forests and parks, climate change, nuclear issues, clean air/water, COVID public health measures, polluter accountability
- Equity Crossover: Willingness to work with indigenous tribes to protect their resources and elevate their voices in decision making process

## • Economic Security:

- Subtopics: affordable housing, worker's rights, income equality, labor unions, minimum wage, rent ceilings, COVID economic relief
- Equity Crossover: race and gender pay gaps, houselessness programs

## • Equity:

 Subtopics: police reform, prison reform, affirmative action, LGBTQ and anti-racism protections in the workplace, womens' rights (reproductive, etc), mental health issues, Pro-life v.s. Pro-Choice, death penalty

As relevant, we also include "additional notes" that relate to topics outside our core values (such as gun control) or insight on potentially corrupt candidate behavior. Lastly, we also include here relevant information about the District's race to consider. None of these are factored into the candidate's letter grade.

# Grading Methodology:

**A - F Grading scale:** For the purposes of this grading scale, votes cast and direct action taken are weighted more heavily than public statements.

- A = 2+ statements, actions, or votes in support of the core value\*
- $\mathbf{B} = 1$  statement, action, or vote in support of the core value
- C = Conflicting statements, actions, or votes in support and opposition of core value
- $\mathbf{D} = 1$  statement in opposition
- $\mathbf{F} = 2$ + statements, actions, or votes in opposition (or 1 extreme instance)
- Unknown = No information found

## Shemia Fagan

#### Environment:

• **Voting Record in Support**: OLCV gives Fagan a 92% lifetime score relating to votes on environmental legislation (source)

## Education:

• **Protections from Abuse:** While not directly addressing education, Fagan has co-sponsored several bills aimed at preventing exploitation and abuse of students by educational institutions and staff (Source: BillTrack50)

## Economic Security:

• **Preventing Evictions**: Fagan voted for several bills intended to protect vulnerable renters and homeowners with mortgages from eviction and foreclosure stemming from pandemic-induced insolvency. (Source: BillTrack50)

## Equity:

Police/Protest Reform: In the wake of the death of George Floyd, Fagan has co-sponsored multiple bills
in the Oregon Senate that specifically aim to prevent acts of police brutality and ban the use of tear gas and
LRAD devices during protests. (source)

## Kim Thatcher

#### Environment:

- Walked Out: In 2019, Thatcher walked out of the state Senate session in order to block the passage of HB2020. HB2020 was a bill that would pressure companies and polluters to purchase credits in exchange for each emitted ton of carbon. Over time these credits would become more expensive with the intent of forcing corporations to adopt more environmentally friendly practices. (source)
- Cap-and-Trade: She strongly opposes any and all cap-and-trade bills. (source)

#### Education:

• The interest group Stand for Children Oregon ranks Thatcher amongst the lowest scored current Oregon legislators given her votes against education bills such as HB 5017 (the State School Fund) and HB 3380 (expanding access to preschools). . (source)

### **Economic Security:**

• Thatcher's contracting company has a longstanding rivalry with the Oregon Dept. of Transportation that allegedly includes filing fraudulent claims as a matter of business practice and destruction of evidence during trial (unproven due to a lack of cooperating witnesses and the state's inability to afford sufficient computer forensics to prove ODOT's case) (source).

## **Equity**:

• **Immigration**: Thatcher has a prolonged history of introducing and supporting policies explicitly targeting undocumented its (<u>source</u>)

Additional Notes: As the Secretary of State, the winner of this election may be placed in charge of redrawing state legislative district boundaries in 2020 (provided the legislature is unable to agree on a set of boundaries). The results of this election would thus have a cascading impact on the number and shape of Oregon's voting districts for the next ten years.

## **Tobias Read**

#### Environment:

Unknown

#### Education (A):

- Read is endorsed by the Oregon Education Association.
- Funding Kindergarten: According to his <u>website</u>, "while serving in the Oregon House of Representatives, he successfully fought to fund full-day kindergarten for every child in Oregon because a strong early education opens doors to more opportunities later in life."
- Affordable Higher Education: Read supports affordable higher education (<u>source-interview</u>). "Read is
  focused on supporting better regulations for student loans to protect borrowers and their co-signers, and is
  working to help students reduce their dependence on loans to afford higher education and skills training."
  (<u>website</u>).

#### Economy:

- Fair Wages: The UFCW Local 55 labor union endorses Read because he backed the <u>"responsible contractor policy"</u> that directs Oregon's Public Pension properties to hire contractors who offer fair wage and benefit standards.
- Retirement: In 2015, he sponsored OregonSaves, the first state-sponsored Oregon Retirement Savings Plan; OregonSaves enrolls workers whose employers do not offer a retirement savings option, giving hundreds of thousands more Oregonians an opportunity to retire not otherwise accessible. Additionally, he chaired the House Committee on Transportation and Economic Development.

## Equity:

• **Housing:** During his term as Treasurer, "Read led the creation of the <u>Oregon Sustainable Bond Program</u>, which will help fund affordable housing development and projects that strengthen our communities and our economy." He also worked with a diverse group of organizations including the Latina Network, Stand for Children and the Oregon Student Association, and legislators to pass the <u>Education Savings Credit</u> in June of 2019.

#### Additional Notes:

• Out of State Money: Unfortunately, as of early December 2020, more than 40% of the money the treasurer reported raising in 2019 came from big-time out of state law firms, of which Read has direct discretion of whom he hires in lawsuits filed by the state. As such, this presents a potential conflict of interest.

## **Ieff Gudman**

#### Environment:

- Waste Sewer Project: In 2012, while serving on Lake Oswego's City Council, Gundman wrote an opinion piece (Page 8) opposing the Lake Oswego Interceptor Sewer project. The project addressed capacity and structural soundness concerns with the sewer system and created a fund set aside in the event of a leak or burst once the project was complete. Gundman argues the fund was overfunded, and asked the City to credit funds back to citizens and mentions the funds also "could be used to upgrade the Portland-owned Tryon Creek wastewater plant," indicating support for other projects that prevent environmental harm.
- **Climate Action**: In 2018, at the end of his term on the Lake Oswego City Council, Gudman helped craft and pass a Climate Action Plan, with numerous positive impacts detailed in <u>this article</u>.

#### Education:

• **Public School Funding:** Gudman supports the renewal of the <u>Lake Oswego Option Levy</u> which provides \$6 million a year to fund public schools in Lake Oswego. While Lake Oswego is an affluent area with high

- property tax revenue that funds schools, it's important to note the Lake Osewgo's School District 2017 report card states the district receives \$600 federal funds less per student than Salem.
- **Higher Education**: In 2015, he proposed via a <u>Portland Tribune article</u>, a "Oregon Giving Pledge, made up of our state's most successful individuals and families. It would be a permanent mechanism to provide no-interest loans to students seeking post-secondary education either at a university, community college or professional/technical school. Individuals and families fortunate enough to have achieved success can contribute either for tax credits, tax deductions, a desire to help or all three."

#### Economic Security:

Houslessness/Mental Health: In a 2015 article, Gudman shares his opposition to any increase in business
income taxes, which behind property taxes are the primary funder of county homeless services and mental
health interventions.

#### Equity:

• Funding Police: <u>Gudman</u> believes "the City Council can potentially fund the vitally needed Police/911/LOCOM (Lake Oswego Communications) facility within existing resources." Despite deeming himself a "budget hawk," (Frugality tab of <u>Platform page</u>) he believes investing in the police department is imperative. Given the outcry from the clack community to defund the police, this stance does not seem to further racial equity.

## Ellen Rosenblum

## Environment (A):

- Carbon Emissions Laws: Rosenblum joined a lawsuit against the National Highway Traffic Safety Administration after the decision was made to remove California's federal exemption allowing the state to set a higher fuel efficiency standard than the federal law. She <u>stated</u>, "today, with basically the stroke of a pen, the federal administration just set back years of hard work on reducing carbon emissions."
- Carbon Emission Accountability: She also partnered with Governor Brown in a multi-state investigation into Volkswagen's violation of emissions standards, resulting in a \$68 million settlement committed to diesel engine clean-up. Rosenblum also "intends to support, as allowed by law, the critical work [Kate Brown] has done, guided by public health experts, to ensure the safety and health of all Oregonians" (DOJ, May 2020).

#### Education (A):

• Financial Aid: In 2013, Rosenblum partnered with 12 other state attorneys generals, in support of the Protecting Financial Aid for Students and Taxpayers Act, a bill intended to ban for-profit colleges from using federal funds for marketing and recruitment purposes to ensure those dollars directly serve and educate students. It did not pass, but her support indicates her commitment to more equitable higher education (source).

## Economic Security (A):

- **Federal Minimum Wage:** Rosenblum is a proponent of fighting income inequality and in February of 2020 circled a petition to raise the federal minimum wage via her <u>website</u>.
- **Protecting Borrowers**: In 2012, Rosenblum ordered the permanent adoption of previously temporary rules that protected home owners from predatory lending practices. Per Rosenblum the order "placed no new obligations on local banks and credit unions, but made it unlawful for a mortgage loan servicer to fail to deal with a borrower in good faith" (source).

#### Equity (C):

- Police Accountability: Rosenblum pledges "to do everything in [her] power to help move [police accountability] conversations into concrete actions that address structural injustices, running the gamut of issues, including the possible expansion of [her] office's authority to independently investigate and prosecute excessive use of force cases" (source).
- Mandatory Minimums: As a former judge who enforced, yet opposed Measure 11, Rosenblum "sometimes wondered why I was even sentencing the defendant in a case because the sentence was already kind of a done deal and it took the discretion away from judges" (source under 2012)
- Houselessness: She supports the "<u>HereTogether Homeless Services Measure</u>," or Measure 26-210, which
  secures funds for case management, mental health care, addiction and recovery treatment, job training,
  housing assistance, and culturally-specific services.

## **Michael Cross**

#### **Environment:**

• **COVID:** Cross shared via his campaign's <u>Facebook page</u> his opposition to Kate Brown's announcement that phase 2 is the last phase the state will enter until a widely available COVID treatment and vaccine are available. Given COVID is a public health crisis, Cross's opposition is concerning.

## Education:

• Funding with Business Taxes:: In an <u>interview</u> with OBP in 2019, Cross raised objections to the \$1 billion annual business tax for education passed under Brown that year.

Economic Security: N/A

Equity:

- Racial Justice: Cross shared via his campaign's <u>Facebook page</u> a picture in relation to the Black Lives Matters protests stating "due to COVID, we're gonna need people to riot from home and destroy your own [explicative]." This flippant attitude toward human rights appears problematic for racial equity.
- **Police Reform:** Also via his <u>Facebook page</u>, he expressed his opposition for Police Policy reform by condemning the special session held for these issues in June.
- Problematic Language: In his Oregon Candidate Questionnaire responses, Cross opposes Rosenblum
  "appealing [a] circuit court judge's ruling for a NEW TRIAL for people WRONGFULLY CONVICTED of
  murder." In his statement, Cross uses problematic slavery analogies, even claiming his opponent thinks she's
  above "us 'plantation workers."

## **Ted Wheeler**

<u>Environment</u>: Under Wheeler, Portland joined the Bloomberg Philanthropies American Cities Climate Challenge to tackle transportation and energy-related emissions. <u>Source</u>

#### Education:

• Removed SRO's: Under pressure from BLM, Wheeler oversaw the <u>removal of school resource officers</u> from Portland Public Schools.

## **Economic Security:**

• **Houselessness Programs**: Wheeler has made significant investments in housing and homelessness prevention, but has seen the number of homeless persons stagnate in recent years.

- Clearing Encampments: His office has <u>received criticism</u> for clearing out Houseless encampments.
- Wheeler voted to enact the Residential Infill Project, which increases the number and variety of housing types available in the city, making housing more affordable to lower income residents.

#### **Equity**:

Oversight of Police: As most Portland mayors do, Wheeler chose to take on the role of police
commissioner at the start of his first term; his leadership of the bureau has come under fire after a series of
clashes between police and BLM protestors.

## Sarah Iannarone

#### Environment:

• Green New Deal: Iannarone is running on a 'Green New Deal' platform

#### Education: N/A

• The office of mayor has little oversight into school policy (this is Portland Public Schools' purview), so neither candidate has an especially well-developed education platform

## **Economic Security:**

- **Small Businesses**: Iannarone proposed a wide range of ambitious economic reforms that prioritize small businesses
- **Disaster Preparedness**: Iannarone proposed a <u>resilience based approach</u> to city disaster preparedness
- **Zoning Reform**: Iannarone proposed a series of zoning and housing reforms such as a Tenants' Bill of Rights, re-legalizing SRO's, and utilizing Community Land Trusts to ease rent burdens, improve housing accessibility, and reduce the number of people forced into homelessness.(source).

#### Equity:

- Wealth Inequality: Her policy agenda includes multiple measures intended to close the racial wealth gap in the city.
- **BLM**: Iannarone has incorporated BLM/racial equity issues into her policy agenda in light of recent protests. <u>Source</u>

#### Additional Notes:

The 2020 mayoral race may end up becoming a referendum not on homelessness but on police brutality - the Black Lives Matter protests have produced numerous cases of police violence against protestors and journalists, and the resignation of Police Chief Jami Resch. Portland is due for a Charter Commission in 2021 that may radically transform the city's governance structure - Wheeler has openly stated he intends to be the last mayor of the commission-style city government, and Iannarone has also implied that she would make substantive changes to Portland's form of elected leadership.

## **Alex Spenser**

#### **Environment**:

- Climate Change: Spenser describes climate change and extreme weather as high on her list of priorities. She
  plans to address both of these issues by making timber and stewardship practices stronger. One example of
  Spenser's policy would be thinning and clearing felled wood to prevent forest fires from occurring.
- Cap-and-Trade: Spenser seeks to modify cap-and-trade to hold business owners to an incentive-based reduction of carbon as opposed to a penalty-based reduction of carbon. Spenser feels this change will foster competition and improve greenhouse gas fighting efforts in Oregon.

### Education:

• Equal Education for Everyone: Spenser seeks to propose her Equal Education for Everyone Amendment. This amendment looks to provide every child and or student in Oregon a free education to the extent they desire (University and beyond). Spenser aims to make public schools the envy of private school.

## **Economic Security:**

- **UBI:** Spenser believes a Universal Basic Income (UBI) will strengthen the economy and suggest one for individuals transitioning from 15\$ to 25% an hour.
- Living Wage: Spenser supports a \$15 minimum wage with an increase to \$25 by 2030.

#### Equity:

- Police Reform: Spenser is in favor of creating a database that compiles incidents of extreme force by
  members of the police. As well as redistributing police funds towards allocation and mandated use of
  body-cameras on officers.
- Activism: Led the Women's March in Klamath Falls.

- Livability: <u>Hook's economic policy</u> typically revolves around solving rural residents' lack of access to critical infrastructure, housing, and services these issues are often lumped together under the umbrella term of 'livability.'
- **Affordable Housing**: Hook's page on affordable housing directly references the way zoning and land use combine with wage stagnation to create unaffordable housing prices.

#### Equity:

BLM: <u>Hook's website</u> prominently supports the BLM movement, providing educational resources for
people looking to get involved and a strong statement in support of the movement, including its relevance to
local rural counties.

## **Jami Cate**

## **Environment:**

• Human Activity Causes Fires: Cate is a strong advocate for responsible stewardship of <u>rural wilderness</u> <u>areas</u>. Her facebook posts suggest she largely faults human activity such as cigarettes, neglected campfires, and other acts of carelessness by campers and hikers for recent increases in wildfire activity.

## **Education:**

 COVID: Cate has <u>recently addressed</u> the uncertainty regarding school reopenings during the COVID crisis, prioritizing safe options for kids to interact and choices for parents to ensure kids are educated and taken care of during remote learning.

#### **Economic Security:**

- Affordable Housing: Cate's campaign made mention of <u>affordable housing and providing resources to</u> <u>resolve the homelessness crisis</u>, but not in significant detail. As with the ADA issue, it was dropped from her website after she won the primary election.
- Trade Schools: Cate advocates for using trade schools as a means of preventing heavy student loan burdens and providing students (especially in rural areas) with marketable practical skills.

#### Equity:

- ADA Abuse: Notably, Cate's campaign website chose the ADA and alleged abuse/lax enforcement of regulations involving service dogs as a major issue during her primary campaign, but dropped the issue for the general election. It is unknown whether this policy position originated in some personal connection, but it is a rather 'niche' issue to pursue.
- In veiled terms, her website alludes to pro-life, anti-gun control, and anti-welfare positions, though these 'buzzwords' are not explicitly used.

#### Additional Notes:

- <u>Cate's platform</u> addresses the disconnect between the heavily Democratic state legislature and the concerns
  of rural Eastern Oregon farmers. During the primary, Cate's campaign website was the primary means of
  determining her political positions, but recently her use of Facebook has provided more insight into critical
  issues and her stances on them. This is likely a means of continuing to campaign in the COVID era, but the
  commingling of personal and political posts allows readers more nuanced insight into her candidacy.
- Although Cate barely won her primary over Scott Sword, the Republican party cast significantly more overall votes and likely will take this election. The GOP's historic dominance in this district led to Hook being the only Democrat to declare their candidacy in this race; the previous Republican incumbent routinely amassed 70% vote shares and ran unopposed in 2016.

## Jerry Allen

- Oregon's 1st District includes Multnomah, Washington, Yamhill, Clatsop, and Columbia Counties. It leans
  solidly Democratic and is expected to be easy for Bonamici to win as such, resources for her opponent are
  likely scarce and the campaign is not especially hard-fought. Christensen provided a photo and survey
  responses to Ballotpedia, but little else is known about him, his political stances on many issues, and his
  priorities if elected.
