**Welcome to Ladki Se Baat Karne Wala App** ("App", "we", "us", or "our"). This Privacy Policy explains how we handle your information when you use our mobile application available on the Google Play Store.

By using our App, you agree to the collection and use of information in accordance with this policy.

### 1. Overview

Our app is intended for **entertainment purposes only**, allowing users to engage in **prank/random video chats** with strangers, and includes an **Al chat feature** for general interaction and app support. The app **does not provide real dating or matchmaking services**, and **does not store or process any sensitive personal information**.

#### 2. Information We Collect

We do not require or collect any personally identifiable information (PII) from users.

However, for the app to function correctly, we may collect the following **non-personal** and **device-level information** through third-party services (e.g., Google AdMob, Firebase):

- Device model, OS version, app usage data
- IP address (used for analytics or ad targeting)
- Crash reports and diagnostics
- Basic interaction logs (e.g., AI chat commands, app navigation)

# 3. Permissions Used

To offer full functionality, our App may request the following permissions:

- Camera Access for video call functionality.
- Microphone Access for real-time audio chat.
- Internet Access for connecting to video/Al chat servers.
- Push Notification Access (optional) for new updates or important messages.

These permissions are only used while the app is actively running and are not used for background tracking or surveillance.

# 4. Al Chat and Support

The AI chat feature allows users to interact with a virtual assistant for entertainment and support purposes. The input provided to the AI chat is **not stored** or used to identify users. It is only used to generate responses in real time and improve user experience.

# 5. Third-Party Services

We may use third-party services that collect limited user data to:

- Serve ads (e.g., Google AdMob)
- Analyze app usage (e.g., Firebase Analytics)
- Improve performance and stability

These services operate under their own privacy policies. We recommend reviewing their respective policies for more details.

# 6. Children's Privacy

Our App is **not intended for users under the age of 18**. We do not knowingly collect data from children. If you are a parent or guardian and believe your child has used this app, please contact us immediately.

### 7. User Rules and Community Conduct

Users must follow the in-app rules:

- No abuse, nudity, or adult content
- Do not share or request any adult media
- Use the platform respectfully and responsibly
- This app is strictly for entertainment (prank chat) purposes only

Violations of these rules may result in removal or banning from the platform.

### 8. Data Retention and Deletion

We retain user data only for as long as necessary to fulfill the purposes outlined in this policy. All personal data collected will be permanently deleted within **90 days** from the date of account inactivity, service termination, or upon valid user request, whichever occurs first.

- The App does not show or track real-time GPS locations.
- All video calls are random and for fun—we do not verify identities or offer matchmaking.
- This app does not store any live chat or call history.
