▲僱傭關係 Employment Relationship: 實習生於期限內為廠商提供勞務, 且受到指揮或管制約束, 由廠商給付報酬, 廠商具有指揮監督權, 就屬僱傭關係, 須依勞基法之規定, 應為實習生負擔勞保、健保及勞工退休金提撥等。If an intern provides labor services to a company within a specified period, operates under its command or control, and receives compensation from the company, the company holds the right to direct and supervise the intern. In this case, an employment relationship is established, and the company must comply with the Labor Standards Act by covering labor insurance, health insurance, and labor pension contributions for the intern.

According to the Ministry of Education's official letter No. 1132303690 dated December 30, 2024 (ROC Year 113), foreign students participating in internship courses and engaging in off-campus internships must clearly distinguish between the "Internship Contract" and the "Student's Personal Work-Study Contract with the Company." When a student is involved in both an off-campus internship and a work-study program at the same company, the total weekly working hours must not exceed 40 hours. Additionally, the daily total hours for both internship and work-study activities must not exceed 8 hours, and all work must conclude by 10:00 PM.
