1.	Members of the Diocesan Convention: Minimum delegate age	Canon 1	Title I Canon 1 Section 1.1.4	Changes age of delegate. Must be 18 <i>on or before</i> the first day of convention; allows for the election of a "youth" delegate with voting. The requirement that said delegate must be 18 on or before start of convention is to comply with Texas law stipulating that one must be 18 to have the legal capacity to contract.
2.	Members of the Diocesan Convention: Convention Lay Delegate formula based on ASA	Canon 1	Title I Canon 1 Section 1.1.6	The proposed formula drops the Confirmed Communicant in Good Standing ("member") standard and adopts the ASA standard instead, to emphasize those who actively participate in the life of the community, plus the few shut-ins who regularly receive Eucharist but are physically unable to attend Sunday worship regularly. The formula also drops the sliding disincentive as church membership increases (to meet the needs of larger congregations) balanced with granting a minimum of one delegate to each Parish or Mission, for the first 25 and 50 persons, regardless of size (to meet the needs of the smallest congregations). This formula also recognizes and encourages the filling of pews and the development of active LEV ministries in all the congregations. It also encourages the formal recordation in the Register of attendance on Sunday services and Saturday night services and those who, for health reasons, must participate "off campus" but still as an integral part of the spiritual community through the LEV ministry. It also emphasizes the need to declare as mission stations those groups that have few numbers, so not to give disproportionate representation to a handful of people who do not constitute an active church and instead to encourage their

				combination with other active churches. No cap on delegates; based strictly on ASA.
3.	Members of the Diocesan Convention: Mission station representative	New	Title I Canon 1 Section 1.3	Adds a new category of convention member: nonvoting members from a mission station. Affirms the voice of the mission stations and that they are part of the ministry and governance of the Diocese.
4.	Members of the Diocesan Convention: Lay diocesan officials as convention members	New	Title I Canon 1 Section 2.1	Adds a new category of convention member: certain lay diocesan officials that are elected by convention (President of Standing Committee, President of Corporation, Chair of the Deputation to General Convention). These folks will have seat and voice, but no vote. Adding these lay officials increases the "participation" factor in our governance and tends to equalize the lay officials (who have not been elected as delegates from their Parish or Mission) with all the active clergy officials who may hold the same office but already get a vote per their clergy status.
5.	Attendance at Convention: only voting members required	Canon 2	Title I Canon 1 Section 4	Only voting members of the Convention are required to attend. Non-voting members, e.g., youth representatives, mission station representatives, alternate delegates, ex-officio church officials without vote, should attend but are not required to attend meetings of the Convention. Added language suggesting that parishes should cover the expenses of their delegates and the diocese should cover the expenses of the diocesan officials.

Meetings of Diocesan Convention: Parish and Mission reports	Canon 2	Title I Canon 2 Section 2.4	Among reports submitted to convention, adds a requirement that each parish or mission should submit a report to include a short summary of what each church has done, plans to do, etc. for the journal and for history. Added language to clarify the content and due dates for materials. Added items to be permanently stored with the Journals.

For laity, the Credentials Committee would now have to count as present (1) 1/3 of the total number of lay delegates elected by the congregations (who potentially could attend convention) and (2) whether those lay delegates are from 1/3 of the (17) active congregations represented. We are told that the Credentials Committee has already been doing this at conventions, though that is not what the canons or constitution currently require.

Allows for a plurality instead of majority vote in non-episcopal and deputy elections, if the convention gives unanimous consent after three (3) ballots without an election The Deputies and First Alternates would still need a majority but other Alternates could be elected by a plurality. Episcopal elections still require 2/3 supermajority.

This provision further eliminates the nominating ballot and simplifies the process of electing deputies and alternates.
