### 1. How To Prepare Papers

Manuscripts should be prepared on A4 size white paper with 3 cm, 2.5 cm, 2.5 cm and 2 cm margins from the top, bottom, left and right respectively.

Centred at the top of the first page of a manuscript should be the complete title of the manuscript, name(s) of author(s) affiliation(s), mailing and email address(es), then the abstract under the heading **ABSTRACT** (left justified in italic, Times New Roman, 10 points), not exceeding 15 lines, keywords under the heading **Keywords:** (not more than eight keywords, in bold and italic, Times New Roman, 10 points) and followed by the text. The text should be typed and single-spaced, using a font similar to the one used in this text (Times New Roman, 10 points). Paragraphs should be separated by double spacing.

#### 1.1. Language Used

Manuscripts must be written in English.

#### 1.2. Figures and Tables

A table, illustration and the corresponding text should be placed on the same page as far as possible. Otherwise it may be placed on the immediate following page. Its size should be smaller than the typed area.

##### 1.2.1. Label of Figures

A figure and photo should be labelled with "Fig." and a table with "Table". It must be assigned an Arabic numerals as figure or table number; the figure number and title should be placed below the figure, and the table number and title should be placed on top of the table. The first letter of the title

should be in capital letter. Illustrations and tables should be placed in the middle of the page between left and right margins.

1.3. Sections and Subsections

Sections and subsections should be numbered and titled as 1, 2, etc. and 1.1., 1.2., 2.1., 2.2.1., and etc. respectively. Capital letters should be used for the section titles. For subsections, the first letter of each word should be in capital letter, followed by small letters.

1.4. Length of Manuscript

The submitted paper must be camera-ready 10-20 pages long and formatted according to JISRP template. Each manuscript should not exceed 20 pages including illustrations and tables and do not paginate.

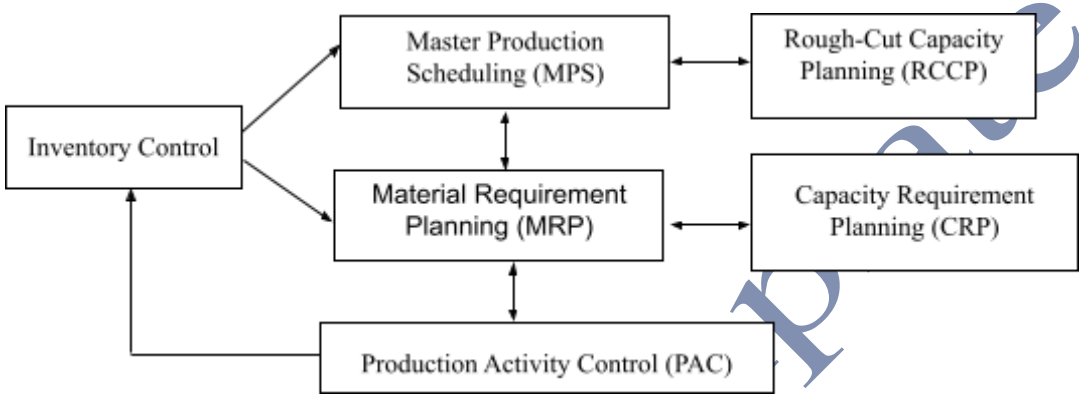


Fig. 1: Example of an illustration of figure 1

1.5. References

References should be noted with numbers [1], [2], [3], etc. at the right of the corresponding part of the text. The numbers should be the same as the references listed at the end of the manuscript under the heading **REFERENCES** (left justified). Reference to articles in periodicals should take the form: initial(s) and name(s) of author(s), title (within quotes “ ”), title of journal (in italic), volume number, issue number, year published and page numbers. Reference to conference proceedings/reports should take the form: initial(s), and name(s) of author(s), title (within quotes “ ”), name of conference in full (in italic), venue and date held, volume number (if any)/report number and page numbers. Reference to books should take the form: initial(s) and name(s) of author(s), title of book (in italic), edition (if any), place of publication, publisher and year published. Indicate chapters/page numbers where

relevant. Use Vol., No., ed. and pp. to indicate volume number, issue number, edition and page numbers respectively.

## 2. Submission Notice

The author must ensure that the manuscript submitted to this journal has never been published before and assume full responsibility for the contents of his/her manuscript.

## References

All the references that used in the manuscript must be listed in this part. In this part, all the used references must be taken from primary sources (i.e. ISI WoS journals and the least number is 80% from all the references) that published in the last FIVE years. Each article should has at least THIRTY references. References should be numbered and the numbering in order of appearance in the text. When referring to a references in document text, write the references number in square brackets, eg: [1], [2] and so on. All the served data or quotes in the article taken from the other author articles should attach the reference sources. The references should use a reference application management such as Mendeley, End Note, or Zotero. The writing format that used in the JISRP follows the format applied by IEEE standard.
