It is important to avoid excessive repetition of phrases as this can result in the page being rejected by search engines. Make sure your abstract reads well and is grammatically correct. 1. Writing Instructions (12pt)

To write articles

Please follow these guidelines to write articles:

1. First level titles (e.g., Introduction, Conclusion, etc.) must be printed in bold, in all capital letters, centered, size 14 and numbered in Roman numerals.

2. Second level titles, for example, if there are additional points in a particular chapter, you must use regular numbering numbers 1, 2, 3 etc., bold print, capital letters at the beginning of the word, italics, left alignment and size 12 pt.
3. This journal requires a minimum of 9 pages.
4. Use Century Gothic font

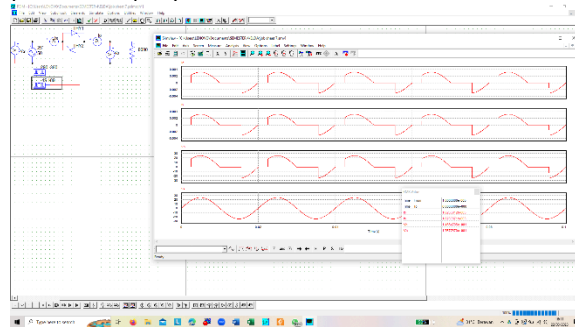


Figure 1.(This section contains the names/descriptions of the included images)
