#### Introduction

Earlier in 2023, the Council's Cabinet approved plans to reduce traffic and cut pollution in five more areas of the borough. This will help reduce our impact on climate change and support more people to walk, shop and cycle locally.

The Chatsworth Road area is one of the areas we have included in these plans.

#### **Background**

To inform the plans, the survey gathered information on how people travel around the local area. We also spoke directly to local community groups and businesses and listened to their experiences of travelling in the local area.

The information gathered in the survey will be used to:

- Make Chatsworth Road and the surrounding area easier to walk and cycle in
- Improve journey times for buses and ambulances
- Reduce traffic in the area
- Improve the Chatsworth Road area as a place to visit and shop, including on market day.

What did we know about Chatsworth Road already?

- 6,100 vehicles travel per day on Chatsworth Road
- 40% of traffic on Chatsworth Road is through traffic vehicles which drive the length of the road without stopping or accessing a local side road
- 20.4mph is the average speed on Chatsworth Road, which is above the speed limit.

#### **Consultation & Engagement Approach**

The survey was carried out from 19 June 2023 until 16 July 2023 via the Council's survey platform Citizen Space.

Paper copies of the survey were also distributed to 16,000 households and businesses with a Freepost envelope enclosed. Responses were analysed along with the responses on Citizen Space.

#### Response rate

1183 respondents took part in the survey.


#### **Executive summary**

- What is your postcode? (Base 1183)
  - The majority of respondents were from the E5 0 postcode area (746)
- Please tell us how you travel around the Chatsworth Road area in a typical week for each of the following journeys
  - The highest number of respondents meet up with friends or relatives (1913), with the highest percentage, at just over 40%, relating to those who walk (809).
- Do you support improving walking, cycling and air quality if it might lengthen motor vehicle journeys by a few minutes? (Base 1169)
  - The majority of respondents, at two thirds (722), stated that they support improving walking, cycling and air quality even if it might lengthen motor vehicle journeys by a few minutes.
- Which of the following would you like to see the Council introduce more of in your local area? (Base 4051 - select all that apply)
  - Trees, planting and rain gardens, which can be themed as environmental, were the two highest responses at 32.48% combined.
  - Other themes from comments included, transportation and traffic management, environmental improvements, pedestrian and accessibility enhancements, parking and vehicle restrictions, public facilities and amenities, and concerns about LTNs.
- Do you own, or have access to, a private car, van or motorcycle? (Base 1183)
  - Almost two thirds of respondents stated that they do own, or have access to, a vehicle (717), with just over a third who do not (466).
- Which entry/exit route do you drive through the most to get to your property? (Base 827 - Those who own, or have access to, a vehicle ONLY)
  - Just under 45% of respondents stated that they use the entry/exit from the south (past Homerton Hospital, The Castle Cinema or Chats Palace).
- How easy do you find it to incorporate physical activity into your everyday life? (Base 1154)
  - The majority of respondents, at almost two thirds, stated that they walk, cycle or use a manual wheelchair for at least 20 minutes per day (703).
- Are you a Hackney blue badge holder or Hackney companion e-badge holder? (Base 659)
  - The majority of respondents stated that they are not a blue badge holder or companion e-badge holder (602). Just under 11% stated that they are (57).
- Please let us know if you have any other comments about how you travel in the Chatsworth Road area (634 comments)
  - Key themes were traffic congestion and road closures, impact on businesses, air quality and pollution, safety and education, community engagement and consultation, and alternative solutions.

 An additional analysis was done which mentioned traffic levels on neighbouring main roads and residential streets, role of the bus service, walking environment on Chatsworth road and around, pedestrianisation for the Sunday Market, incorporating physical activity in day-to-day life and access to supermarkets and Homerton Hospital.

### **Overview of results**


#### What is your postcode? (Base 1183)



The chart above represents the postcode areas of respondents who took part in the survey.

There is a clear majority of respondents in the E5 0 area, which is specifically the Chatsworth Road area, followed by E9 6, E5 9, E9 5 and E5 8, which are all surrounding areas in close proximity.

## Please tell us how you travel around the Chatsworth Road area in a typical week for each of the following journeys (Base 1,176 respondents who gave at least 1 response)




The chart above shows statements asking how respondents travel around the Chatsworth Road area in a typical week by different modes of transport.

The highest number of respondents meet up with friends or relatives (1913), with the highest count relating to those who walk (809).

The other statements which have a majority of respondents who walk, are those who shop for essential items (897), exercise or get fresh air (897), and visit Chatsworth Road Sunday Market (858).




The chart above represents the respondents who do not use the Chatsworth Road area for any of the journey options or they do not carry out this journey.


The chart above is a cross-analysis between how the respondent travels around the Chatsworth Road area by those who use a private vehicle and enter or exit from the **north**. The figures are based solely on those respondents who meet both criteria, 1 and 2 above, with a **base figure of 637**.

The highest number of responses relates to those who meet up with friends or relatives, accounting for 123 of respondents who use a vehicle and enter or exit from the north. This is closely followed by those who shop for essential items, accounting for 115 respondents.



The chart above is a cross-analysis between how the respondent travels around the Chatsworth Road area by those who use a private vehicle and enter or exit from the **south**. The figures are based solely on those respondents who meet both criteria, 1 and 2 above, with a **base figure of 650**.

The highest number of responses relates to those who shop for essential items, accounting for 116 of respondents who use a vehicle and enter or exit from the south. This is closely followed by those who travel to and from your place of work, accounting for 107 respondents.


## Do you support improving walking, cycling and air quality if it might lengthen motor vehicle journeys by a few minutes? (Base 1169)



The majority of respondents, at two thirds (722), stated that they support improving walking, cycling and air quality even if it might lengthen motor vehicle journeys by a few minutes.

Just over a quarter of respondents (321) stated that they do not support this, with a much smaller percentage stating that they don't know (76).


"Do you support improving walking, cycling and air quality if it might lengthen motor vehicle journeys by a few minutes?"



The chart above is a cross-analysis between the support question above and whether the respondent owns or has access to a vehicle. The analysis shows very clearly that those who do not own a vehicle are much more in favour of the support to improve walking, cycling and air quality as opposed to those who own a vehicle, with a percentage difference of 32.37%.

Of those who own a vehicle, a higher percentage support than oppose by 13.7%, with just over 7% stating that they don't know.

## Which of the following would you like to see the Council introduce more of in your local area? (Tick all that apply) (Base 1161 respondents who gave at least 1 response across all options)



The chart above represents a list of things that residents would like to see more of in their local area. Respondents were asked to select all options that they would like, so a total of 4051 selections were made from 1161 respondents who gave at least 1 response across all options.

Trees, planting and rain gardens, which can be themed as environmental, were the two highest responses at 856 and 738 responses respectively.

Respondents were able to suggest other options, with a total of 186 comments added which were analysed into key themes:

#### • Transportation and Traffic Management:

- Description:
  - Focus on improving transportation options and managing traffic flow in the area.
- Number of Comments: 40
- Quotes:
  - "Access to LTNs for residents, Bike lanes, Dedicated cycle lanes, Bus gate and other means to reduce through traffic, Less parking restrictions."
  - "More bins, Car-free days, Stop through traffic on Dunlace Road, Close the street to through traffic, Clean the streets better."

#### • Environmental Improvements:

- Description:
  - Suggestions related to enhancing the environment, green spaces, and sustainable practices.
- o Number of Comments: 24
- Quotes:
  - "Public art, Trees, Planters on streets, Better short-term parking on side streets for shopping, Street trees, Green corridors."
  - "Bodies of water to help with mitigating urban heat island effect,
     Shared planting and growing corners, Orchard walls, Play zones."

#### • Pedestrian and Accessibility Enhancements:

- o Description:
  - Recommendations for improving pedestrian safety, accessibility features, and overall walking conditions.
- Number of Comments: 27
- o Quotes:
  - "Seating: benches NOT parklets, Improved fencing along Lea Bridge Road, Portable air quality monitor in libraries, Better lighting, Pedestrianise Chatsworth Road."
  - "Safer walking areas, Spaces where people rather than motorists are given priority, Pedestrianise Chatsworth Road, Improved fencing along Lea Bridge Road."

#### • Parking and Vehicle Restrictions:

  - Concerns and suggestions regarding parking, vehicle restrictions, and overall traffic management.





  - Comments expressing concerns or opposition to the implementation of Low Traffic Neighbourhoods.
- Number of Comments: 14
- Quotes:
  - "No LTNs anywhere in Hackney, Removal of LTNs, LTNs. We need to get the cars off the roads, Removal of LTNs is what I would like to see, Less LTNS causing huge local pollution."
  - "STREET CLEANING, OPEN UP ROADS SO LESS TRAFFIC AND EMISSIONS ON MAIN ROADS, Remove large service lorries for Spar, Less blocked roads and restrictions so traffic can flow properly."

#### Do you own, or have access to, a private car, van or motorcycle? (Base 1183)



The chart above shows an almost two thirds response to those who do own, or have access to, a vehicle (717), with just over a third who do not (466).


## Which entry/exit route for Chatsworth Road do you drive through the most? (Base 828)



Those who stated that they own, or have access to, a vehicle, were asked to specify which entry/exit route they drive through most to get to their property.

Just under 45% of respondents stated that they use the entry/exit from the south (past Homerton Hospital, The Castle Cinema or Chats Palace). This was followed by


those who use the north (past Millfields Park or Lea Bridge Road). Just under 15% said from the west (past Powerscroft Road, Median Road OR Clapton Park United Reformed Church), and just under 8% said they don't know.



When looking at the entry and exit routes by those who stated they have a disability, the highest number of respondents at almost 50%, responded from the north (past Millfields Park OR Lea Bridge Road).


Overall the number of those who have a disability and also own, or have access to, a vehicle, is a small proportion of the total number of respondents who took part in the survey (8.71%).

## How easy do you find it to incorporate physical activity into your everyday life? (Base 1154)



The majority of respondents, at almost two thirds, stated that they walk, cycle or use a manual wheelchair for at least 20 minutes per day (703).


A fifth of respondents stated that they do at least 20 minutes of exercise a few times a week (229), followed by those who do another form of exercise for at least 20 minutes per day (168), and those who rarely do 20 minutes of exercise (54).



The chart above is a cross-analysis of the incorporating physical activity into their everyday life by the top 5 postcode areas.


E5 0 accounted for the highest number of respondents, with just under 59% stating that they either walk, cycle or use a manual wheelchair for at least 20 minutes a day. The majority of respondents across the other postcodes all state the same.






The majority of respondents stated that they do not have a disability (952). Just under 12% stated that they do (139) and just under 8% stated that they would prefer not to say (92).

#### How would you describe your disability? (Base 170 - select all that apply)




The highest percentage of respondents, at almost two thirds, stated that they have mobility issues (99). This is closely followed by a chronic illness/long term health condition (84).

The majority of respondents stated that they are not a blue badge holder or companion e-badge holder (602). Just under 11% stated that they are (57).

Those who stated that they are a blue badge or e-badge holder, were the majority of those with a disability, although the overall number is very low for this group.

Just under 15% of respondents with a disability stated that they are not badge holders (89).

  - "Pollution won't be solved by restricting individual activities. There needs to be a comprehensive plan addressing industrial sources, not just blaming citizens."

#### **Additional qualitative analysis**

#### • Traffic levels on neighbouring main roads:

- Besides Chatsworth Road, Homerton High Street, Lea Bridge Road, Lower Clapton Road/Urswick Road and Kenworthy Road were the streets most mentioned by residents' in their comments.
  - Comments centred around existing levels of traffic on these streets as well as the cycling and pedestrian environment and air quality on these roads and concern that any change to the Chatsworth Road local area does not increase traffic on these roads.
  - There was also concern about the impact of the banned turns being implemented through a separate turn at the Chatsworth Road/Lea Bridge Road junction.

#### • Traffic levels on neighbouring residential streets:

- Glyn Road, Dunlace, Brooksby's Walk, Clifden Road and Glenarm Road were the most mentioned streets by residents' in their comments.
  - Comments centred around existing levels of traffic on these streets and concern that any change to Chatsworth Road does not increase traffic flows on these streets.

#### • Role of the bus service:

o Improvements to the experience of bus users was mentioned in several comments. Comments centred around parked cars on Chatsworth Road which can block the buses and other vehicles on the road, the reliability of bus journey times, the walking environment to bus stops and speed bumps.

#### Walking environment on Chatsworth Road and around:

 The impact of the quantity and speed of vehicles on the walking environment was the most mentioned factor in relation to the walking environment. The quality of the pavement surface, the availability of seating and cleanliness were also mentioned.

#### • Pedestrianisation for the Sunday Market:

 44 comments received either explicitly asked for Chatsworth Road to be closed to vehicles for the Sunday market or stated the positive impact when the road has been closed historically for Sunday markets.


#### Incorporating physical activity in day-to-day life:

 Comments included suggestions for outdoor gyms, low traffic walking routes, cycle-free walking routes/pavements, availability of free spaces to exercise, low traffic cycling routes, access to swimming and ice skating.

  - o Homerton Hospital


Gender: Are you... (Base 1145)



There was a fairly even split of female and male respondents who took part in the survey (589 and 492 respectively).


All others accounted for a much smaller percentage.

Age: what is your age group? (Base 1151)




The highest percentage of respondents stated that they were in the 35-44 age group (345). This was closely followed by 45-54 (251), then 25-34 (189), 55-64 (175), 65-74 (114), 75-84 (49), 85+ (15), 18-24 (9), and under 16 and 16-17 (2 each).

Do you regularly provide unpaid support caring for someone? (Base 1062)




The majority of respondents stated that they do not have caring responsibilities (863), with just under 19% stating that they do (199).

Ethnicity: Are you... (Base 1045)




The majority of respondents, at just under three quarters, stated that they were "White or White British" (744). All others accounted for a much smaller percentage.

#### Religion or belief: Are you or do you have... (Base 989)




The majority of respondents, at just under 60%, stated that they were "Atheist/no religious belief" (587). The next highest was "Christian" (236) and then "Muslim" (98). All others accounted for a much smaller percentage.

#### Sexual orientation: Are you... (Base 1000)




The majority of respondents, at just over three quarters, stated that they were "Heterosexual" (783). All others accounted for a much smaller percentage.

## Housing Tenure: Which of the following best describes the ownership of your home? (Base 1073)



The highest percentage of respondents, at just over a third, stated that their property was being bought on a mortgage (405). This was followed by just over a quarter who owned their property outright (288), renting privately (153), renting from a local authority/council (101) and renting from a housing association/trust (85). All others accounted for a smaller percentage.
