V. State of the Budget

A. Treasurer's report

- 1. \$18,000 from dues; the rest is money that we have from the building, etc. Budgeted for \$36,000 right now we have a lot of money, but we need to decide if we're increasing the dues. Every \$10, we are making \$5,000 more for the budget, and that's \$1 per month for dues. Tracy proposes we raise it for 2024-2025.
- 2. ISEA dues will go down some because of the refiguring of councils instead of units.
- 3. Membership increased stipends on the proposed budget for 2023-2024.
- 4. Membership/Community Engagement/Multicultural increased because that way we can take it from the "right" pool of money instead of grabbing from here and there for the t-shirts, bags, etc.
- 5. Legislative conference has been virtual, so don't think we'll spend, but keep it in case it comes back to in-person.
- 6. Delegate Assembly will go to odd years, so that will become every other year.
- 7. Talked about innovative teacher grants and money do it quarterly; once per quarter discussion of having people apply for each quarter it's a good way to have conversation.
