Existing settlement hierarchy

Question SH1. Do you think Small Village is still the appropriate tier of the hierarchy for Abthorpe? If not, which tier do you think is more appropriate? Do you think Hamlet is still the appropriate classification for Foscote? If not, do you think Foscote should be in one of the Settlement Hierarchy tiers?

Yes – Abthorpe should be classified as a small village

Yes – Foscote should be classified as a Hamlet

Question SH2. What is you experience of being in this tier? Have any issues arisen, for example through Planning Applications, because of being in this tier?

No specific issues have arisen as a result of our allocation to the Small Village Tier

Question SH3. Have you identified any advantages or disadvantages from being in this tier?

Our experience is that while we are a small settlement in our own right, we are geographically, economically and emotionally linked to other settlements in the Tove Valley, eg Wappenham, Lois Weedon, Weston, Bradden, creating a larger and more significant community. We are uncertain how tiers that focus planning decisions at the individual settlements level, morph into planning across coherent rural regions such as ours, particularly concerning decisions around public services and facilities.

Question SH5. Do you have a vision for your parish for the next 15 years? What changes or enhancements would you like see?

We hope to see Abthorpe flourish as a village. Abthorpe would like to see improved infrastructure for the existing population. This could be linked to any new housing developments. Abthorpe would like to see a small, limited growth in housing, within the confines of the existing village envelope. A mix of housing would be desirable, with some affordable houses for Northamptonshire families. Any new houses <u>must</u> have off-road parking.

Question SH6. What needs does your Parish have over the next 15 years?

- 1. The Parish Council has received requests is for allotments where people can grow their own produce. Such provision should be linked to any potential new housing developments.
- 2. Like many villages we have a mix of housing, most of which have limited or no off-road parking. As a result the village green at the heart of the village, and the narrow roads leading to it and the village pub, are overwhelmed with parked cars which erode the benefit of the village green as a communal open space. They also endanger the overall H&S of the community by potentially restricting access for emergency vehicles. A scheme or schemes to alleviate this problem should be found.
- 3. There will be an increasing need to provide access to vehicle charging facilities going forward, where a significant proportion of properties in Abthorpe do not have individual off-road parking. Guidance, financial and logistical support will be required.

Question SH7. Do you think your Parish has the right mix and amount of housing and employment? Are there any sites or opportunities you would like to highlight for future development or redevelopment?

We have very few employment opportunities within the village. With the exception of the pub, equine and agricultural sites, there are no opportunities, if you discount working from home. It is difficult to see where any significant employment opportunities might arise.
