Argumentative Speech Bowl – Resource Packet Fall 2021 - Final Round

As a reminder, students and coaches should confirm student intent to participate in the final round of competition through completing this <u>form</u> by **November 19, 2021**. The final round of the Argumentative Speech Bowl will be hosted LIVE, via a Zoom webinar, on **Thursday, December 2, 2021 from 4:30-6:00PM.**

Final Round Format

- The Fall 2021 Argumentative Speech Bowl will only feature speakers from the middle school division.
- In one (1) speech that is one (1) to three (3) minutes in length, students will be responsible for contextualizing the problem (inherency), clearly articulating the advantages and disadvantages of the proposed policy action.
 - The strongest speeches will preempt reasonable objections the audience might have to the policy action.
 - In the development of their speeches, students may use evidence provided by the AUDL but are strongly encouraged to do additional topic research.
 - A designated professional staff member will hold up a yellow card when there is one (1) minute of speech time remaining. When **three and a half (3:30) minutes** of speaking time has expired, the host will interrupt the speaker to conclude the end of speech time.
- There will be a **one (1) minute cross examination** where students will answer **one (1) question** posed by judges about their speech.
- The order of student speeches will be chosen randomly and will be announced prior to the start of the event.
- Judges will rank final round contestants using the Updated ASB Speech Rubric provided.

Rubric – A copy of the rubric provided to judges for speech evaluation will be shared with all competitors.

Feedback and Suggestions

Based on feedback from judges from the first round of competition, students are encouraged to be mindful of the following:

- Students should remember that argumentative or persuasive speeches are somewhat different from speeches given in a policy debate round in terms of pace and presentation. Students should not assume that their audience has any familiarity with formal policy debate.
- Students are encouraged to focus on presentation as well as content, making sure to occasionally look up at the audience as they are speaking.
- Students should assume that the audience has a minimal understanding of the problem their plan seeks to address and the policy/plan they are proposing. Students are responsible for persuading the judges and audience that their plan is a good idea.
- Students should use the introduction of their speeches to draw in the audience and to preview the outline of their speech. While students are welcome to order their speech in any manner them deem appropriate, a sample structure is:
 - Introduction
 - Opening Line Includes a hook or information that encourages the audience to keep listening.
 - Explanation of the problem or reason the plan is necessary.
 - Policy
 - Articulation of the policy It should be easy for the judges and audience to discern the proposed policy and the benefits and drawbacks to it. An example would be, "I ______ would propose that the United States federal government should..."
 - Explain benefits or advantages of the proposed policy action
 - Benefit 1
 - o Benefit 2
 - o Benefit 3
 - Conclusion Should adequately conclude the speech. Strong conclusions usually make some reference to the themes introduced at the beginning of the speech.
- Students should make sure to explicitly refer to sources when using them to support their speech. An example is, "In (article name), (name of author) suggests that..."

Topic: Net Neutrality

The United States Federal Government should continue its current policy of net neutrality as proposed by the Biden Administration.
