Who is eligible to apply?

- Agree to invest EUR 511,292 in a government bonds profile for 5 years; or, to invest EUR 170,000 if you select the funded alternative
- You have no criminal record

Investment Options in the BG IIP

In order to abide by the Inspiration of Financial Investment Act, you have to present a straight investment certificate issued by the Bulgarian Ministry of Financing. One of the most protected method to acquire such an financial investment certification is to invest in a Bulgarian federal government bonds profile. The financial investment is totally safeguarded and also assured by the Bulgarian government.

As a qualified financier in BG IIP, you can choose between two financial investment alternatives to take part:

Full Financial Investment Option - you will transfer the full amount of BGN 1,000,000 (EUR 511,292) for 5 years. At the end of the fifth year, this quantity is reimbursed to you without accrued passion.

For the full financial investment option, you should demonstrate individual or household combined internet assets of at least EUR 511,292. Most typical properties appropriate for taking part in this program are cash, property, service and financial investment certifications, including bonds and also supplies.

Financed Investment Alternative - you shall transfer a decreased quantity of EUR 170,000. This quantity is made use of to finance a 1,000,000 BGN (EUR 511,292) shut five-year term financing from a legal Bulgarian bank. The quantity of EUR 170,000 is not refunded to the capitalist at the end of the fifth year, considering that it is utilized to cover the small business loan expenses.

For the funded financial investment option, you need to demonstrate personal or family **Citizenship Application Status** along with mixed net assets worldwide of greater than EUR1 million. Most typical assets appropriate for participating in this program are cash money, property, organization and investment certificates, including bonds and supplies.

On the basis of this investment, you are considered "special" by the Bulgarian state, according to the legislation active, and you are granted Permanent Residential condition for 5 years. After 5 years, you might get Bulgarian ticket with [Immigration Review](#) and Bulgarian citizenship.

Legal Background of the BG IIP

The statutory stipulations of the Bulgarian Financier Program for Residence and Citizenship are specified by an amendment in the Foreigners in the Republic of Bulgaria Act (FRBA) legislation and published by The Bulgarian State Gazette, issue 36 (May 15, 2009).
