

EXCLUSIONS POLICY

This Document has been published by Anomaly Actors Central Command in order to notify the public of our Departmental Exclusions Policy, as well as other Exclusions that may affect your ability to join Anomaly Actors. These exclusions are upheld and enforced by Anomaly Actors Central Command, with collaboration from the Internal Security Service.

Knowing violation of this exclusion may warrant permanent Blacklist from Anomaly Actors, as well as a full foundation exile.

Section 1 | Anomaly Actors Exclusions

Exclusion Details

Anomaly Actors is classified as a *Misc Department*, this means that *both of* your departmental slots are available to use as needed. Please note that we recommend being in no more than one other department during your time in Anomaly Actors, as we require a considerable amount of time in-game, which may become overwhelming.

The Anomaly Actors Departmental Exclusions take place once you are fully inducted as a Trainee into Anomaly Actors, and affect you for the entirety of your time within Anomaly Actors, as well as an additional 1 Month period after discharging from the Department. By accepting your invitation of induction, you agree to all of the terms within this document.

Excluded Departments

The Departmental Exclusion Policy affects the following:

MTF ScD THI Scribes

All affected Departments and Sub-Divisions may not be joined for the entire duration of the Departmental Exclusion. If you are within them when Inducted into Anomaly Actors, you must discharge from them before accepting the invitation of membership.

While under the effects of this exclusion, you are also not permitted to host or assist with Training others on SCPs, their behaviours, or how to counteract them. You are also forbidden from participating in any recontainment operations in any form. Any form of application, induction or affiliation with the aforementioned Departments/Sub-Divisions while under the effects of this Exclusion are also strictly forbidden.

ISS Exclusion

If a member of the *Internal Security Service* joins the *Anomaly Actors Discord Server* for *investigative purposes*, they are *not permitted to be inducted* into Anomaly Actors for the *entirety of their posting* within the server, *as well as for a 2 Month buffer period* once the posting has ended.

Breaches of the Agreement

Knowingly breaching this agreement can go up to and beyond immediate Foundation Exile and permanent blacklist from Anomaly Actors and any of its divisions.

Personnel found to be encouraging members to breach this agreement will have a formal complaint delivered directly to their Department Overseer, urging for measures to be taken against them. This may also include an immediate and indefinite blacklist from Anomaly Actors and any of its divisions.
