 - i. **Iftars**: 7 Caterers are assigned. So far we have \$30k collected. Plan is to distribute 250 meals each day. We have sufficient volunteers and follow the same protocols as last year. Food distribution is from 6:30 to 7:30. Gates open at 5:00 and gates will close at 8:00.
 - ii. **Taraweeh**: Previous Motion: Stop Maghrib at the masjid during Ramadan and have Isha and target 8 rakat of taraweeh for a maximum of 30 minutes and limit attendance to 70 people.

 An Imam from a masjid in Dubai' is in Cincinnati due to some personal reasons. He is going to help with Taraweh inshallah. There are 3 people that will lead Taraweh. We will start from surah Nahl with
 - with Taraweh inshallah. There are 3 people that will lead Taraweh. We will start from surah Nahl with the intention of finishing the Quran on the 29th since they have been reading the Quran during normal salath. Gate will open at 9:15.
 - **Motion:** Increase max attendance to 85 people since we can have 85 with social distance when including mezzanine. The formal communication will not change and will stay at 70 people. Passed
 - iii. **Eid**: Previous Motion: We will have Eid salah at the masjid. **New Motion**: 4 Eid prayers at 7:30 AM, 8:30,9:30,10:30 with 110 people max. Each salah will be 15 minutes and people will be asked to leave after salah. The first 3 salah will be for above 13 year olds only. The 10:30 AM Eid will be for families with children under 13 and require registration.
 - First salah starts at 7:30 and ends at 7:45. There will be two overflow tents in the back of the parking lot. Motion passed.
 - iv. Zakat al fitr: \$10/person. There will be a donation box at iftar pickup, in the masjid and online.
 - v. **Ramadan Khatira:** Evening khatira starting at 8PM for 5 minutes and recitation of Quran before Maghrib on Zoom.
 - vi. **Quran competition**: There will be a meeting on Sunday May 9th:
 - c. Driveway update: Neighbors were not properly informed of the driveway via the city of Cincinnati. There were some concerns from neighbors and things have been resolved. Now the next hearing is April 21st for final approval. Initial concerns are historic horse pillars, tree removal and a gate.
