- Paul Bruening Regarding lines 4320 & 6320 and the intent of kindness of these two line items:
 - o (Line 4320 \$750 for Volunteer Appreciation) Jesus modeled the life of service to His disciples and they were not given gifts for their service; no mention in the Bible of gifts to Christians who serve. Paul requests that this line not be funded. Concerned that there are some people who really sacrifice (the widow's mite) and this seems an unimportant use of funds and cheapens our service and limits our reward. There should be no need for recognition. Consider instead of spending money for volunteer gifts that we contribute to Voice of the Martyrs, Lifeline Pregnancy Center, or others to support and give outward to support outreach for Christ.
 - o (Line 6320 \$300 Guest Services) Paul feels this has to do with marketing our "brand" and the early church welcomed people but didn't hand out any gifts to those that visited. Suggests adding a line to include other outreaches to record gifts to charities as God leads us throughout the year.
 - o Daniel Geaslen asks that motion be delayed and referred back to the Governing Board.
 - o Paul Bruening motions an amendment to defund/remove 4320 (\$750 volunteer appreciation) and reduce overall budget by that amount, Kandi Sprague second; motion carries.
 - o Paul Bruening motions an amendment to defund/remove 6320 (\$300 guest services) and reduce overall budget by that amount. After discussion, Alan Jones calls to question and Chris Matlock second; motion fails.
- Ben motions to amend the incorrect amount of the mortgage payment (line 3211) to the correct amount of \$35,008.68, second Chris; motion carries.
