

WAIVER FOR USE OF FACILITIES AT FORD FARM

- One disclaimer for each rider (unless under the age of 16, where siblings can be entered onto same form).
- Save for death or personal injury caused by negligence, neither Ford Farm, Mark and Mandy Stephens or Dartmoor Pony Club, nor its owners or employees, accept any liability for any accident, loss, damage, injury or illness to riders, horses, owners, spectators, property, vehicles and their contents and accessories or any other person or property whatsoever, whether caused by their negligence, breach of contract or in any other way whatsoever.
- All riders must wear a riding hat conforming to the current BSI standard at all times whilst mounted.
- All riders under the age of 18 years must be accompanied by a responsible adult and must be kept under control
 at all times.
- The Facility is a working farm with heavy machinery operating over it. Riders are advised to avoid such machinery and must stay within the jump/ dressage field other than entering/leaving Ford Farm.
- Riders, trainers, coaches, or any person responsible for a rider must hold public liability insurance and any person bringing a groom, rider or paid assistance onto the premises must hold employers liability insurance. Trainers and coaches MUST be qualified. This insurance should be able to be produced at any point.
- The Proprietor reserve the right to cancel any reservation without notice and reserve the right to refuse any admission. The proprietor cannot be held responsible for any consequential loss or liability howsoever caused.
- By riding at the Premises the rider accepts that they/their trainer or responsible adult has surveyed the facilities (and any obstacles such as show jumps) and the ground conditions and understand that they/their trainer are responsible for assessing the suitability of the ground conditions and/or suitability, construction and maintenance of the jumps.
- The Proprietors reserve the right to request that riders/trainers/owners or any other person using the facilities do leave in circumstances where in the opinion of the Proprietors and/or its management, a person is creating a dangerous situation, riding in a dangerous manner and/or where a person is mistreating a horse or acting irresponsibly. Where a person is asked to leave they must refrain from jumping any further jumps and immediately return to their mode of transport and remove the horse and themselves from the premises.
- Litter is to be taken home and droppings/hay must be cleared before leaving the site. Jumps to be returned to original positions.
- Users are required to close the gates of all facilities whether entering or exiting and to obey all other signage.
- All breakages must be reported immediately and paid for in full by the Hirer.
- Dogs are not permitted onto the premises.
- Ford farm has 24hr CCTV in operation. This will be viewed and acted upon if required.

| Definitions: "The Proprietors" are Dartmoor Pony Club its subsidiaries, directors, employees and contractors and Mark and Mandy Stephens. "The Premises" is the land on which Ford Farm is situated and Dartmoor Pony Club are based. "The Facility/Facilities" is the show jumping arena and dressage arena. The "Rider(s)" is/are the person(s) using the Facilities who are responsible for any trainer, spectator, groom, assistant or observer in attendance at the premises with the rider. |
