SUMMARY

WHO SHOULD TAKE THIS COURSE - the training is designed to facilitate in-house inspections to make sure that the inspections are completed properly. Additionally, completing inspections in-house equates to huge savings for the company by avoiding reliance on outside vendors to complete the inspection. Certain situations necessitate expediting inspection; i.e., the truck is needed badly to make critical deliveries and a delay in the completion of the inspection needs to be avoided, especially if the inspection is overdue. There is a cost saving depending on factors like the number of cargo tanks and the necessary equipment. In-house inspections may be far more cost-effective than outsourcing.

WHAT YOU WILL NEED FOR THIS CLASS

We recommend shopping online for the test equipment or obtaining the required equipment from your propane equipment supplier.

 THIS CLASS: Thickness Tester (Mike uses the NDT International Thickness Tester). This is not mandatory, however, it is much more accurate than just using a pit gauge. Using the pit gauge is a qualitative test relying on the experience of the tester and the tester's perceptions and opinions. i.e., a sniff test. Using a thickness tester is a quantitative test that requires precise measuring instruments.

- THIS CLASS: Pit Gauge we recommend Gal gauges
- THIS CLASS: Combustible Gas Detector
- THIS CLASS: Propane Cargo Tank to Inspect. NOTE: The cargo tank does not have to be due for inspection; participants need a cargo tank motor vehicle for the hands-on portion of the class.
- THIS CLASS:
 - DAY 1: A web-connected tablet, laptop, desktop or TV with camera and microphone. Participants may certainly use their individual devices but it is common for groups to participate with one web-enabled device, such as a smart TV with microphone and camera for classroom sessions.
 SMARTPHONES MUST NOT BE USED TO FOLLOW THROUGH THE CLASSROOM TRAINING.
 - o DAY 2: For each cargo tank to be inspected, we need one person to be responsible for streaming the video of the inspection for that CTMV via Zoom. For instance, if a company has 5 participants at a location, only one will need to stream the inspection to Zoom. A web-connected tablet, laptop, or phone with camera and microphone allowing for streaming of the virtual inspection of your CTMV

FYI - The highlighted GREEN is for Pressure Test & Internal Visual Inspection (PI) CLASSES ONLY (NOT THIS CLASS) - We have a PI class on the calendar - Ask Us.

- PI ONLY Magnetic Particle Tester note this is required <u>only</u> for the
 PI class
- PI ONLY A source of water to completely fill the cargo tank.
 - Filling with water serves two purposes;
 - 1. The pressure test is a hydro test which is why the cargo tank is filled with water.
 - 2. By filling with water we are purging the cargo tank of all flammable gas. i.e. The relief valves are removed during the filling process allowing water to push out residual flammable vapors. After the CT is full, you will plug the relief valve openings.

Note that the textbook will include info on Pl.

Following this procedure, you will pressurize the cargo tank with compressed air to perform the pressure test while checking for leaks.

After the test is completed, you will need a place to drain the cargo tank in preparation for the internal inspection and magnetic particle test.

This should cover the preliminary requirements, all of which will be covered in detail during class. The PI procedures are in the textbook that

we will provide, however, this class is not for pressure test and internal inspection - aka "P&I". This class will provide attendees a clear understanding of what to expect in our P&I class.
