K-8 Grade-level Verification Information

For English-language arts and Math, all K-8th grade Horizon Charter Schools students will have 3 learning paths to choose from: On-Demand, Blended Learning, and Supported Home Study. An additional fourth learning option--Alternative Home Study--will become available once a student has been verified/approved to be at or above grade level by completing the following process.

For a student to access all four Horizon curricula & learning paths in either ELA or math, families will discuss the grade-level verification process and criteria with their ST. Using the criteria below, STs will work with families to determine if the student is at or above grade level in the subject area. If a student meets Phase 1 criteria for the subject area, then the ST will complete the online Grade-level Verification Request form. Once SBAC scores are available, Phase 2 criteria will confirm grade level for the requested subject area. STs will check to see if the student still qualifies for Alternative Home Study once SBAC scores are available and after BOY iReady scores come in.

Verifications are valid for one school year. A new request must be submitted each year.

If a student in grades 3-8 is verified to be at or above grade level and elects to use the Alternative Home Study option, the student **must** participate in state testing AND Horizon assigned assessments annually to ensure the student maintains a proficiency level at or above grade-level in the verified subject area. If a student does not participate in testing or receive a valid test score, the student forfeits eligibility in that subject area for the subsequent school year.

Grade-level Verification Process

- 1. Family works with ST to determine if a student meets the eligibility criteria using charts below;
- 2. Family completes Grade-level Verification Request online form: (use form for NEXT YEAR'S grade level of 2025-2026 school year)

Grades K-2 Grades 3-5 Grades 6-8

- 3. ST notifies families that student meets criteria, and works with family to, select and order standards-based curriculum.
- 4. ST orders Alternative Home Study in OPS; ST add an internal note that the student qualified for AHS
- 5. When SBAC scores and BOY scores are available, ST confirms continued eligibility. If a student is no longer eligible, then the ST orders a new curriculum in OPS and uses the drop form to let the Program Secretary know of the change.

All Alternative Home Study Students MUST take all state, local and teacher-assigned assessments in order to continue to qualify for Alternative Home Study to ensure student progress and continue Grade-level Success.
