

PRIVACY POLICY

This Privacy Policy describes how Danny Wilis handles personal information we collect about users of Car Connect App: Sync Control.

Personal Information We Collect

Information You Give Us

We collect personal information you give us, such as:

Account information. We collect personal information when you create an account, such as your email address and password, as well as your phone number if you provide one to enable two-factor authentication or if you use our telephony service.

Account content. If you have a Car Connect App: Sync Control account, you can use and store different types of data in Car Connect App: Sync Control, such as photos and videos, files, messages and other content.

Transaction information. When you order paid versions of Car Connect App: Sync Control we collect information necessary to complete the transaction, including your name, payment information and billing information.

Forum content. You may post messages and other content in help forums or message boards within Car Connect App: Sync Control. This information is stored within Car Connect App: Sync Control and other users can see it.

Contact details. We collect the contact details you share with us when you communicate with us, which may include your email address, phone number, postal address or social media handles.

Feedback and correspondence. You may share information with us when you respond to surveys, request customer support or otherwise interact with us.

Contact details for parties you invite. If you decide to invite someone else to create an account on Car Connect App: Sync Control, we will collect your and the third party's names and email addresses to send an email and follow up with the third party. You or the third party may contact us at willisdanny141@gmail.com to request deletion of the other party's information. By inviting someone else to use Car Connect App: Sync Control, you confirm that you have that person's permission to do so.

Device data. You may choose to give us permission to access certain data on or components of your device, such as your photos, contacts, microphone and camera. You can always disable this access in your device's settings.

Sensitive personal information

We will never ask you to send us or submit to Car Connect App: Sync Control any information related to racial or ethnic origin; political opinions or union membership; religious or other beliefs; your health, biometric or genetic information; information about your sexual preference or sexual orientation; or information about your criminal background.

Information we collect automatically

Device and usage information. We use server logs, cookies and similar technologies to automatically collect information about your computer or device and how you interact with Car Connect App: Sync Control. For example, we may record your application version, browser type, computer or mobile operating system, Internet Protocol (IP) address (a number that is automatically assigned to your computer or mobile device when you use the Internet, which may vary from session to session) and your unique device, application or advertising identifiers. In addition to information about your device, we collect information about how you interact with Car Connect App: Sync Control, such as the page that referred you, your search terms, pages or areas of Car Connect App: Sync Control you use or share, the time and duration of visits, features you used and links you clicked on.

Cookies. See our Cookie Notice for more information about how Car Connect App: Sync Control and third party analytics providers and advertisers use cookies and similar technologies to collect your information when you use Car Connect App: Sync Control.

How We Use Your Personal Information

We will only use your personal information in ways that are compatible with the purposes listed below for which it was collected or as subsequently authorized by you.

To provide the service

We use your personal information to provide and support Car Connect App: Sync Control. As part of providing Car Connect App: Sync Control we may send you service announcements, technical notices, updates, security alerts and support-related messages through Car Connect App: Sync Control or by email. We may also communicate with you in response to your support requests, questions or feedback.

For research and development

We use the information we collect to better understand your interests and Car Connect App: Sync Control, make improvements to Car Connect App: Sync Control and to develop new features and services.

To send you marketing communications

If you use Car Connect App: Sync Control, request information from us, or participate in our surveys, promotions or events, we may send you Danny Willis-related marketing communications. You can always opt out of these communications by following the opt-out instructions in the message or by contacting us.

To create anonymous data

We may create aggregated and other anonymous data from our users' personal information. We make personal information into anonymous data by removing information that makes the data personally identifiable to you. We may use this anonymous data and share it with third parties to operate, understand and improve Car Connect App: Sync Control, develop new services and for other lawful business purposes.

For security, compliance, fraud prevention and safety

We may use your personal information as we believe appropriate to investigate or prevent violation of the law or our Terms of Use; to secure Car Connect App: Sync Control; to protect our, your or others' rights, privacy, safety or property; and to protect, investigate and deter against fraudulent, harmful, unauthorized, unethical or illegal activity.

For compliance with law; legal claims

We may use your personal information as we believe appropriate to (a) comply with applicable laws, lawful requests and legal process, such as to respond to subpoenas or requests from government authorities, (b) where permitted by law in connection with a legal investigation and (c) to prosecute or defend legal claims

With your consent

In some cases we may ask for your consent to collect, use or share your personal information with your consent, such as when we request access to your photos or other data through prompts in your mobile operating system.

How We Share Your Personal Information

Affiliates

We may share some or all of your personal information with our subsidiaries, joint ventures, or other companies under common control, in which case we will require those entities to honor this Privacy Policy.

Service providers

We may employ third party companies or individuals to provide services that support Car Connect App: Sync Control (such as customer support, hosting, payment processing, website and mobile app analytics and email delivery). We authorize these service providers to use your personal information only as necessary in connection with providing their services to us. If we learn that a service provider is using or disclosing personal information in a manner contrary to this Privacy Policy, we will take reasonable steps to stop it.

For compliance with law; legal claims; security, compliance, fraud prevention and safety

We may disclose information about you as we believe appropriate to government or law enforcement officials or private parties (a) for the security, compliance, fraud prevention and safety purposes described above; (b) as required by law, lawful requests or legal process; (c) where permitted by law in connection with any legal investigation; and (d) to prosecute or defend legal claims.

Business transfers

We may sell, transfer or otherwise share some or all of our business or assets, including your personal information, in connection with a business deal (or potential business deal) such as a merger, consolidation, acquisition, reorganization, sale of assets or in the event of bankruptcy.

Your Choices

Access, correct or delete

If you have an account, you can access and update the personal information in your profile. Registered users may also contact us to request deletion of your account and personal information. We may request information from you to help us confirm your identity and process your request. Applicable law may require or permit us to decline your request, such as where we need to retain your information for security, compliance, fraud prevention and safety, to comply with law or for legal claims. If we decline your request, we will tell you why, subject to legal restrictions. Once we process your request you will not be able to access your account or

use Car Connect App: Sync Control. When we delete any information, it will be deleted from our active database, but where permitted by law, may remain for a period of time in our backup files or other instances where deletion is not practicable.

Marketing communications

You may opt out of marketing-related communications by following the opt-out prompt in the message, or by contacting us. You may continue to receive service-related and other non-marketing communications.

Security

We use a variety of industry-standard technologies and procedures to help protect your personal information from unauthorized access, use, or disclosure. However, security risk is inherent in all information technology. Thus, while we use reasonable efforts to protect your personal information, we cannot guarantee its absolute security. If you believe the security of Car Connect App: Sync Control or your personal information has been compromised, contact us immediately.

Third Party Sites and Services

Car Connect App: Sync Control may link to or integrate with other websites and services operated by third parties, including social media platforms, advertising services and other websites and applications. These links and integrations are not endorsements of, or representations that we are affiliated with, any third party. We do not control third party websites, applications or services and we are not responsible for their actions. Third party websites and services follow different rules regarding their collection, use and sharing of your personal information and we encourage you to read their privacy policies to learn more.

Children

Car Connect App: Sync Control is not directed to anyone under the age of 16. A parent or guardian who becomes aware that a child has used Car Connect App: Sync Control may contact us and we will attempt to delete the child's personal information as soon as possible.

Changes to this Privacy Policy

We may modify this Privacy Policy at any time. If we make material changes to this Privacy Policy we will notify you by email (if we have your email address) or another reasonable manner through Car Connect App: Sync Control. Any modifications to this Privacy Policy will be effective when posted (or as otherwise indicated at the time of posting).

If you object to an update of this Privacy Policy, you must notify us and ask to deactivate your account and delete your personal information prior to the effective date of the update. Continued

use of Car Connect App: Sync Control after an update to this Privacy Policy will indicate your acceptance of the update.
