COMMISSIONS

Ordering:

- Please write in a clear/nice manner
- Provide neat/clear references >> Please do not give me a wall of text. I will not accept your commission without a clear reference
- Disrespectful and ill behavior will not be tolerated, and your commission will be canceled if it occurs.
- All prices will be listed on the commission sheet. However, as stated on the sheet, prices may vary due to complexity of the character's design and/or the task.
- *Please be absolutely sure that you have the financial ability and desire for a commission before ordering!*

Payment:

- *I only accept USD through paypal*
- Commissions must be paid in full unless stated otherwise (different types of commissions may have different payment rules and will be stated in the description)
- Please do not send payment before we have both confirmed everything.
- I will cancel your commission if payment is not received within 48 hours.

Process:

- It is not guaranteed that I will provide continuous work in progress screenshots (WIPs) of the commission on my own accord. If a WIP is wanted, it must be personally asked by the commissioner
 - If the commission payment is split and the commissioner has not completed the full payment, WIPs will be watermarked and will not be full sized.
 - WIPs might also be given if I, the artist, am uncertain with something about the commission and need clarification
- Time to complete the commission may vary based on the type of commission and complexity
 - I, the artist, will inform you if there are any delays.

Refunds:

- There will be no refunds issued for any reason other than me, the artist, being unable to complete the commissioned work, at which point I will contact the client to issue the refund. The client may not ask the artist for a refund.
- On SOME occasions, a partial refund may be discussed if given good reason. Refund price may vary depending on the percentage of work that has already been completed.

Mistakes and Errors:

- I will correct any mistakes if they were included in your order.
- When a commission is finished I will allow small changes to be made. (ex. Adding an extra earring, different colored nails, etc)
 - If bigger changes are desired, there will be extra charge.

Rights and Permissions:

- **The artist (VukoBird/Deadove):**
 - Retain all rights to the work done.
 - Reserves the right to refuse any commission for any reason.
 - Reserves the right to cancel any commission for any reason. If this is the case, a full refund will be issued immediately.
- **The client:**
 - Agrees that the work paid for is a DIGITAL GOOD, and will be delivered by means of electronic transfer (via DeviantArt Notes, Discord, email, etc), and acknowledges that there will be no physical copy mailed to them.
 - Is free to use the finished work for private, **non-commercial** uses. The work will **not** be marketed, promoted, or sold and used for profit in any way.
 - May not upload the artwork to social media sites other than in a private gallery for their personal use.
 - May not claim credit for the artwork itself, and must credit the artist. Please link back to the artist's DeviantArt/Twitter/Instagram/Toyhouse page.
 - May not remove or tamper with the artist's watermark in any way.
 - May not edit the artwork other than to crop or resize the image.

Subject Matter:

- Artwork will be drawn in my style.
 - You may not request a drawing in someone else's style. (Sad that I have to type this part out but I have seen people who ask that and it's really disrespectful)
- Again, this is a DIGITAL GOOD, therefore you will not be given a physical copy. It will be through an electronic transfer.

- **What I WILL draw:**

- Animals (almost any sort of animal really), anthros, monsters/creatures/fantasy species, humans, humanoids
- Original Characters that belong to you (obviously)
- Original Characters that are not yours
 - Please get permission from the owner for me to do so
 - If this is a gift/surprise then I can also do that
- Gore
 - Ask me about it! This will require the client to provide me more information on the topic (extreme/specific gore and subjects may be rejected)

- **What I WILL NOT draw:**

- NSFW
- Full on mechas (maybe)
 - I will have to see a ref. Please keep in mind that if I find it too complex, I will reject it.
- Overly complex characters
 - I am usually ok with character designs but there may still be one I come across that I may reject.
- Any under aged character(s) in sexual situations, pedophilic content, "adult" characters that look like children in sexual situations.
- Fetish art of any kind.
- Politics related subjects.
- Hateful/Harmful material towards groups or individuals.
- Overall, anything that just makes me uncomfortable. I will inform you if this is the case!

DESIGNS AND ADOPTS

General Rules:

- Read the description/information/rules for any specific design or adopt
 - Rules may change depending on the type: auction, flat price, trade, raffle, giveaways, etc.
- Please tell me if you are selling/trading/giving away the design. I appreciate knowing where they are.
- Pay within the 24 hour limit.
 - Failure to do this will result in the adopt/design being put back up for sale.
 - If the design is from an auction, it will go to the next highest bidder.
- Please credit me:

- Adopts/Designs that you have **bought** with currency may be sold.
 - The owner of the design may **not** sell the design for more than it was bought for UNLESS additional art was added after purchase.
- Adopts/Designs that you have **won** or **received** through giveaways, raffles, etc may **not** be sold for currency. They can only be gifted/traded.
- You may change/edit the design once you have received it. It's yours!
- Do not harass others
- If it is an auction: Please do not hide or edit your bid/offer.
 - If you must edit your bid/offer in any way because you are canceling it, please reply to your comment with the edit of why you have backed out. Do not edit the original comment!
 - If I see your offer has been edited I will not count it.
 - ex: [Here](#) (this also applies if the auction is done on Twitter, etc)
- I, the artist, have the right to refuse an offer/bid or claim of an adopt.

REGARDING NFTS/CRYPTOCURRENCY/AI

- I, the artist, will **NOT** work with people involved with NFTs/Crypto/AI.
- I, the artist, will **NOT** make NFTs/Crypto/AI.
- If the client is found using my art for NFTs/Crypto/AI they will be blacklisted immediately and legal actions will be implemented.

THE BLACKLIST

- The blacklist is completely private and will not be free to the public. I will not give names or information if it is not completely necessary.
- If you are on the blacklist and are trying to purchase an adopt or commission me, I will refuse.
