GROUNDS – Maria Barrows

- o Maria contacted Leeds and pre ordered 35 tons of sand for the beach. It will be delivered late March/early April. Since we paid early, they are not charging a delivery fee. Maria will contact Wael Dada as the time gets closer for his help in spreading the sand.
- o The Gardening Club has removed and stored the Christmas lights they set up around the Cove
- Maria will throw out the car at the triangle which is in disrepair. She will contact
 Hammett's in Forked River to purchase 3 evergreens in pots to replace the car. There
 will be a solar spotlight on the plants.
- o The gate to the left of the clubhouse is not latching because the pole is leaning. The pole needs to be dug out and set straight in order to fix.
- o Maria has secured 3 estimates to replace the clubhouse fence. Patches have been made by many over the last couple of years but it is now beyond repair.
 - A motion was made by Carol and seconded by Maria to replace the entire chain link fence.
 - The BOD unanimously approved the motion to purchase a new black chain link fence for the entire beach property with 2 double and 1 single gate as it is currently.
 - A permit is needed and Maria will contact the Township to determine their requirements.
 - Maria will send the final information to the BOD once she reviews the estimates and has the companies come out in person to measure the fence and get final quotes.
