

Following Are Requisites To A Thorough "Cleanup" And Restoration For The West Coast USA.

1) Full Disclosure On The EPA Or Central Regulating Agency's Plan of Decontamination / Outline Of Remediation / Restoration / And Full Documentation According To Regulations; Ref. Clean Air Act And Community Right To Know / Title 40 - Chapter 1 - Subchapter J - Part 300 Of The Code Of Federal Regulations - Section § 300.3 And The Nuclear Radiological Incident Annex (NRIA).

2) The Assembly Of Reputable Watchdog Agencies To Ensure Adherence And Cohesion To Procedures In The Thorough And Comprehensive Results In Regards To Decontamination/Restoration Process And The Performances Of Protective Systems In Its Entirety Through the Process In Conjunction.

3) The Documentation Of Research Data In Regards To Project Completion / Including Condition Of All Environmental Modules Up To Including But not limited to Humans.

4) The Continued Investigation And Prosecution Of The Protective Agencies' Failure To Perform / Isolation Of Causation Of Failure / Correction Of The Systematic Breakdown / Additionally Modification Of Existing Systems To Ensure No Repeat Events / Similar Investigation Into Checks And Balances With Reliable Corrective Measures Activated / Documented In Results To All Pertaining Entities.

Note: As Per Social / Political And Others Evolution - The Periodic Upgrade Of Agencies / Departments / Laws And Systems Has Been Necessary - This Instance Is No Exception / The Serious Nature And Consequences Of The Systematic Failure Has Led To An Imperative And Immediate Upgrade.

5) The Immediate Injunction / Permanent Cessation / Abatement Of The Source Problem In Addition To Assistive Or Aggravating Sources, In The Actuality That Any And All Decontamination / Remediation / Restorative Efforts Will Be Completely Null And Void With The Continued Insertion Of Threatening / Hazardous Radioactive Fuel Arriving Daily. According To All Documented Evidence / Accounts Of The Source's Complete Willingness To Compound The Problem And Results (Ref. Tokyo Electric Power Company's (TEPCO) Daiichi NPP In Fukushima, Japan, Restarting Two Additional Damaged Reactors In Series Causing The Increase Of 40,000% And An Additional 400 Tons P/D) And The Current Publicized Intent Of The Same Corporate Source To Relight The Fourth And Possibly Final Contributor To Dangerous Threatening Hazardous Material Currently Being Imported To United States ("Probably The Final Straw" In Meltdown And Devastational Contributions) And Existing Aggravating Contributions, I.E.: Facility Leaks / Hazmat / Flushing (The Intake And Release Of Contaminated Seawater Through Existing Nuke Facilities) Increasing The Accrued Levels Of The Source Accumulation - Three Facts Become Clear:

d) In Category Of Additional R.Con. Contributions An Immediate Embargo And Upgraded Import Regulations / Inspections Will Be Necessary To Halt The Continued Accrued Effect To The Existing "Piles" / The Humanity And The Modules Surrounding.

6) a) An In-depth Study Into The Scope of Mutation / Well Documented Data And Accounts Exist As To The Mutative Effects Of This Particular Threat / The Contributions Of Alternate Contamination To The Current Stereo Effect Are Mandatory For A Thorough Remediation. Note: The Complete Cost Of All Efforts Including Possible Destruction And Restocking / Remuneration For Victims Appears Obviously To Qualify Under The Federal Regulations / Remuneration And Liability / Reviewing One Concept Of Remediation Efforts (Included) Should Include The Use Of All Currently Funded 501(c)3 / Emergency Response And Other Entities.
