  - i. **Enrollment** –Deanna Downs presented an enrollment update. GVCS is currently at 684 students. Enrollment for the 2025-26 school year ended on February 28<sup>th</sup>. GVCS is collecting retention information for the 2026-27 school year. Orientations for the 2026-27 school year have started and GVCS already has a healthy waiting list.

Additionally, there was a slight increase in salaries and benefits and a slight decrease in books and supplies. Overall, cash flow continues to be very healthy. All in favor, the 2025-26 GVCS Second Interim Budget is approved as presented.
- c. **Approval of Revised GVCS Conflict of Interest Code** – Deanna Downs stated that as part of our regular governance review process, administration conducted an assessment of the current Conflict of Interest Code to ensure it remains accurate, up to date, and aligned with our organizational structure and operational practices. The revisions are administration in nature and do not represent a change in the Board’s ethical standards or expectations. They ensure that the Code accurately reflects current roles and responsibilities within the organization. Adrian Heredia made a motion to approve the revised GVCS Conflict of Interest Code. Raul Ramirez seconded the motion. Roll Call Vote: Heredia-aye; Palacios-aye, Ramirez-aye; Bean-aye.  
All in favor, the revised GVCS Conflict of Interest Code is approved as presented.
- d. **Approval of Proposed 2026-27 GVCS School Calendar** – Deanna Downs stated the Board approves the start and end dates of the school calendar. This school calendar aligns with prior school year calendars. Adrian Heredia made a motion to approve the 2026-27 GVCS School Calendar. April Palacios seconded the motion.
