On the above date I was sent to in reference to a man with a gun. Later information received was that the person with the gun was identified as Ray Pierrot, and that he had pointed the gun at his sister. Upon my arrival I waited for cover officers to respond. Sgt. Steve Willow, Officer Joedy Cypress and Officer Ben Clove responded as cover officers. Sgt. Willow contacted the complainant while the other officers secured the area. I took a position at the Southeast corner of the residence at Sometime later I was told by Sgt. Willow that due to the tactical situation he was going to recommend that the S.W.A. Team be called out. Before the SWAT team arrived Officer Cypress Sgt. Willow and I approached the residence at and flattend the tires on the car beRayging to the suspect to better secure the scene. After the SWAT team arrived and accessed the situation I was relieved by Officer Oak' and instructed to maintain a perimeter position at the intersection of 11th and STREETave. to prevent anyone from coming into the scene. I maintained that position while Cpl Dan Aspen and Sgt. Steve Willow were attempting to talk with Pierrot on the telephone. I could hear some radio traffic concerning Pierrot threatening to shoot at the Officers if they did not leave. I also heard that Pierrot was not willing to talk with police by phone and kept hanging up. I also heard radio traffic that a shot had been heard coming from inside the residence.
Approximately 1400 hrs. I could hear radio traffic stating that Pierrot had come out of the residence and had a gun, and that Pierrot was in an Eastbound direction of travel. I assumed a position of cover. I heard shots fired and someone calling for medics because Pierrot was down.
The medic had staged in the area of 11th and Burrell. I removed the cones from the street and signaled them to got to the scene.
I continued to secure the area until investigations had completed work at the scene and left at approximately 1930 hrs.
I was later advised that Pierrot died due to injuries sustained.

I was given a brief walk through of the scene and then went about marking the location of the officers involved, the shell casings, the subjects weapon, his location when initially shot, his location when he went down, and the trajectory of the shots fired.

After I completed all this, I met with Lt. Pine, explained the scene as best I knew it, and cleared the scene and returned to the station to supervise the patrol functions ongoing.

On 04/18/96 at about 0900 hours I was contacted at my home by dispatch who told me that a S.W.A.T. call out had been made and it was requested that I respond to the station.

Once at the station I contacted Sgt. Cedar who told me that the

"Crisis Negotiations Team's" equipment had been loaded in the "Special Response Vehicle". I spoke with Cpl. Woode who briefed me on the situation to present. I was told that L. Pierrot had threatened his sister, pointing a firearm at her and demanding that she exit the residence. I was told that Sgt. Willow was on scene.

I was contacted by dispatch and told that Sgt. Willow wanted me to respond to the location where M. Pierrot was at. I took the "CNT" briefcase and responded to that address. Before I arrived I was rerouted to the "Command Center", 11th and STREETavenue. I arrived at 11th and STREETat about 1010 hours. I went to the residence, and contacted Sgt. Willow

I was introduced to the family members at that location, to include: the sister of L. Pierrot , Ursula (mother of L. Pierrot), the Grandmother of L. Pierrot and Scott Hawk (friend of the Pierrot family). Sgt. Willow then told me that it had been reported that L. Pierrot 's sister had gone to the residence of L. Pierrot , and L. Pierrot had threatened her with a pistol and demanded she leave. I was told that L. Pierrot said that he had taken "50" sDouglasping pills and another prescription medication, that L. Pierrot had been drinking and was drunk or lethargic. I was told that L. Pierrot had threatened to kill anyone that responded to the door. I was told that what had set this situation in motion was that L. Pierrot had been contacted by M. Pierrot and told about her weekend in Worley State with P. Willow. I was told that L. Pierrot had been told by M. Pierrot that she was having a birthday party on 04/19/96 for their (L. & M. Pierrot s) son and he (L. Pierrot) was not invited, as P. Willow was going to be there.

Myself and S. Willow set up a negotiations center in the kitchen area of hours S. Willow made telephone contact with L. Pierrot after having gone through the telephone operator, as L. Pierrot had had a telephone block on his line, blocking all incoming calls. Sgt. Willow told L. Pierrot that we were concerned about him and

were there to help him. After about seven minutes L. Pierrot hung up. S. Willow told me that L. Pierrot sounded "real" groggy, not due to intoxication, rather due to "pills".

I recorded information as it was passed on to me by S. Willow and others. I attempted to record the conversation of S. Willow using my pocket recorder. I was unable to record L. Pierrot 's portion of the conversation due to not having the proper recording device. The attached pages of yellow legal pad are the notes that I took during the incident. At about 1100 hours S. Willow attempted to recontact L. Pierrot by telephone with negative results, after having let the telephone ring 35 times.

- 1106: L. Pierrot answers S. Willow's call, responding "I don't want to talk to anyone I don't know" and hanging up.
- 1107: L. Pierrot again answers S. Willow's call giving the same response and hanging up.
- 1108: The telephone operator tells S. Willow that L. Pierrot is attempting to call out, he's getting a machine.
- 1112: S. Willow calls L. Pierrot after about one minute L. Pierrot answers and hangs up.
- 1114: S. Willow calls L. Pierrot and it is decided to allow S. Hawk to talk to L. Pierrot in attempt to convince L. Pierrot to speak with officers. L. Pierrot answers and S. Hawk states: "Ray this is Scotty". L. Pierrot hangs up.
- 1126: M. Pierrot calls S. Willow and states she was called by L. Pierrot . M. Pierrot says that L. Pierrot said, "The first one he sees is dead" and "get them out of here".
- 1132: S. Currian who is present with M. Pierrot radios and says that L. Pierrot called M. Pierrot and advised that we had "five minutes to get the cars out of here".
- 1135: M. Pierrot is on the telephone to L. Pierrot who is telling her which cars to move.
- 1138: S. Willow is attempting to call L. Pierrot . M. Pierrot says that L. Pierrot has called her again and she is attempting to get him to call S. Willow. M. Pierrot says that L. Pierrot refuses to call S. Willow and hangs up.
- 1140: S. Willow again attempting to call L. Pierrot . Operator states that L. Pierrot is on the line with another party (M. Pierrot ) and attempts to break in.
- 1141: L. Pierrot 's telephone is ringing.
- 1142 L. Pierrot answers and hangs up.
- 1142: S. Willow is again calling L. Pierrot .
- 1143 L. Pierrot answers and hangs up.
- 1143: S. Willow is calling L. Pierrot . It has been decided to allow Ursula Pierrot , L. Pierrot 's mother to speak with L. Pierrot in attempt to keep him on the line Rayg enough to convince him to speak with police.
- M. Pierrot calls 3512 11th street on L. Pierrot 's sisters cell phone. M. Pierrot say that L. Pierrot called and said that he was going to start shooting holes through the walls.
- L. Pierrot answers and Ursula Pierrot says that he told her to "shut up" and hung up.
- 1145: A neighbor calls and speaks with Ursula Pierrot, Ursula Pierrot hangs up.

At this time myself, S. Willow and T. Douglas discuss the movement of the vehicle requested by L. Pierrot . I state that L. Pierrot is not negotiating with us and we should not move any vehicles until he negotiates with us, further I have concerns for the safety of anyone trying to move the vehicles.

1155: S. Hawk is allowed to remove his vehicle per L. Pierrot s request.

At some point near this time I advise S. Willow that I am going to remove the family from this residence as the situation is too hostile and we are to close to the suspect to protect the family should the situation get worse. I escort all family members across the street to the residence of M. Wright, an L.P.D. employee.

- 1200: M. Pierrot states that L. Pierrot has stated, "The officer behind the shed and Aspen's house needs to move or he's dead".
- 1203: M. Pierrot states that L. Pierrot called and said, "I have a full face shot of the officer behind the shed".

Near this time myself, S. Willow, Lt. Douglas and Sgt. Cedar had a discussion about retreating and letting the situation defuse. It was decided that that was not an option as we were not able to solicit any commitment from L. Pierrot , and because it was believed that the family members would most likely attempt to contact L. Pierrot resulting in either an armed confrontation, or worse. Further it was not known, due to L. Pierrot 's failure to communicate with us if L. Pierrot would come out after officers left and confront a member of the public, his estranged wife or P. Willow.

- 1212: M. Pierrot states that she has received several calls from L. Pierrot who made a comment about shooting off the legs of an officer he can see. M. Pierrot said that L. Pierrot said that he has five weapons loaded, "armed", shotguns, rifles and pistols.
- 1214: L. Pierrot calls M. Pierrot and hangs up. M. Pierrot said that L. Pierrot said, "screw you" (meaning the police), he isn't giving us anything even if we move the second vehicle.
- 1217: M. Pierrot says that L. Pierrot called and said that we had five minutes to move the cops or he kills himself.
- 1219: L. Pierrot calls M. Pierrot and says, "four minutes" and hangs up.
- 1221: L. Pierrot calls M. Pierrot and says, "three minutes" and hangs up.
- 1228: L. Pierrot calls M. Pierrot and says, "times is up", advising M. Pierrot that he has a gun to his head, then hangs up.
- 1229: L. Pierrot calls M. Pierrot and says, "goodbye Melissia" and hangs up.
- 1239: S. Willow is attempting to call L. Pierrot . 1240 L. Pierrot answers and hangs up. S. Willow says that L. Pierrot  $\,$  is "real Groggy".
- 1248: L. Pierrot calls M. Pierrot and wants blue car moved, stating that he will give nothing in trade.
- 1250: L. Pierrot calls M. Pierrot and says that he is done negotiating and begins talking about family and kids. M. Pierrot says that L. Pierrot said that if officers leave he will talk to somebody. L. Pierrot is told officers are not leaving and is offered the opportunity to speak with Ofc. Clove, Oak' or myself. L. Pierrot declines offer, stating that he will talk to no one and hangs up.

- 1257: M. Pierrot says that L. Pierrot says that he will not talk to the police because he does not want to go to jail, then demands that she get the police out of there "now!" L. Pierrot hangs up.
- Myself, S. Willow and Lt. Douglas discuss having myself go to M.
- Pierrot 's location and speak with L. Pierrot when he calls. I express the need to cut M. Pierrot out of the communications link as L. Pierrot should be forced to negotiate with us and not M. Pierrot . It is decided to send Lt. Pine to M. Pierrot 's location.
- 1307: L. Pierrot calls M. Pierrot and says that he is not going to talk anymore and that the police can just kill him.
- 1319: L. Pierrot calls M. Pierrot and Lt. Pine answers. (S. Willow's watch indicates 1316 hours.)
- 1320: L. Pierrot calls Lt. Pine and says, "I just saw one leave", then hangs up.
- 1333: L. Pierrot calls Lt. Pine, when Lt. Pine answers L. Pierrot says I didn't call to speak with you, then hangs up.
- 1335 L. Pierrot calls S. Willow and says that his attorney is on the way up to the scene.
- 1338: L. Pierrot calls S. Willow and says that he saw two more come back.
- 1340: L Pierrot calls S. Willow and claims that we lied about officers leaving the scene, then hangs up.
- 1341: S. Willow attempts to call L. Pierrot back.
- 1342: L. Pierrot answers and says that if we don't leave we will have to suffer the consequences, then hangs up.
- 1343: S. Willow calls L. Pierrot back, L. Pierrot answers and says, "Leave me the fuck aRaye", then hangs up.
- 1349: L. Pierrot calls, I answer and L. Pierrot says, "One more down". (S. Willow had left the area to make contact with another party.)
- 1354: L. Pierrot calls Lt. Pine and hangs up.
- 1355: L. Pierrot calls me and says, "He better run a little faster or the next time he gets taken out". (L. Pierrot is referring to S. Willow who returned to the negotiations residence.)
- 1538: L. Pierrot calls me and says, "do you want to talk?" I respond "Yes". L. Pierrot says, "do you want to sent somebody over here totally unarmed?". I respond, "I don't think that would be a good idea". L. Pierrot hangs up before I can finish my sentence.
- 1402: L. Pierrot calls Lt. Pine and says that he will speak with R. Spruce, then hangs up. S. Willow calls dispatch and gets the number for R. Spruce at home and has him respond.
- 1410 1412: L. Pierrot is reported by SWAT members to be outside near the carport. At this point S. Willow, myself and Lt. Douglas take cover at the entrance to the kitchen in the living room. SWAT members radio that L. Pierrot is walking on the south side of the residence, then to the east. The east side of the residence has numerous windows and myself and S. Willow find cover near the freezers in the kitchen. I can see outside the kitchen windows in a western direction, I see L. Pierrot who I know from his police explorer experiences walking north toward the barn. I can see that L. Pierrot has a blue semi-automatic pistol in his hand, which he is holding with both hands. The weapon is at a high cover position, up near the chest, but not point shoulder. I can hear orders being given to L. Pierrot and can hear officers call him by his

first name. I hear this, "Ray, put the gun down" repeated over and over again. I can tell that it is said at least half a dozen times. I move near the stove, just to the right of S. Willow and hear multiple gunshots that occur at or about the same time. I see L. Pierrot fall to the ground. L. Pierrot is on the west side of the vehicle, Honda at the west end of his Grandmother's house, about half way between street and the barn.

S. Willow and I exit the residence, S. Willow calling for an ambulance at the same instant that L. Pierrot falls. I see A. Cedar secure L. Pierrot 's weapon. Sgt. Spruce has arrived and begins securing the scene and marking officers positions. Barricade tape is used to cordon off the area. I returned to the residence and took possession of the tape that I have placed into evidence. I took my notes and kept them until I attached them to this report. I contacted the Chief of Police by telephone and advised him that the suspect had been shot by the SWAT members. I requested that Lt. Seipert respond to M. Pierrot 's residence. I left the scene at about 1454 and returned to the station.

I stayed in the Investigations section except for routine contact throughout the department until I spoke with L. Shrub, IBI.

Cpl. Tom Woode, Cpl. Dave Fry and Lt. William Pine were advised of the call out as they were on duty and began to gather our equipment in order to respond to the location. Officer Ted Oak and Cpl. Doug Pine were the other SWAT team members who were called in and we all responded from the City Police Department to the area of 11th Street and STREETAvenue where the command post had been established. We arrived at the command post at 10:22 hours.

At the command post was an ambulance and a fire truck aRayg with

Lt. Tom Douglas and Lt. William Pine from the City Police Department. A briefing was held for the SWAT team members where information was given to us from Lt. Tom Douglas and Lt. William

Pine concerning locations of patrol officer's and the location of the residence where the suspect was at. We also received some briefing from Fire Department personnel Travis Myklebust concerning medication which the suspect may possibly have and possibly taken. The first being some type of depressant and the second being some type of insomniac medication.

At 10:28 hours I assigned Cpl. Doug Pine and Officer Oak' of the SWAT team to make a sweep of the area and come back with a diagram of the residence where the suspect was currently at. It should be noted that Patrol Officers had established a perimeter on 11th Street and had been observing the house prior to our arrival. Cpl. Pine and Officer Oak' returned to the command post with a drawing which will be included into the original case file. After a discussion at the command post a decision was made to post Cpl. Doug Pine on the northwest corner of the house at this being the grandmother's house. Cpl. Pine could observe from that location the east and north side of the residence. Officer Oak' was assigned to cover the southeast portion of the residence which was done from behind a shed at the house directly south of

Officer Clove had been in a location on the north side of the residence, he was told to stay at that location to watch the north side of the residence. Officer Oak' and Cpl. Pine relieved two patrol officers who were then moved out to the perimeter to the intersections of 11th and Cedar Avenue and 11th and STREETAvenue. Traffic was closed down on 11th Street between STREETAvenue and Cedar Avenue. It should be noted that I did use a telephone to call the Communications Supervisor Sharon Clemenhagen and asked her if she had personnel available to call a residence in the 3500 block of 11th Street and if she got an answer to tell the people to stay inside their residence until the situation had been resolved.

At 10:49 hours I advised Sgt. Steve Willow that the perimeter had been established and that he could call and attempt to contact the suspect. At 10:51 hours I advised Sgt. Willow and the perimeter units that if the suspect were to come out the east side door, Cpl. Pine would be the one to give directions and if the suspect came out the north side door, Officer Clove or Cpl. Fry would give the directions. If should be noted that Cpl. Fry had been assigned to assist Officer Clove on the north side of the residence and that Cpl. Woode and I had moved to a position in a barn directly north of the suspect's residence. We eventually moved Cpl. Pine over to the barn area with us.

Cpl. Dan Aspen advised that they had made contact with the suspect and he did sound somewhat groggy and disoriented however, he had hung up. At 11:03 hours Officer Ben Clove advised he saw the suspect looking out the living room window on the north side of the residence.

Cpl. Aspen and Sgt. Willow periodically advised the outside units of the status of the negotiations and what was being said. At 11:25 hours we were advised that the suspect said that "The first officer he sees is dead." At 11:26 hours Officer Ben Clove sees the suspect Pierrot looking out of the bedroom window on the north side of the residence. Sgt. Willow and Cpl. Aspen continue negotiations, concerning the requests of negotiations refer to supplements by Sgt. Steve Willow and Cpl. Dan Aspen. At 11:42 we were advised that the suspect made the comment that he was going to start shooting holes in the walls. At 11:57 hours Officer Oak' observed the suspect Pierrot looking out the sliding glass windows or doors on the south side of the residence.

## At 11:59 hours the suspect Pierrot advises

Sgt. Willow that suspect Pierrot has said that the officer behind the shed near the Aspen house needs to move or he is dead, this would be Officer Oak'. The suspect Pierrot made a couple other comments concerning the officer behind the shed and that he had a clear shot at him and that he will start shooting. Officer Oak' was asked to move to a different location which he did and was still able to observe the south side of the residence. The suspect Pierrot also said that he could still see Officer Oak's leg and threatened to shoot the officer in the leg and he made the comment of being a trained sharp shooter. At 12:07 hours it was discussed whether to leave and hopefully the situation would de-escalate however, there was no commitment on the suspect's behalf that the situation would remain the same if officer's left. An attempt was made to get a commitment from the suspect that if Officer's left someone could talk to him and stay with him. At 12:15 hours the suspect Pierrot said we've got five minutes to leave or he would kill himself. Officer's remained at their positions observing the house and trying to negotiate. Suspect Pierrot made several more phone calls counting down a time period however, he did not shoot himself.

Negotiations or conversations between the suspect and police continued through out the afternoon. At 2:04 PM, the officers on the perimeter heard what we believed a gun shot from the interior of the residence. Officer's were ordered to hold their positions and not approach the house as it was unknown if the suspect had merely fired a round into the walls or ceiling or he had possibly shot himself.

The negotiators were asked to attempt to contact the suspect by telephone to see if there was any response. While waiting for this at 2:07 hours, I heard and observed the door leading onto the car port on the east side of the residence was opened from inside the house. After approximately 30 seconds I observed the suspect Ray Pierrot who is personally known to me exit the door on to the car port. The suspect Pierrot was carrying what appeared to be Luger type or automatic type pistol in his right hand and it was pointed at the back door of the residence at

I observed Pierrot to place both his forearms on top of the car which was in the car port, that being a medium blue colored newer model Chevrolet, and he continued to point the gun towards the back of the house. He then began to sweep the gun in a semi-circular motion from right to left or left to right as if he was looking for someone. Pierrot the proceeded to move to his right around the front of the car in the car port, he still maintained the gun pointed out in front of him in the direction he was moving his head was also moving looking around as if he was looking for someone.

#### I noticed that Pierrot was

having a somewhat difficult time with his motor functions, he seemed to be stumbling as he walked and his coordination seemed to be noticeably effected. As Pierrot moved out into the back yard and began to walk in a southeasterly direction, all three officers being Cpl. Doug Pine, Cpl. Tom Woode and I yelled at him or challenged him and told him to put the gun down. Each of us numerous times called him by name telling him to put the gun down. As soon as heard our voices he turned directly towards us and began walking directly to where he heard the voices coming from. He moved the gun to point in our direction of us in the barn, he held it about chest high and held it with two hands and moved in our direction. His face appeared somewhat blank or expressionless and I did not see him or hear him say anything, he just continued to move towards where the officers were located.

The officers continued to challenge the suspect Pierrot , telling him to put the gun down, telling him to stop and put the gun down. At one point as he got near the front of the gray Honda Civic parked behind the residence he somewhat hesitated, this is where I thought he would stop and obey the officer's commands however, Pierrot continued to proceed towards us. The officer's continued to challenge him telling him to put the gun down and he continued to point it in the direction of the Officers. Officer's stated that it was getting pretty close I said it at the time he was stopped as I began to fire my service weapon I heard a volley come from behind me this apparently being from the shotgun from Cpl. Pine and I believe I heard one pistol round which I believe was Cpl. Tom Woode. I eased off the trigger as I noticed that the suspect Pierrot had dropped the gun and spun in a counterclockwise direction due to the bullets hitting him. I observed the gun to leave his hands and fly back towards the grass over behind him, I lost sight of it when it hit the ground.

I immediately called out for a cease fire as the suspect was down and there was no movement from him and it appeared he was no Rayger in possession of the gun. I approached the suspect and went by him I could see that his eyes were open and he appeared to be looking straight up. I located the gun in the grass about six feet from where he was lying on the ground and immediately took custody of the gun and moved it a further distance away from the suspect. At this time Sgt. Steve Willow was requesting an ambulance and security to seal off the scene. I contacted Cpl. Pine and I told him to make his weapon safe. He said he had shot two or three rounds. Cpl. Dave Fry had also approached and he had fired a round and I told him to make his weapon safe. I remained with them in the grass area. Due to the high volume of traffic near the car and grass area from ambulance, fire and police, I picked up the gun a second time and moved

it over towards the car port out of the way of everyone. When I moved the gun I noticed there was a live round sticking out of the top portion of the gun which I recognized to be a stove pipe or a jammed round.

I remained with Cpl. Fry and Cpl. Pine as medical people attended to suspect Pierrot . I then learned that Cpl. Tom Woode had also fired one round and we all remained in the general same area and pointed out to Lt. Douglas and Lt. Pine and Sgt. Spruce where we were at the time the rounds were fired by officers. It should also be noted that I took Cpl. Woode and Sgt. Willow and made a quick walk through in the residence to make sure there was no one else in the residence. We walked into all the rooms to see if there was anyone there then walked back out. It should be noted that when we looked into the bedroom area we all noticed two rifles, one being in a case sitting on the bed or dresser at the end of the bed and a second rifle standing up in the corner. Officers were then gathered and travelled as a unit back to the City Police Department.

On Thursday April 18, 1996 at 0903 hours I received an emergency page from the City Police Department. When I called the station, I was told that there was a SWAT call out and that Ray Pierrot, whose known to me from his experiences as a Police Explorer, was suicidal and was located at I responded to the station and met with the other team members.

We responded to 11th St. and STREETas this was the designated command post for this incident. Sgt. Alan Cedar directed myself and Cpl. Pine to scout the immediate area of the residence. We were specifically instructed to draw a diagram of the residence outlining windows and doors and places of concealment and cover for officers. Myself and Cpl. Pine did this as instructed, I acted as a cover officer while Cpl. Pine prepared the diagram. While doing this we were able to contact the patrol officers that had maintained the perimeter. The officers that were contacted were Officer Joedy Cypress, Officer Larry Elm, and Officer Ben Clove. These officers were not able to offer any information that we had not al Aspeny had at the command post.

Myself and Cpl. Pine returned to the command post and met with the other team members. We had been told that two of the tires to Pierrot 's vehicle which was parked under the carport on the north side of the residence had been flattened in order to prevent him from driving away.

Team assignments were given by Sgt. Alan Cedar. I was directed to relieve Joedy Cypress near the John Aspen residence and take up a position so I could observe the east side of the residence. It was also determined that myself and Cpl. Pine would respond to the area of the carport and take down a blue plastic tarp in order to offer the officers at the scene a better visual of the livingroom windows at the carport and the carport door should Pierrot exit this area.

After the tarp was removed I responded to Officer Cypress's location and relieved him of surveillance on the east side of the residence. Officer Cypress was directed to secure the perimeter on 11th Street and block all traffic.

I monitored the radio traffic related to this incident and also passed on observations that I had made while on the east side of the residence to the other team members. I have had the opportunity to review a supplement report completed by Sgt. Alan Cedar on this incident as well as the radio log completed by the dispatcher. Refer to the above listed reports for specific times and actions by officers at the scene.

At about 1158 hours I observed Pierrot looking out the sliding glass door on the east side of the residence. This information had been relayed to the other officers. At about 1201 hours I was advised by radio that Pierrot made the statement that he's got a shot of the officer's face behind the shed. At this point I was not exposed, however due to my location behind the shed where I lost sight of the residence. I was then told that Pierrot stated that he still had a shot at my leg. I was still totally concealed at this point and out of sight of Pierrot . For safety reasons it was determined that I would take up surveillance at another location.

I moved to the rear of the John Aspen residence to a wood shed. This gave me a position to continue to maintain surveillance on the east side of the residence and part of the carport. I continued to monitor radio traffic in this incident.

From my position I could see Sgt. Alan Cedar, Cpl. Tom Woode, and Cpl. Doug Pine. Their position was near a barn near the residence of 3511 11th Street.

At 1407 hours I monitored radio traffic indicating that the carport door had opened and that Pierrot was outside with a gun.

When Pierrot stepped out of the carport area where I could see him, he appeared to be looking in the area of the Aspen residence where I had initially been stationed. Pierrot seemed to be sweeping the area and looking for officers.

With Pierrot 's location and the location of Sgt. Alan Cedar, Corporal's Pine and Woode, it was apparent that I was possibly in a crossfire situation. I radioed at 1409 hours "I'm getting out of here." I moved to the area of the deck near the pool of the John Aspen residence. I could see that Pierrot still had a pistol in his hand and was now moving towards the location of the other team members near the barn. My position was still not one of safety and I removed myself from the potential line of fire near the rear of the Aspen residence. I heard numerous commands given by the officers at the barn ordering Ray Pierrot to put the gun down. The specific statements that I recall were "Ray put the gun down". I heard this approximately 12 times. I then heard numerous gun shots and I remained in my position still out of the sight of the incident.

I heard someone shout cease fire and I was able to see that Pierrot was now down on the ground and officers were approaching him. I responded to that approximate area where I was directed to assist in shutting the scene down. I went to the driveway of and stood by at 11th St. and assisted in setting up the perimeter.

At 1440 hours the SWAT team members cleared the scene and returned to the station.

On 4-18-96, at about 0925 hours, I was at my residence when I received a telephone call from Sgt. Alan Cedar. Cedar said that the SWAT Team had been called out in regards to Ray Pierrot being the suspect in a man with a gun call at 3512 1/2 11th Street. Cedar requested that I respond to the Command Post at 11th and STREETand contact Lt. Tom Douglas who was al Aspeny at that location with Fire Department personnel.

I immediately left my residence and at about 0928 hours contacted

Lt. Douglas at 11th and Burrell. Douglas said the call at involved Ray Pierrot who had earlier in the morning pointed a gun at some of his relatives, was currently in his residence with several firearms and had been making threats about shooting any officers who tried to contact him. Pierrot was also reported to possibly be under the influence of an antidepressant drug and a hypnotic drug for insomnia.

While awaiting the arrival of other SWAT Team members at 11th & Burrell, Lt. Douglas and myself continued to monitor radio and cellular phone traffic. Ray Pierrot was calling frequently to speak with Misty Pierrot at During these calls, Ray Pierrot made numerous threats to the effect that he would shoot any officers that came to his residence. According to Misty, Ray sounded very groggy, was slow to respond, and seemed disoriented and confused.

A request to call out Corporal Dan Aspen as a negotiator was made. The initial thought was to have Aspen go to Misty Pierrot 's residence and take over the phone conversations when Ray called. It was hoped through this process a constructive dialogue could begin to bring this incident to a peaceful conclusion. Through later discussions with Lt. Tom Douglas, it was decided to have Aspen come to the incident scene to team up with Sgt. Steve Willow for negotiation purposes. Lt. Douglas called the station to make arrangements for someone from the Communications Section to go to Misty Pierrot 's residence to assist and act as support.

At about 1022 Hours, the SWAT Team members and the Special Response Vehicle arrived at 11th & Burrell. Team members were briefed by Lt. Douglas about all currently known information, and were provided an interior diagram of the residence where Ray Pierrot was at. This diagram had been provided by Sgt. Steve Willow, apparently from Pierrot 's relatives. Officer Oak' and Cpl. Pine were deployed by Sgt. Cedar for purposes of scouting the incident scene and developing a diagram of the residence that Pierrot was in from the perspective of door openings, windows, etc. Having received the scouting information from Oak' and Pine, Team Leader Cedar made the assignments for the deployment of team members. Cpl. Aspen and Lt. Douglas went to the Pierrot residence at to begin a negotiation process with Pierrot. I remained at 11th & STREETas a secondary communications link between the station and the scene.

At 1257 Hours, I was requested by Lt. Douglas to go to Misty Pierrot 's residence and take over any potential communications with Ray Pierrot from that location. This request was made following conference with Sgt. Willow and Cpl. Aspen regarding the direction the negotiations were currently going. It appeared that every time Ray Pierrot called Misty Pierrot he became more threatening, escalating and potentially out of control. It was hoped that this request would de-escalate the situation and begin working toward a peaceful resolution.

At 1311 Hours, I arrived a and made contact with Misty Pierrot and Communications Specialist Stephanie Fish. I explained to Pierrot and Fish what we hope to accomplish by having me now become involved in the communications link with Ray Pierrot, rather than Misty.

At 1317 Hours, I received a phone call at Misty's residence. I answered the phone and identified myself to the caller. The caller did not speak whatsoever, I could hear a very faint moaning and some breathing on the other end of the phone line. I

believed that it was Ray Pierrot on the other end of the phone.

At 1331 Hours, I received a telephone call from Ray Pierrot . Pierrot indicated that he will not talk to me and immediately hung up the phone. The call lasted about 5 to 6 seconds.

At 1352 Hours, Ray Pierrot called Misty's residence again. When I answered the phone, Ray Pierrot asked if he could talk to his wife. I indicated that that was currently not possible, that he needed to talk to me so that we could get this incident taken care of. Within about 10 seconds of starting the call, Ray Pierrot hung up on me.

At 1400 Hours, Ray Pierrot called me again. He and I briefly discussed the need for him to begin speaking with either myself or the team of Aspen and Steve Willow. Pierrot irately indicated that he did not wish to speak to any of us, and asked if Randy Spruce was present. I indicated that Spruce was the scheduled supervisor for swing shift, that he was not currently involved in this incident, but that I could make immediate contact with him if Ray would speak with him. Ray then hung up the phone. I immediately requested to Lt. Douglas that contact be made with Spruce for his immediate response to the 3500 block of 11th Street to begin helping resolve this incident.

I received no more phone calls while I was at Misty Pierrot 's residence. At about 1404 Hours, I monitored radio traffic over the scanner at Misty's residence, that indicated a gunshot had been heard inside the residence. At 1408 Hours, radio traffic was monitored indicating that Ray Pierrot was outside with a gun and panning the area in an easterly direction from his residence.

At about 1410 Hours, radio traffic was monitored that indicated a subject was down. Overlapping traffic from police and fire/ambulance units made it totalling confusing as to exactly what was going on at the scene.

Within a couple of minutes, and with no radio traffic to provide information about the situation in the 3500 block of 11th street,
I left Misty Pierrot 's residence and arrived at tabout 1417 hours. As I arrived, I

observed ambulance personnel loading Ray Pierrot into the back of an ambulance on a gurney.

Immediately after the ambulance with Pierrot left, SRO Glen Rogers and I placed yellow police barrier tape in a widened perimeter around the residences and property at the left. Within a few minutes I was able to make contact with Sgt. Randy Spruce, who was also at the scene, and he and I began to place barrier tape and traffic cones at those locations occupied by SWAT Team members at the time of the shooting. Yellow barrier tape and other marking devices were used to mark physical evidence that would ultimately be evaluated by an investigative team from the State Department of Law Enforcement.

I remained at the scene to assist, whereupon, I was contacted by Detectives Oakly and Stump. They indicated that they had been assigned to the scene to assist the State Investigative Team.

I stood by at the scene with other state investigators and department personnel, to await the arrival of a search warrant for Mary Pierrot 's vehicle and Ray Pierrot 's residence and immediate residential property. The warrant had to be obtained as Pierrot family members had refused to give any type of consensual search for the premises.

The search warrant signed by Magistrate Carl Kerrick arrived at 1715 hours. Those present at the time a search in compliance with the warrant began, were myself, Detectives Oakly and Stump, and State Investigators Dave Yew, Dave Denblyker, and Vern Teak . As part of my assistance in the service of the search warrant, I found the following specific items at the listed times:

1746 Hours: Found a spent .22 caliber casing under a red blanket in the living room area of the Pierrot residence.

1748 Hours: Found a bullet hole with powder tattooing around it, in the right side arm of a chair located in the northeast corner of the Pierrot living room.

1610 Hours: Used a thin brass rod as a probe to illustrate the path of travel of the bullet into the above described chair.

1612 Hours: Moved chair and located a lead bullet fragment on the carpet underneath the above described chair.

I continued to assist other department officers and state investigators until such time as the search was completed. Upon completion of the search warrant service, the barrier tape around the scene was removed and the scene was secured by all involved officers.

On 4-18-96 at about 1300 hours I was directed by Chief Baldwin to go to the scene of this incident to obtain information in order to secure an arrest warrant for Ray Pierrot for the crime of aggravated assault. I arrived at ve at 1321 hrs and spoke with Sgt Steve Willow and Cpl Dan Aspen. I was told about the incident that had happened at about 0830 hours when Ray Pierrot had pointed a gun at his sister Mary Pierrot and told her, "get out of here" when she went into his residence a was told that Mary Pierrot had described the gun as a Ruger type semi-automatic handgun.

Sgt Willow also told me that during the period of time that the officers were on the scene and negotiating with Ray Pierrot that Pierrot had made several threats upon the lives of the officers there. Sgt Willow gave a couple of examples from the log that Cpl Dan Aspen was keeping during the negotiations. I was told that at 1200 hours, Pierrot said that the Officer behind Aspen's house moves out or he is dead. Another statement from Pierrot was received at 1203 hours when he said that when he observes any officers he would "take them out".

I left the residence at and returned to the Nez Perce County Prosecutors Office at 1352 hours in an effort to obtain the warrant. While at the Prosecutors Office I was listening to my radio and at 1410 hours I heard the officers at the scene advise that a shooting had taken place and that the suspect was down and were requesting an ambulance respond. I terminated the request for the arrest warrant at that time as it was not immediately necessary.

I returned to the police department and was directed by Chief Baldwin to call off-duty Det Stump and have him respond to the City Police Department and that I was to assist the State of State Bureau of Criminal Investigation in the investigation of the shooting incident.

After a brief meeting at the City Police Department with CIB

I went to the scene with Det Stump and NPC Prosecutor DeniseRose. Upon my arrival at the scene it was determined that a search warrant was needed in order to search the residence that Ray Pierrot had been in at At 1557 hours myself and DeniseRose returned to her office to prepare the search warrant. I discussed the situation with Sgt Alan Cedar and used that information for the affidavit to obtain the warrant. After obtaining the signature of Judge Kerrick I returned to the scene at 1654 hours.

I advised the investigation supervisor at the scene, SA David Berry that I had the signed search warrant. I was tasked to assist SA Vern Teak in searching the residence. Lt Bill Pine also assisted. The search was conducted and Teak seized all the property that was taken and maintained control of those items. For information as to what was recovered see inventory sheet. Among the items recovered was a spent .22 cal casing that was located in a blanket in the living room. In addition, the .22 cal bullet was noted to have been fired into a chair in the living room and the expended bullet was found on the floor below the chair.

The items that were recovered outside was recovered by a different search team (Stump, Berry and Dave Yew). Other members of the investigation team conducted a neighborhood canvas and interviews with the SWAT team members.

While conducting the scene investigation Det Stump took video film of the area. CIB members took the still photographs.

After the scene investigation was concluded, Stan Pierrot arrived at the scene to obtain medication for his grandmother that lives in the main residence. While he was there I gave to him two purses beRayging to his mother Ursula and his sister Mary and a bag containing camera equipment and a CD/Radio that had been in Mary Pierrot 's vehicle. Stan Pierrot signed for these items. It should be noted that these items were not search and only the check books in each purse were looked at to determine ownership. This was done in the presence of Stan Pierrot .

After that was done I escorted Stan Pierrot through Ray Pierrot 's residence. The residence was then locked and the house Douglas was given to Stan Pierrot . Members of the investigation team assisted Stan Pierrot in covering Mary Pierrot 's vehicle to protect it against the weather pending repair to the glass.

For information concerning the location of City Officers and evidence obtained form the exterior scene see supplemental reports of those officers involved.

I was tasked to attend the autopsy of Ray Pierrot that was scheduled to occur on 4-19-96 at 0800. I arrived at St Joseph Regional Medical Center at the appointed time. Myself, SA David Berry and SA Vickie Seed attended the Autopsy. Dr Tree conducted the autopsy. I took photographs of the autopsy as well as did Dr Tree and SA Berry.

During the autopsy approximately 20 shotgun pellets were removed from the body. These were taken by SA Berry. Berry made a sketch of the body and marked the approximate locations of the wounds. Dr Tree also did this as a part of the exterior examination of the body. The body was x-rayed prior to the interior examination. For additional information see autopsy report when completed by Dr Tree.

On 4-22-96 I made the return of the search warrant to the court in front of Judge Elliott.

On 04-18-96 at approximately 0849 I was standing outside the dispatch center when I heard Communications Specialist Fish take a 911 call where she began repeating to the dispatcher she had a man with a gun at I observed Sergeant Willow at the station and I contacted him and advised him of the call at which time both he and Officer Clove who was also at the station immediately left. I went back to the Communications Center where Fish asked me if the officers should be advised that the suspect was Ray Pierrot , who I was aware was the estranged husband of another Communication Specialist, Misty Pierrot . I told dispatch to go ahead and inform the officers of this information so that they would be aware that they were dealing with an individual who may be under stress from marital problems.

At 0855 hours I did leave the station to go to the residence at approximately the same time Sergeant Willow arrived at the scene. While I was enroute Sergeant Willow called me via radio requesting that SWAT Team be activated. Because Sergeant Willow was present at the scene and was able to make that assessment I did call the station and requested the SWAT Team be activated. At 0915 hours I arrived at the residence at where the suspects mother and sister were present. I was present when the complainant, Mary Pierrot told Sergeant Willow that she had went in to the residence where her brother was staying which was directly west of the residence we were at and that her brother had threatened her with a firearm which he had pointed at her and told her to leave. Pierrot reportedly had several weapons in the residence and it was believed he was taking some prescription medication which had been prescribed for him, anti-depressants and sDouglasping medication. It was unknown by family members if he had been drinking alcohol. Sergeant Willow had directed patrol officers on his watch to surround the suspects residence until they could be relieved by members of the SWAT Team. I left the residence and went to a gravel parking lot on the north west corner of 11th and STREETwhich I advised the station would be the command post. I requested an ambulance with paramedics to stand by at that location in case the suspect injured himself or others.

While waiting for the SWAT Team to arrive at the command post/staging area I was advised by Sergeant Willow that Pierrot was in contact with his estranged wife Misty by phone.

We discussed the need to have someone at M. Pierrot 's residence and when Crisis Negotiator Corporal Aspen went into service I directed him to proceed to M. Pierrot 's residence. While he was enroute Sergeant Willow contacted me and we decided that he would be in need of the assistant negotiator at his location. I contacted the police station and talked to Communications Supervisor Clemenhagen telling her that M. Pierrot should have someone with her at this time. Apparently this was later accomplished when Communications Specialist Fish did go to M. Pierrot 's residence. Lieutenant Pine contacted me at the staging area and we received a rough sketch of the interior of the residence where the suspect was at. At 1022 hours the SWAT Team arrived at the scene and Sergeant Cedar directed Scouts to go check the area. The Team returned from their scouting mission, there was a briefing where they were shown the rough sketch of the interior of the residence and they also made a sketch of the scene so they could deploy SWAT Officers to contain the suspect. As the SWAT Officers moved into position in their assigned area, Officers Elm and Cypress were relieved of perimeter positions. Officer Elm was directed to close the street at

Sergeant Willow attempted to begin Crisis Negations with Pierrot at approximately 1050 hours. While I was in contact with the negotiators at the command post they relayed that they were having difficulty getting through as there was some kind of a line block where they could not call in without operator assistance. During this time the line would be busy at times as he was calling his estranged wife M. Pierrot . City Fire Department Paramedic Scott Hawk apparently arrived at the residence before we had been able to secure the street and the area and insisted to Sergeant Willow that he be allowed to attempt to talk with Pierrot as he was a friend of the family. Apparently the suspect hung up the phone when this individual attempted to negotiate. Sergeant Willow advised that he was continuing to have problems attempting to communicate with Pierrot . I advised Lieutenant Pine at approximately 1140 that I am going to go up to the residence and meet with the crisis negotiators. After I arrived apparently the suspect is demanding that some vehicles be moved from the rear of the residence. Myself, Sergeant Willow and Corporal Aspen discussed the moving of the vehicles as requested by the suspect.

Scott Hawk volunteered to remove his vehicle which is a red Toyota four wheel drive pickup. Sergeant Willow and myself felt that if we can do something for the suspect at this point that we may see some movement if Hawk is allowed to move his vehicle around to the street out of sight. Approximately a little after noon Pierrot begins threatening that he can shoot one of our officers. We decided that it is too dangerous to keep family members in the residence any Rayger because the suspect is alleged to have rifles which could penetrate the interior of the residence. At that time myself and Corporal Aspen escorted family members across the street, out of line of fire where they remained until the incident was over. At approximately 1217 Pierrot tells Sergeant Willow that we have to remove the officers or he will kill himself. He calls on two different occasions counting down the minutes then apparently calls his estranged wife telling her the time is up. We wait several minutes until Sergeant Willow calls, he advised us that Pierrot appears to be groggy. Pierrot makes additional calls wanting a car moved and wanting the officers to leave. The three of us then discuss having Corporal Aspen go to M. Pierrot's location to speak with suspect when he calls. It was decided we would request Lieutenant Pine to go to that location and he immediately went to M. Pierrot's residence so we could take control of all communications with Pierrot.

It was decided that we needed more telephones in the residence because we needed to keep the one phone line open. At approximately 1320 hours I left the residence running south away from it, apparently Pierrot calls and tells Lieutenant Pine who has arrived in Pierrot 's residence that he just saw one leave. I met Detective Oakly at 11th and Cedar, Detective Oakly is there to obtain information to apply for a warrant for aggravated assault. I have Detective Oakly accompany me back to the residence at approximately 1338 hours where Pierrot calls Willow and tell him that he saw two more come back.

At approximately 1349 Sergeant Willow leaves the residence and runs northbound down 11th Street to contact Pierrot 's attorney who Pierrot had apparently called, Dave Maple. Dave Maple had arrived at the road block at 11th and STREETand contacted Officer Elm. I had advised Officer Elm to not allow Mr. Maple to enter the area as the scene was unstable. Pierrot calls Corporal Aspen and told him, "one more down". At approximately 1355 hours after Sergeant Willow returns to the negotiations center Pierrot calls and tells Corporal Aspen that he'd better run a little faster or next time he'll be taken out. Shortly after this call Pierrot calls and wants one of the officers to come to his residence totally unarmed and Aspen does not agree to that situation.

## At 1402 hours we're advised that Pierrot has called Lieutenant

Pine stating he will speak to Sergeant Spruce. Sergeant Willow calls Sergeant Spruce at home, he advised he will be enroute. Sergeant Willow, Corporal Aspen and myself discuss the possibilities for proRayged negotiations and have decided that we will continue to negotiate and will hold the perimeter for as Rayg as it takes to resolve the situation in a peaceable manner if at all possible.

At approximately 1410 hours SWAT Officers report that Pierrot is outside near the carport. Sergeant Willow and Corporal Aspen moved to the kitchen to attempt to see him and Sergeant Willow advises that he is out of the residence and moves back into the living room. Sergeant Willow and Corporal Aspen take positions on each side of the doorway leading into the kitchen in case Pierrot attempts to come into the residence. I took a position in the doorway of the hall leading into the bathroom and bedrooms where I can cover the front door and the north side windows in case Pierrot comes around the residence. We do this because we do not have visual contact with Pierrot and are not sure where he may go. I hear radio communications where Office Oak' advises that he is retreating as Pierrot is walking on the south side of the residence towards the east. Due to the fact that apparently he is pointing his weapon according to radio traffic I advised SWAT Team to challenge Pierrot. I immediately begin to hear hollering. A few moments later I hear what appears to be five to six shots being fired outside the residence. Corporal Aspen advises me that Pierrot is down at which time the three of us exit the residence. I can hear Sergeant Willow calling for the ambulance and for officers to secure the perimeter. As the ambulance goes by Scott Hawk who is standing near the apartment on 11th Street begins running into the yard saying he's a paramedic, I direct him back to the street as I realized he was not on duty at the time and for the fact there apparently is a connection with the family, that he may not be able to function in a manner which would be conducive to giving the suspect proper emergency medical treatment. I remember challenging Hawk three times telling him to get back to the street or he would be arrested, before him turning and leaving to the street. Immediately I see that officers are placing barricade tape up around the perimeter of the area.

I go back to where paramedics are attempting to stabilize the suspect and preparing to transport him. I assisted paramedics by moving a gurney into position and by loading two medical bags into the ambulance as they transport Pierrot from the area. Sergeant Cedar then walks me through the scene and shows me where each SWAT Member was stationed and which officers fired their weapons and where Pierrot was when he was wounded by the officers. Sergeant Spruce was also present during this and I then advised Sergeant Cedar to load up the SWAT Team and return to the station and secure their gear and stand by for the investigators there. I remained at the scene until officers from the State Criminal Investigation Bureau arrived. I walked Supervisor Dave Yew through the area showing him what I had briefed on and at 1617 hours I left the scene. At 1630 hours I arrived at the station and shortly after six p.m. I did give a statement to State Investigator Vickie Aspen as to my recollections of the incident.

Sgt. S. Willow

On 4-18-96, at about 0852 hours, I heard dispatch send Ofc. Elm to on a call of a man with a gun. I immediately got in my patrol unit and left the station to respond. While responding we learned from dispatch that the complainant was the suspect's sister and that the suspect was on the phone with his estranged wife who was at another location. Ofc. Elm and I arrived at and contacted Ursula Pierrot, mother of Ray Pierrot and a Mary Pierrot, sister of Ray. Mary was still on the phone with dispatch when we arrived and I told her to hang up. I learned from them that earlier in the morning Ursula had been called by Ray's estranged wife, Misty, and that he was very despondent and was threatening to shoot himself. During this phone

conversation Misty had called Ursula to tell her about her son and Ursula and Mary came to to talk to her son. We were standing in front of which is a tan colored house. I learned that Ray was in a blue house at the rear of , and that the address in learned that when Ursula and Mary came to the house they went to the house Ray was in. They said both the east door and front door where locked. Ursula had a Douglas to the east door, which is at the carport of the house. She said she unlocked the door but the inside latch was still secured. She then forced the door and the latch broke and herself and Mary entered the house. They then walked to the northwest bedroom where Ray was. Ursula said she saw that Ray had a black colored pistol in his right hand and the gun was lying next to Ray. She asked Ray to come and talk to her and he told her that it was over and he did not want to talk to her. Mary said she then started walking into the bedroom to try and talk to Ray and he raised the gun off of the bed and pointed it directly at her and told her to "get out of here". Mary described the gun as black in color and possibly a Ruger semiautomatic. Ursula then started telling Mary that he did not point the gun at her but Mary then showed me how Ray pointed it at her. Her motions indicated to me that Ray had pointed the gun directly at her. I asked her if she was positive and she told me that she was. I then positioned Ofc. Elm to watch the north and east sides of the house and I positioned Ofc. Joedy Cypress to watch the south and east sides of the house. I entered the and took up surveillance through a kitchen window on the west side of the house. I then kept interviewing both Ursula and Mary.

I further learned that Ray had no less than four other guns in the

house besides the one they saw. Mary told me that he had two rifles, a shotgun and another handgun. I then called Lt. Douglas on

the radio and told him that I believe a SWAT callout was needed because of the circumstances. He agreed and told dispatch to callout the SWAT Team. I told Lt. Douglas that the command post should be in the church parking lot at 11th and Burrell. At about this time Ofc. Clove arrived at the scene and he was able to take up a position so he could watch the north side and west sides of the house at

Knowing that negotiations would have to be done when the SWAT Team arrived and to gain more knowledge of the suspect's physical state and mental state I started gathering more intelligence on the suspect. I learned that he was very despondent from his recent marriage breakup. He was very depressed and could not sDouglasp so either Tuesday or Wednesday he went to Dr. Carlos Privet and was put on some medication. They were not sure what it was. I also was able to obtain a layout of the inside of the house and also learned that Ray did have Douglass for a blue car that was parked in the carport at the time. There was also a gray colored Nissan parked between the house that I was in and the house where Ray was. Mary told me that it was her car and they had driven it over to the location.

I then spoke with Lt. Douglas. I told him my concerns of the suspect's chances of getting mobile in the blue car parked in the carport. I advised Lt. Douglas that I felt that with the officers currently present that we could disable the car by deflating the driver's side tires. Both Lt. Douglas and I came to the decision that disabling the car should try and be done prior to the SWAT

Team deployment. I then went outside and talked with Ofc. Cypress and Elm. My pocket knife and a knife of Ofc. Elm were given to Ofc. Cypress. While Ofc. Elm and myself covered Ofc. Cypress we were able to go up to the suspect's vehicle and Ofc. Cypress flattened both driver's side tires by puncturing them with a knife. During this time the knife blade closed on Ofc. Cypress's finger on his left hand and he received a cut. After we came back to a safe position we were able to bandage the cut.

Right before I came back into the residence I saw and heard a red pick-up being driven into the driveway at the pick-up drove to the back of the residence and parked next to Mary's gray Nissan. I saw a male exit the pick-up and I immediately recognized this subject as Scott Hawk, who is an employee with the Fire Department. I learned from Mary that she had called

him and requested him to come to the scene because he is a friend of hers. She also told me that he had some training in Crisis Intervention debriefing and that possible he could be used in negotiating with Ray. I advised her that at this point only trained police negotiators would talk to Ray once the SWAT Team was deployed.

I then learned more information from Ursula Pierrot . She told me that on Tuesday Misty Pierrot and P. Willow, an employee of the Police Department went out of town for an overnight trip to Worley, Id. Supposedly on their return to town on Wednesday Ursula said that Ray had told her that Misty had "flaunted" the trip in Ray's face. Ursula also told me that on Friday, the oldest son of Ray and Misty was having a birthday and that Misty was having a birthday party at a park. Ray had asked Misty in he could attend and Misty told him she did want him there because P. Willow was going to be there.

It should be noted that when we first arrived at and found out that the suspect was Ray Pierrot, Ursula first said that she did not want Willow to be there. I told her my name including my first name and she said that she did not want Phil Willow there. I assured her that he was not on duty today and would not be at the scene. Also when Scott Hawk arrived he addressed me as "Steve".

At about 0930 hours I received a call on the phone from Misty Pierrot . She briefly told me that Ray was very desponded, had barricaded himself in the house and had five loaded guns. He also had told her that he had taken about fifty sDouglasping pills and that he couldn't see very well right know. She told me she still had Ray on the phone and had to get back talking to him before he became suspicious.

It was decided around this time that when Cpl. Aspen arrived he would go to 1905 Birch, where Misty was, to try to talk to Ray. However before he got there the decision was made to have Aspen come to my location to assist when we started Negotiations.

Between 0945 and 1030 hours the SWAT Team had arrived at the Command Center at 11th and STREETand had sent out a scout team.

Also at about 1010 hours Cpl. Aspen arrived at my location and I briefed him on the situation. I also introduced him to the civilian members that were in the house. Also during this time I had phoned paramedics at the Command Center and they telephoned Dr. Carlos Privet' office to find out what certain medication Ray was on. This information was passed onto the members of the Tactical Team.

At about 1050 hours Sgt. Cedar told us that the SWAT Team was in position and that we could start negotiations. Before this I had received another call from Misty advising me that she had tried to call Ray back but that he had put some kind of block on his phone to stop incoming calls.

At 1050 hours, I called Ray on the phone number provided me by Ursula . I received the message that the call could not be completed because the caller did not want to answer any incoming calls. From this point on until the negotiations ended I had to call the operator to have the call placed through to the suspect's phone.

At about 1051 hours a male subject answered the phone. I know L. Pierrot personally and it sounded like him. I identified myself and told Ray that I wanted to talk to him. L. Pierrot sounded very groggy and lethargic. It appeared to me that he was under the influence of some type of medication. I talked with Ray for about nine minutes. Most of the conversation Ray would just say "it's done", or something to that effect. When I would ask Ray what was done he would say "talking". At no time did Ray ever make any kind of threat to himself. At about 1059 hours the conversation was terminated by Ray hanging up.

At 1100 hours I called the house back through the operator. The phone rang at least 35 times before I had the operator terminate the line.

At 1106 hours I called Ray back. When he answered he said "I don't want to talk to anyone I don't know" and then he hung up. At 1107 I again called Ray with him saying the above statement again. At 1108 hours I attempted to call Ray but the operator told me that Ray was trying to call out on his phone.

At 1112 hours, I attempted to call Ray and I spoke with him about one minute. Again Ray tells me that he only wants to talk to someone he knows. I tried to tell Ray that he knows me, which he did, but he refused to talk to me.

At 1114 hours we (Cpl. Aspen and I) to try and let Scott Hawk, a friend of the family, to try and talk to Ray. I called the house and when Ray answered I put Hawk on. Hawk says "Ray this is Scotty" and Ray hangs up on Hawk.

At 1126 hours, Misty Pierrot called me and said that she is talking to Ray. She told me that Ray had called her at her house. Misty Pierrot tells me on the phone that Ray is starting to make threats towards officers. He told Misty that the first one he sees is dead and get them out of here. This information was relayed to Sgt. Cedar and the rest of the members of the SWAT Team.

At 1132 we learn that dispatcher Stephanie Pierrot is with Misty and that she has a portable. She then starts communicating with me on what Ray is telling Misty on the phone. Fish tells us that Ray said the we had five minutes to get the cars out of there. At 1135 hours we learn that Ray is talking to Misty and he tells her which of the cars to move.

At 1138 I again attempt to call Ray. Misty says that Ray has called her again and she is attempting to convince Ray to talk to me. Misty says that Ray is refusing to talk to me and he hangs up. At 1140 I again attempted to call Ray and the operator says he is talking to someone else. At 1141 hours I am able to get through to Ray's phone and it rings for about one minute before Ray answers and immediately hangs up. I immediately call Ray back and after one more minute he answers and immediately hangs up on me. This happens three straight times where the phone would ring for a Rayg time and then Ray would just hang up the phone.

At 1143 hours I again call Ray. A decision was made prior to making the call the we would try and let Ray's mom, Ursula Pierrot to talk to him. When Ray answers I hand the phone to Ursula . She tries to convince him to talk to the police. After about ten seconds Ray hangs up the phone on his mom. Ursula told me that all Ray said to her was "shut up".

Misty then calls us at the house on a cell phone that Mary Pierrot has. I spoke with Misty and she says that Ray in threatening to start shooting holes in the wall.

At this time Cpl. Aspen. Lt. Douglas and I discuss the possibility of moving one of the cars that Ray has demanded to be moved. At 1155 hours is was decided to let Scott Hawk move his pick-up. He moves his pick-up. When Ray still makes threats about shooting holes in the wall a decision was made to move the family and friends that were in the house to an apartment across the street. This decision was made for the safety of the civilians.

At 1200 hours Fish tells over the radio that Ray has stated, "The officer behind the shed and Aspen's house needs to move or he's dead". This threat was made towards Ofc. Oak. At 1203 Ray told Misty that "I have a full face shot of the officer behind the shed". Again this threat is directed towards Ofc. Oak.

A decision was made to ask Ray what would happen if we left the scene. Ray just told Misty that things would not change if the police left. With the amount of firearms that Ray had and the threats that he alAspeny had made towards Mary and Ofc. Oak a decision was made that this could not be an option at this point.

At 1212 hours, we receive information from Fish that Ray has told Misty that she has received several calls from Ray and Ray is threatening to shoot the legs of an officer he can see.

Information is also received that Ray has five weapons loaded and Aspeny to use. This would include rifles, shotguns and pistols.

At 1214 Ray phones Misty and tells that he will not give up anything if we move the second car that he is demanding moved. I try to have Misty that he would have to give up one of his weapons before the second car is moved. Ray rejects this offer.

At 1217 we learn that Ray has called Misty and tells her that we had five minutes to move the cops or he was going to kill himself.

At 1219 Ray calls Misty and says we have four minutes to move the cops before he shoots himself. At 1221 Ray calls Misty and all he says is "three minutes".

At 1228 Ray phones Misty and tells her "time is up", tells Misty goodbye, says he has a gun to his head and hangs up.

At 1229 L. Pierrot calls M. Pierrot and says "goodbye Misty" and hangs up.

At 1239 I attempted to call Ray Pierrot . At 1240 Ray answered by saying "hello" and then hangs up. To me L. Pierrot sounded very groggy.

At 1248 Misty Pierrot calls and says that Ray had called her and is demanding that the blue car is moved. However Ray does not agree that he will give anything up if the blue car is moved.

At 1250 L. Pierrot calls Misty Pierrot and says that he is done negotiating and begins talking about family and kids. Misty Pierrot says that L. Pierrot said that if officers leave he will talk to somebody. L. Pierrot is told officers are not leaving and is offered the opportunity to speak with Ofc. Clove, Oak or D. Aspen. L. Pierrot declines this offer and says that he will not talk to anyone any Rayger and hangs up.

At 1257 M. Pierrot says that L. Pierrot says that he will not talk to the police because he is afraid that he is going to jail. He then demands that she get the police out of the area immediately. L. Pierrot then hangs up from Misty Pierrot.

At this time we (Lt. Douglas, D. Aspen and I) decide to end Mellisa Pierrot trying to negotiate with L. Pierrot . We talk about D. Aspen going over to Misty's residence to try and talk to Ray. We feel that it is important for Ray to try and negotiate with one of us instead of Misty. It is decided to send Lt. Pine over to Misty's to talk with Ray and Leave D. Aspen at our location to assist in the negotiations.

At 1307 we learned that Ray had called Misty and told her he is not going to talk and that the police just can kill him.

At 1319 Ray calls Misty' house and Lt. Pine answers the phone. He immediately hangs up.

At 1320 hours Ray phones Misty's house and tells Lt. Pine "I just saw one leave" and then hangs up.

At 1333 hours, L. Pierrot calls Lt. Pine, and when Pine answers Ray says I didn't call to talk to you and then hangs up.

At 1335 hours Ray calls me and tells me that his attorney is on his way up to the scene. It is learned that Ray's attorney is Dave Maple. I advise the outer perimeter officers that Maple is on his way up to scene and when he does arrive to contact me.

At 1338 hours Ray calls me and tells me that he saw two more (meaning police officers) come back.

At 1340 hours, Ray calls me and claims that we lied about officers leaving the scene, then he hangs up.

At 1341 I tried to call Ray back but he did not answer. At 1342 I tried back and Ray answered. He tells me that if we don't leave we will have to suffer the consequences, then he hangs up.

At 1343 hours I called L. Pierrot back. He just says "Leave me the fuck aRaye" and then hangs up.

At about 1347 hours I was advised by Ofc. Elm that Dave Maple is at his location at 11th and Burrell. I immediately leave the house to go to talk to Maple. When I spoke with Maple he tells me that Ray had called him at his business and was very despondent over his marriage problems. Maple asks if he could talk to Ray over the phone and I told him at this time I felt that would not be the best thing to do. I then went back to the house where Lt. Douglas and Aspen were.

When I arrived D. Aspen tells me that Ray had called him while I was running back to the house and said "He (meaning me) better run a little faster or the nest time he gets taken out".

At 1358 hours L. Pierrot phones and speaks with Aspen. Ray requests an unarmed person come over to the house to talk to him and Aspen says that you not be a good idea.

At 1402 hours we learn that L. Pierrot had phoned Lt. Pine and he told Pine he would be willing to talk to Sgt.

Spruce. I then phoned dispatch and I was able to call

Spruce and he told me that he would be coming to our location.

At around 1410 hours SWAT members radio that the door on the carport side of the house had opened and closed. Sgt. Cedar requests someone that is in the house where we were to try and see what is going on. I went to the west side kitchen window and I saw Ray Pierrot looking out over the blue car that was in the carport. He had a semi-auto weapon in his right hand and he also had his left hand on the weapon and was holding it in a combat type style. He was looking around and was also sweeping the area with the weapon as he was moving it around. I immediately radioed this information to the SWAT members and then moved back to get a safer cover position. I then heard SWAT members say that L. Pierrot is walking east towards the house we were in. They then advise that he is walking more in a southerly direction. Lt. Douglas then advises SWAT members to challenge Pierrot and I then heard several members yell at Pierrot to drop the weapon. They then advised that L. Pierrot is now walking north towards the barn where Sgt. Cedar, Cpl. Woode and Cpl. Pine are. Out of the west side kitchen windows I see L. Pierrot walking towards the area of the barn. At this time I could not see any of the officers that were in the area of the barn. I see L. Pierrot pointing the weapon toward the area of the barn. He had the weapon in both of his hands in a combat style. the gun was at chest high pointing at the barn. I again hear several times officers yelling at L. Pierrot to drop the gun but L. Pierrot does not drop the gun. I hear several commands (no less than six) for L. Pierrot to drop the gun but he does not. At this time D. Aspen and I start moving forward and at this time I heard what I thought was three gunshots go off. I immediately see L. Pierrot drop to the ground and I

immediately radio for the medics to come into the area. D. Aspen and I immediately exit the house and Cpl. Woode starts to assist with medical attention to L. Pierrot . It appears to me that L. Pierrot has struck with multiple rounds. The medics arrive and tend to L. Pierrot . I assist with crime scene security by having Ofc. Clove go to the driveway on 11th Street and not let any non law enforcement personnel into the scene. Sgt. Cedar and I then go into to secure this area. We do not locate any gunshot rounds in the house but find a rifle lying on the bed in the northwest room of the house and we find a box of .22 caliber ammunition by a chair at the northeast corner of the living room.

Sgt. Spruce arrives and starts assisting Lt. Pine in securing the scene. Lt. Pine and G. Rogers secure the scene with barrier tape. After L. Pierrot is taken to the hospital I then go to the front of the house at to assist in securing the scene. After IBN arrives I then clear the scene and go back to the station and I stay there until I am interviewed by L. Shrub, agent for State Bureau of Investigations.
