Administration discussed with the board that they are working to get a bid for the auditorium lighting. Administration discussed that the expense would be no more than \$35,000. A motion was made by Slaymaker, seconded by Rabe to approve getting additional lighting in the auditorium, at no more than \$35,000. Motion carried.

The board received a bid from StageStep for new flooring on the auditorium floor for \$8980.56. A motion was made by O'Rourke, seconded by Rabe to approve the bid from StageStep for \$8,980.56. Roll call vote. Slaymaker nay, Rabe aye, Miller aye, O'Rourke aye. 3 – 1 Motion carried.

The board received a bid from SCS for expoxy flooring at the elementary, nurses' office, lounge and faculty bathroom for \$37,223.
