Written report - Currently we have 20 groups registered to District 20. If you are from one of the new groups that have just registered, I encourage you to go to the meeting finder on Area 48's website and check your listing. District 20 listings can be found here:

I also encourage any of the members, whether new or not to periodically check the meeting finders to verify accuracy. Our records data base, which I keep for our district, is what drives the meeting finder for Area 48, and subsequently, the "Chair App" from GSO.

There has been a trial of listing a group in the meeting finder without publishing their password, and instead publishing an anonymous email to request password. I'm happy to report this seems to be functioning well.

I was informed that at this year's Fall voting Assembly that they will be verifying voting members. This will be done through our records database, so if you are a GSR or an Alternate GSR and you are not listed then you will not be able to vote at the assemblies. I have checked our records and I believe everything is correct. Please let me know if you have any questions about this.

I have heard from a few GSR's that the issue of not getting the welcome packets has been resolved and they are receiving them.

I attended the Area Records meeting this month. The database has a new function that allows me to remove the last name of members while keeping a last initial. This is helpful in making copies of information in an anonymous way. It was also discovered that one of our groups in D20 is being listed as "inactive" and I don't know why. The Area records chair is looking into it.

We're only a few months away from our position rotations as a district and I will be rotating out. I want to invite anyone interested in taking on this position to reach out to me. It truly is an amazing service job. I thought it was only going to be data entry, but I'm often times the first person a new GSR, or a new group talks to, which has been fun and challenging.
