PART 2: CASE STUDY PROPOSAL

Overview

THE DEFINITION: A case study is an in-depth analysis of a real-life situation or incident, which provides content and theory to a real-life situation.

THE PURPOSE: To walk the reader through a presented problem, provide background information; and a description of the solution and how it was derived. It allows the researcher to tell the whole story while focusing on evidence-based communication.

A case study is a process or record of research in which detailed consideration is given to the development of a particular person, group, or situation. Within the context of this class, your case study will be:

- a research strategy and an empirical inquiry that investigates a phenomenon within its real-life context
- a descriptive and exploratory analysis of a person, group, or event
- Includes qualitative and quantitative evidence relies on multiple sources of evidence.
- An analysis of persons, groups, events, decisions, periods, policies, institutions, or other systems that are studied holistically

Elements of a Case Study

Problem

• Describes the problem/situation through the three lenses

Background & Context

- Describes why the problem exists
- Gives context and background including stakeholders (who's involved), includes supportive data if necessary

Solution & Implementation

- Describes the solution or lack thereof and the implementation of the solution
- Discuss the solution and rationale, including hard data and evidence

Evaluation & Results

- Explains the response to the solution
- Includes a summary of how well it's working (if applicable)

Choose a topic for your own proposed case study on a climate justice issue of interest to you, which, upon approval of your topic, you will research further, write up a report, and share with the class. It could be a local, national, or international case study. Consider the following definition: *Climate Justice recognizes the disproportionate impacts of climate change on low-income communities and communities of color around the world, the people and places least responsible for the problem.* Conduct some initial research and answer the questions below for your proposal due by class time on Wednesday 1/17.

REMINDER: You will be delving into your topic in detail. You will need to examine this topic from ecological, economic, and social (historical, cultural, political) perspectives. It is imperative that these three perspectives are to provide a full and accurate context to your topic.
